Describe present and historic physical appearance.

The South Pittsburg Historic District comprises approximately 46 1/2 acres of the historic core of the town. The district retains the integrity of its growth period 1880 to 1940, and is surrounded by areas with substantial post 1940 development and the commercial section of town.

South Pittsburg was laid out by F. P. Clute, an English civil engineer. The streets were paved, and there were concrete sidewalks for pedestrians. Each block had 20 lots, each 50 feet x 140 feet, 10 fronting on each north south street, with an alley in the center of the block.

Retaining walls are built where a slope has been cut into for sidewalks and streets. These walls are mostly located in the southern end of the district. Construction is of either coursed stone or rusticated concrete block.

Housing for industrial workers was built on 1 or 2 lots. From the founding until the advent of the Bungalow in the early 20th century the houses were 1 story cottages, of rectangular or irregular form with some Victorian ornamentation. A few workers houses are two stories. They were built of weatherboard with brick or concrete block foundations, most have gable roofs, some are pressed metal. They are situated near the front of the lot with a small front yard. Concrete walks lead to the entrance from the public sidewalk.

Housing built by industrial managers and owners was larger, generally 2 stories and with more ornamentation. Some examples of manager housing have Queen Anne and Italianate details.

In the early 20th century there was a shift in the types of houses typical for each group. Workers began to build Bungalows instead of cottages. Bungalows were constructed of weatherboard and brick with foundations that were most frequently brick although concrete block and stone are not uncommon. The majority have gable roofs. Plans are square or rectangular, most have porches across the front.

The Revivals of the 1920's and 30's are represented by the managers housing. They built in the Colonial, Dutch Colonial, and Tudor Revival styles.

The Dutch Colonial houses were built of rusticated concrete block with concrete block foundations. They have gambrel roofs with the entry perpendicular to the roof line. Colonial Revival houses were weatherboard with gable roofs and brick or concrete block foundations.

Sheds and garages built prior to 1930 are common. Several are built of concrete block although the majority are of weatherboard or vertical board. Brick and artificial sided outbuildings are infrequent. Many have concrete or wood foundations and shed or gable roofs. Asphalt shingles and metal are the two most common roofing materials.

Some earlier outbuildings were converted into garages with a minimal loss of integrity. Many of the older ones have outward opening barn doors or sliding doors. Most outbuildings have small double hung sash windows with 4 over 4 lights.

Outbuildings are positioned near the rear of the property, garages open onto the alley with a door facing the property, or they face the property with a driveway running beside the house from the facing street. Sheds usually have 1 door facing the property.

The district retains its layout of streets and sidewalks. Houses have asphalt shingle roofs and some have artificial siding but retain their historic feel. Relatively few post 1930 structures are included in the district and they use the same materials of the older houses, they are similarly set back, and some have elements sympathetic to their neighbors.

Contributing resources (c) are significant to the historic and architectural development of the district, possess compatible design elements, maintain the scale, use and texture of the district. Noncontributing resources (nc) have little or no architectural significance or do not fall within the period of significance of the district.

The term "Victorian Cottage" refers to 1 story houses with rectangular of irregular plans that have elements from the Queen Anne style, such as decorative attic vents, wrap around porches, millwork or decorative shingles in gables. Site 132 (photo 26) is a representative example of this style.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The South Pittsburg Historic District is the intact residential core of the city. It is eligible for the National Register under criteria "C" for its examples of late 19th and early 20th century housing styles, from Italianate influenced to the Colonial Revivals of the 1920's. The district is eligible under criteria "A" for it development following a preconceived plan, it is the best collection of historic resources that represents the town plan. The town developed from its founding, in 1873, until the economic decline of the 1930's.

The community of South Pittsburg was founded circa 1873 by the Southern States Coal, Iron, and Land Company, known as the "Old English Company," at the site of the Battle Creek community. At this location James Bowron, one of the four founders of the company had already built an iron foundry after searching the southeast United States for an area with coal and iron resources to exploit. In 1876 the company started to build machine shops, foundries, furnaces, houses, supply houses, and began grading streets, and putting in water mains.

Bowron had searched much of the United States looking for an area with iron and coal deposits. Prior to establishing a foundry in South Pittsburg he had purchased land in Hawk's Nest Colliery, Virginia, and Etowah, Georgia. Neither of these sites had coal deposits however, only iron deposits.

Bowron convinced his partners (Thomas Whitwell, a metallurgist, Mr. Pike, a Quaker banker, and Joseph Cliff, a fire brick manufacturer) to purchase 3000 acres of land for the town site. The company hired F. P. Clute, a civil engineer, to survey and plat the structure of the town. Clute's plan called for separate commercial, residential, and industrial sections.

Clute's plan provided for narrow paved streets. The north/south streets were named alphabetically after trees, the east/west streets were numbered. Residential lots were 50 x 140 foot tracts, twenty lots on each block, ten fronting on each north/south street. A service alley ran down the center of each block.

A separate sidewalk system allowed for pedestrian traffic. Stone and concrete retaining walls were built beside the walks on hills to prevent mud from collecting. People could walk from their homes to their job or to the mule drawn streetcar that ran along Cedar Avenue to the industrial park.

Bowron dreamed of South Pittsburg becoming the industrial center of the South with natural resources brought in from the other "Old English Company" towns—Whitwell (formerly Cheekville), a coal mining community, Victoria, site of the ovens that processed coal into coke, and Inman where there were iron mines.

Bowron was successful in attracting industry to the area. By 1890 over 3500 men were employed by a variety of industries such as manufacturers of stoves and ranges, foundries, a slat mill of the Eagle Pencil factory, hosiery mills, and an ice factory. Companies located in the city included Perry Stove Works, South Pittsburg Pipe Works, South Pittsburg Furnaces, Sad Iron Foundry, South Pittsburg Brick and Terra Cotta Company, Sequatchie Hoe and Tool Works, Shuster Foundry, Duncan Hughes and Hillman Lumber mill, Battle Creek Coal, RM Payne Brick Plant, Blacklock Foundry, Cast Iron Pipe Plant, South Pittsburg Ice Company, and South Pittsburg Knitting Mills.

South Pittsburg's commercial section supported dry goods stores, soda fountains, restaurants, saloons, clothing stores, an Opera House and theaters. The town also had two newspapers, the South Pittsburg Hustler, and in 1911 the Colored Column supplied news of the black community. Professionals were also found in South Pittsburg, there was a supply of dentists, lawyers, doctors, teachers, and ministers.

Industry affected the growth and development of the town. Several foundries relocated to Birmingham, Alabama when it was discovered that there were rich iron deposits there, and transporting products would be easier because Birmingham was on major traffic routes, South Pittsburg wasn't. When Tennessee Coal, Iron, and Railroad relocated from South Pittsburg to Birmingham

around 1900 the town suffered a slight recession. The development of the Dixie Portland Cement plant in adjacent Richard City in 1906 helped restart the economy. The completion of Hale's Bar Dam in 1910 also helped the city because it provided cheap electrical power to the residents and industry.

Much of the iron industry had left South Pittsburg before the abundance of limestone for cement was discovered. Even though the cement plants were not in South Pittsburg they influence South Pittsburg's economy. People would come the few miles up the road to shop, and cement was shipped out through the town.

A branch of the Nashville, Chattanooga and St. Louis (N. C. and St. L.) railroad connected South Pittsburg industry with the main line at Pikeville, in Bledsoe County. The railroad was an important link to the outside for industry which shipped large quantities of pig iron and other goods. The first eight months of 1899 saw 3,139 cars of pig iron shipped out, as well as 903 cars of miscellaneous merchandise. South Pittsburg had larger freight receipts then any other city on the line except Nashville and Chattanooga. Average daily shipments were 30 cars of 20 tons each.

The Old English Company had built some cottages for industrial workers but these were demolished when the elementary school was constructed. They also built four large houses of which two remain, the Cook-Headrick House (site 131), an Italianate influenced house which is prominent in South Pittsburg at the corner of Oak and 4th, and the Downing-Rogers Home (site 115) at Magnolia and 4th is a fine example of a simplified Italianate.

When the founders of the company died in 1877 and 1878 the company holdings were purchased by American interests. In 1886, under the direction of William Bowron, son of James Bowron, these interests formed the South Pittsburg City Company (City Company). The City Company purchased 700 acres to add to the town.

The City Company continued to attract industry to South Pittsburg continuing its growth. They also followed Clute's plan in the development of the city. Residents and developers purchased lots from the company and hired one of the local contractors to build a home. Rental properties were common and in high demand. In 1911 the South Pittsburg Real Estate and Building Company was formed to help the homeless find a residence. W. M. Cameroon was a prominent contractor in the town, he built five of the houses in

the district as well as houses elsewhere in the city and in Richard City. He built five of the houses on Elm Avenue (12, 13, 14,16, and 17), four of these are one story hall-and-parlor plan houses, the fifth (site 14) is a two story, T-plan house.

South Pittsburg never developed to the grand dream of James Bowron and Thomas Whitwell. Following World War I the city was hard hit by the nationwide decline in the demand for coal, and the general decline associated with the depression further harmed industry in the city. New construction practically ended from 1930 until after World War II, when South Pittsburg, like many other communities in Marion County, became a more residential city instead of an industrial one, although industry continues to be important to the community.

South Pittsburg has a cross section of the architectural styles popular in late 19th/early 20th century America. The most common style in the district is the Victorian cottage, most built around the turn of the century. The second most common house is the Bungalow, dating from the 1910's and 1920's. These two types of houses were built for industrial workers, the largest group of people in South Pittsburg.

There are also many houses that have no distinct style, they have no decorative features, vary in form and height, have varied plans and roof types.

The styles are mixed through the district, Ranch houses sit beside Bungalows and across the street from Queen Anne's. The district evolved over time with no noticeable pattern of settlement. Elsewhere in South Pittsburg development did occur in stages and primarily during one short time period.

Five churches (sites 1, 23, 37, 57, and 102) in the district fall into criteria exception "A." These five churches were built between 1875 and 1930. They add to the architectural variety of the district by adding Gothic and Spanish Mission elements. The Our Lady of Lourdes Catholic Church (site 57) is the only mission influenced church in South Pittsburg. Christ Episcopal Church (site 23) and Wesley Methodist Church (site 102) are two examples of the Victorian Gothic style. The other two are 1920's Gothic influenced churches (sites 1, 37).

#### Boundary Description and Justification

The South Pittsburg Historic District boundary is shown on the accompanying historic district map. The area is described on tax maps 142-I, 142-J, 142-P, 142-O, revised December 1984.

By these maps the district includes: block 34, lots 129, 130, 131, and 132; block 27, lots 8, 9, 10, and 21; lots 142-I-"B" 1, 2, 3, 4, 5,31, 32, and 35; block 57, lots fronting Pine; all block 52 except lots 89 and 90; block 33 properties fronting Magnolia; block 28; block 21 lots 31, 32, and 33; all block 17 except lot 21; all of blocks 20, 29, and 32; block 51 properties fronting on Oak; block 58, lot 40; block 50 lots 9, 10; block 31, lots 14, 15, 16, 24, 25, 26; all block 30 except lot 6; block 18 and 19; block 45 properties fronting on Laurel; block 42; block 43 lots 30, 69, 70; lot 142-P-"B"1.

The boundaries of the South Pittsburg Historic District are very uneven because of continued development in the town. Modern houses are being built on vacant lots in and around the district. Effort was made to exclude as much modern development as possible from the district which causes the irregular borders. To the East of the district is the commercial strip of town which was excluded because of the residential character of the district. The modern elementary school at 4th and Elm was excluded because it intrudes on the district. To the South of the district is the area traditionally known as "Midway" because it was midway between South Pittsburg and Richard City, it is filled with modern residences. To the North and West of the district are areas of modern housing.


