1. Name: Trinidad Andazola House, survey number 28
2. Location: opposite the San Jose church and approximately 50' southeast of Highway 61 and .3 miles south of the Eby Ranch Road.
4. Owner: Vera Sierra, HCR 3232, Benson, Arizona 85602
7. Description: Photo 68; foundation unknown; stuccoed adobe; asphalt shingle gabled roofs; 2/2 double hung windows and wooden casement windows; stuccoed exterior chimney.
8. Significance: Trinidad Andazola homesteaded 40 acres on the east side of the Mimbres river but chose to build his house here on the west side in 1893 to be part of the community of Dwyer, now known as Faywood. The house qualifies under Criterion C as a good example of the Hispanic New Mexico Vernacular type, modified during the historic period under Anglo-American design influences. The original single file section with side facing gables was expanded in traditional fashion by a gabled rear addition and by an Anglo-style shed-roofed front porch.

Verbal boundary: A rectangle, roughly 70' by 50', formed by lines parallel to and ten feet from the exterior walls of the building. Since this is an unplatted area, this boundary has been created to include only the house.
