

The Pleasant Inn, built ca. 1927, is located at 200 Broadway in Myrtle Beach. It is associated with the property sub-type, "Residential Properties," as identified in the Multiple Property Listing, "Historic Resources of Myrtle Beach, South Carolina."

Characteristics that make it typical of boarding houses in Myrtle Beach are the low, two-story height; wood frame construction; tiered, two-story full facade porches; side stairway leading to upstairs entrance; and rentable rooms for boarders.

The Pleasant Inn is of frame construction with vinyl siding. It is a twostory building with a rectangular core plan, end to front gable roof, and one interior brick chimney. The three bay symmetrical facade has two single doors centered on the first story and one central door on the second story. A tiered, two-story, hip roof porch extends across the full facade and wraps to the right elevation. It features square wooden posts with brackets and a slat balustrade on the second story. The portion of the porch on the rear right elevation of the house is screened in. An outside stairwell on the right elevation provides access to the upstairs. The paired windows are six-over-six double-hung-sash. Stylistic features displayed by the house are exposed rafter ends and gable vents.

The rear porch was closed in on both the first and second floors by Mrs. William F. Simmons, and although the exact date is unknown, it was prior to 1974.

The Pleasant Inn is significant for its association with Myrtle Beach's period of growth and prosperity as a coastal community resort from 1926 to 1954 and as an excellent example of the residential properties commonly built in Myrtle Beach in the mid-twentieth century. It was one of a number of houses built during this time to accommodate permanent residents and boarders.

The Pleasant Inn has been owned by the same family since 1929, when it was purchased by William F. Simmons, a magistrate in Myrtle Beach. Lell Simmons, wife of William F. Simmons, ran a boarding house here known as the Pleasant Inn for many years. Many workers in Myrtle Beach stayed there in the early days. Mrs. Simmons also ran a grocery store a block away from the house for a short while. Mr. Simmons died in 1959, and his wife remained in the house until her death in 1974. One of the Simmons' daughters, Heddy McCabe, owns the house at present. Her niece, Cindy Simmons, lives in the house now and rents rooms to boarders.

Accommodations in Myrtle Beach have changed greatly over the years. The residential properties including boarding/guest houses, permanent residences, vacation and summer homes that were common in the downtown area and along Ocean Boulevard during the 1930s, 1940s, and early 1950s have been replaced by high-rise hotels, shops, theater, amusement parks, and other amenities geared toward the tourist population. Hurricane Hazel in 1954 and developments in the insurance industry dating to the early 1970s have been primary factors in these changes. The Pleasant Inn is one of the few remaining examples of the two-story boarding/guest houses that pre-

The property meets Criterion C as a representative example of the property sub-type, "Residential Properties," particularly of the boarding houses common in Myrtle Beach before the beach became populated by high-rise resorts.
