DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Hannibal Hamlin House of Bangor, built between 1848 and 1851, with a Mansard style roof dating from the 1870's, is a delightful Italianate style dwelling which is in a fine and unaltered condition.

The building faces south-east and is of frame construction with ornate slated Mansard roof, two internal brick chimneys, bracketed cornice, and granite foundation. 2¹/₂ stories are present, each side of the half-story containing two gabled dormers. Fenestration throughout the house is 6/6, and the second-story windows are flanked by external louvered shutters.

Across the south-east side of the house the first story is covered by a porch with cornice fitted with paired brackets and supported by fluted posts. The entrance, while on the north-east side, faces south-east and is likewise covered by a porch.

To the rear of the building is a $2\frac{1}{2}$ -story ell equivalent in scale and detail to the house proper. Beyond the ell is an attached carriage-house with gambrel roof covering $2\frac{1}{2}$ stories and bracketed cornice.

STATEMENT OF SIGNIFICANCE

Though the birthplace of Hannibal Hamlin in the Paris Hill Historic District (N.R. 6/19/73) survives, this is the house which he purchased in 1862 while Vice President of the United States and which remained his home in Maine until his death almost thirty years later. Originally a flat roofed two story Italianate dwelling built in 1851 by William T. Hilliard, Clerk of Courts and later Deputy Collector of Customs, it was altered in 1870 by Hamlin with addition of a Mansard roof, effectively adding a third story.

Born in Paris Hill, Maine, on August 27, 1809, Hamlin was educated in a local school and a nearby academy and after brief periods as a surveyor, newspaper printer, and schoolteacher, took up the study of law in a Portland office. On winning admission to the bar in 1833 he began practice in Hampden, Maine, and soon became active in politics, serving in the legislature from 1836 to 1841. In 1842 he was elected as a Democrat to the House of Representatives, where he remained until 1847; after another term in the legislature in that year he was elevited to complete an unexpired term in the Senate in 1848, returning to the seat for a full term in 1851. He became gradually more and more outspoken in his dislike of slavery and he opposed in particular the Kansas-Nebraska Bill of 1854; finally, two years later, he broke with the Democrats and joined the Republican party. In that year he was elected governor of Maine, the first Republican to hold the office; early in 1857 he left the Senate to assume the governorship, but a few weeks later he resigned to return to the Senate. His position as an Easterner and a former Democrat made Hamlin a strategic choice for the Republican vice-presidential nomination in 1860 on the ticket headed by Abraham Lincoln. Although he sided more often than not with the Radical wing of the party, he remained throught his term in office on close terms with President Lincoln. Failing of renomination in 1864, in 1865 he was appointed collector of the port of Boston, but he gave up the post a year later in protest against President Andrew Johnson's Reconstruction policies. After two years as president of a small Maine railroad he ran successfully for the Senate in 1868 and remained there for two terms, supporting Radical Reconstruction and serving for a time as chairman of the Committee on Foreign Relations. On leaving the Senate he was for a year, 1881-1882, U.S. minister to Spain. Hamlin then retired to Bangor, where he lived, still an influential figure in state Republican affairs, until his death on July 4, 1891.


