Setting:

The stone house is located one mile west of the Westfall post office on the Bully Creek Malheur County gravel road, and is west of the confluence of Cottonwood Creek and Bully Creek. The house is situated east and immediately adjacent to the tall bluff of a saddle shaped mountain. The house is oriented to the east facing the Westfall/Harper county road a mile away. A large fruit tree shades the southwest part of the house.

Outbuildings:

At the north elevation of the house, a small pitcher pump is six feet from the porch and kitchen. Adjacent to the pump is a twelve by fourteen foot root cellar, c.1900, eight feet from the house. The cellar roof is missing. One hundred feet further to the north, beyond the root cellar, is a twelve by fourteen foot hay storage shed, c. 1900. Seventy-five feet from the southwest elevation of the house is a twelve by twenty-four foot grain storage shed, c. 1915. Thirty feet from the southeast house elevation is a large water pump. A four by fourteen foot wood feed trough, c. 1920, is one hundred feet southeast of the house.

House Exterior:

The house is rectangular in shape, thirty-six feet wide and forty-seven and a half feet long. It has two stories. The three chimneys are composed of brick. The hip roof had been covered with wood shingles. A plain closed cornice is present without brackets. Tall apertures for windows and doors utilize segmented keystone arches. Wood frame transoms are present above the doors. One-piece stone sills are at the base of the windows. Single glazed windows are double hung with wood frame and sash. The east elevation, the main entrance, is square cut, uncoursed, hammer dressed ashlar. The remaining elevations are uncut, uncoursed rubble. The foundation for all elevations is basalt flow rock. The stone walls of the house are silicic ash-flow welded tuff.

There was a wood porch/balcony (now collapsed) at the east elevation of the house as well as a wood exterior stairway (now missing) from the ballroom on the west elevation. A wood porch at the north elevation of the house is present. There was a wood porch extending for forty-seven feet at the south elevation, now missing. Bond timber supported the west elevation stairway from the ballroom, and also the wood porch/balcony at the east elevation. A single, wide door was at the main entrance.

House Interior:

On the first floor, the bridging floor joists are supported by basalt masonry about one foot above grade. There is no basement. No sub-flooring is noted in areas permitting examination. Tongue and groove fir flooring is utilized throughout the first and second floors. The stairs are single return with an intermediate landing. The first floor interior includes two bedrooms, a parlor, hallway, dining room, kitchen, pantry, and wire screened wood porch. The interior walls are wood lathe/plaster. The dining room walls utilize wood wainscot facing. The kitchen has a sink with a drain. There is no indoor plumbing.

A ballroom, two rooms reported to be servant's quarters, and a hallway are present on the second floor.

The chimney at the southwest area of the house rises vertically for two floors, then in the attic the brickwork laid at a forty-five degree angle, rises northeastward, and is supported by wooden beams. As this chimney reaches the roof crest, it rises vertically again. The chimney in the southeast part of the house rises vertically for two floors, then in the attic area, without external support bracing, angulates in corkscrew fashion, rising in a northeastward direction to reach the roof crest, then rises vertically again. The third chimney, in the northeastern part of the house appears to rise vertically throughout, to the roof crest. No fireplaces are in the house. The wood stoves that heated the rooms are missing.

House Alterations:

No apparent, significant alterations have been made to the house since its original construction in 1898, except for limited installation of electric lights. Electric power became available in Westfall in June, 1946.

Current Condition of House:

The house has retained its integrity of materials, excellent stone masonry, and design. The stone walls are in remarkably good condition. The majority of roof shingles are missing. The east elevation porch/balcony has collapsed, and the south elevation porch and west elevation exterior stairway from the ballroom are missing. The interior wood lathe/plaster walls are in a state of significant disrepair, and much vandalism has occurred. A portion of the first floor interior stairway is missing.

The roof of the root cellar has collapsed. The root cellar is believed to be c.1900. The wood hay storage shed to the north of the north house elevation, is c.1900, and is beginning to collapse. The grain storage shed is c.1915 and is in an excellent state of repair. At the same site, the original grain storage shed, c.1900, was a lean-to shed with partial roof support utilizing the pyroclastic rock bluff immediately westward and adjacent to the shed. The feed trough southeast of the east elevation of the house is most likely c.1950 and is in good repair.

The Mose Hart Stone House is locally significant in Malheur County under criterion "C" as an intact, rare example of Vernacular-Italianate style architecture. The house copied the architectural style of the Rinehart Stone House in Vale, Oregon. The Rinehart house was constructed in 1872, using sandstone from a quarry at the southeast edge of the town of Vale. The Mose Hart house has been identified by Nielsen and Galbreath in their book, "Oregon's Fading Past", as an architecture gem, soon to be forever lost unless restoration occurs in the near future. This private residence still remains one of the finest examples of pioneer architecture in Eastern Oregon.

Two additional stone structures are present in the Westfall/Bully Creek area. A single room, stone wall jail, c. 1900, still exists across the street from the Westfall post office. Its roof and stone walls remain partly intact. Also, a small stone wall ranch house, is in the region. Its construction date is not known. It has been vacant for an unknown period of time.

Moses W. "Mose" and Mary Elizabeth "Lizzie" Hart were regarded as early settlers of the Westfall area. Mose married Lizzie in the Willamette Valley. Later, they came with a band of sheep to Bully Creek c.1890. It was reported that Mose thought he could winter the sheep without hay, and established a camp on a timber claim. Before spring, most of the sheep had either starved or frozen to death. Later he acquired the ranch at the fork of Cottonwood (earlier called Canyon Creek) and Bully Creek. The stone house, on this ranch, was constructed under the direction of Mose Hart in 1898 at a cost of \$6000.00. The name of the stonemason is not known. On a stone on the left side of the upstairs doorway as one faces west towards the main, east elevation entrance to the house, one can still see an inscription "MWH 1899". The basalt rock used for the foundation most likely was obtained at the ranch site. Extensive basalt rock, illustrating typical columnar jointing, is readily seen nearby. While the Rinehart Stone House in Vale used sandstone from a nearby quarry, the Mose Hart house used silicic ash-flow welded tuff for the house walls that was obtained at a quarry on the Charles Becker Ranch on Indian Creek, eight miles away from the house. This lower Pliocene and upper Miocene welded tuff is a form of volcanic or pyroclastic ash, composed of a mixture of hot gas and glass fragments that welded together, under pressure, to form a very weather resistant rock.

A state legislative act divided Malheur County from Baker County, and the first election was held June 4, 1888. Only male citizens twenty-one years of age or older were entitled to vote. The voting population of the county was about 1,000. About 800 votes were actually cast in the elections. Records show that in 1892, democrats nominated M.W. Hart, from Westfall, for Malheur County commissioner. He lost to republican Webb Anderson, from Dell, by a vote of 341 to 293.

For unknown reason, Mose and Lizzie sold their magnificent stone house soon after construction was completed. According to the original record in the Malheur County Clerk's office in Vale, Moses W. Hart and Mary E. Hart, sold their stone house and associated ranch property to Lemuel Burgess and John F. Kelsey, sheepmen from Shaniko country, for \$6750.00 on November 17, 1900. Mose was born on June 20, 1833, in Pennsylvania, and died September 9, 1909. Lizzie was born June 6, 1845 and died March 3, 1911. They are buried in row seven in the Westfall cemetery. They had no children.

According to Malheur County deed records, Burgess and Kelsey sold the house to Eugene Looney, a trustee for an unnamed party, but believed to be W. Scott Anderson and Nellie E. Anderson, from Ada, Idaho, on March 18, 1907. On November 14, 1913, a quit claim deed transferred ownership to Cleve Cammann and Jay S. Branson. On October 27, 1914, Cleve and Carrie Cammann sold their ownership interest to Jay S. Branson. According to Hazel Fahy Whittenburg, a daughter of Jay D. "Pat" and Lucy Fahy, the Fahy family lived in the stone house from c. 1919 and c. 1927. Lucy Fahy's sister, Fanny Lamberson, was married to Jay Branson. On August 2, 1929, Jay S. and Fanny Branson sold the house to O.H. and Alice Perkins. At unknown dates Russell and Pauline Zimmerman, and later on, Cleve and Carrie L. Cammann owned the house. On June 30, 1941, Lloyd and V. Doris Edmunson purchased the house from the Cammanns. Lloyd and Doris Edmunson were believed to be the last family to live in the house. On April 7, 1958, the Edmunsons sold the house to the Romans family. Martha Romans said they used the house to store saddles and other ranch equipment. The house has been abandoned and vandalized in recent years. Historical graffiti, from Zimmerman family descendents, is dated May 28, 1959. David Post acquired house ownership from the Romans family on March 7, 2000.

The Mose Hart Stone House is significant in Malheur County under criterion "A" because of its location in Westfall, a former major transportation site. The Westfall area was part of the east-west route between Vale and Burns. This route was used by local Indians, and later by wagon trains, fur trappers, miners, explorers, and soldiers. In 1845, the ill fated wagon train, led by Stephen H.L. Meek, and his younger brother, Joseph, traveled through the Westfall area. Later, Bully Creek settlers built a wagon road via Cottonwood canyon to facilitate passage of freight between Vale, Westfall, Beulah, Drewsey, Harney City and Burns. Wagon tracks are still visible several miles west of town.

Initially, no road passed into Harper valley except by way of Westfall. The large Pacific Live Stock Company Harper Ranch included much of Harper basin. The Westfall region prospered in agriculture and livestock, and supplied miners living in the Morman Basin and other gold sites. Sheep and cattle, and various crops were exported to other regions. Alfalfa was introduced in Malheur County c.1881. Potatoes were grown by a former stone house resident, Hazel Fahy Whittenburg, and her husband Jack. Specific economic details for Westfall area are not known, but in 1897, an estimated 35,000 tons of alfalfa hay were harvested in Malheur County. For the entire county, estimated number of stock sold: sheep, 50,000 head; cattle, 20,000; horses and mules, 5,000; hogs, 500. In 1901, the Malheur County assessment roll gave the value of stock in the county: cattle, \$312,605; sheep, \$201,870; horses and mules, \$80,975; hogs, \$970.

The Westfall population increased over the early years, and finally supported three general stores, two hotels, a bank, three saloons, a blacksmith shop, two livery barns, a school house, church, dance hall, garage, and candy store. Over 350 people voted in elections and the census of 1910 showed 140 people living with the city limits.

The stone house, and especially its ballroom, became a center for social and cultural activities in the town. The Mose Hart house was the scene of many dances and parties. It has been reported that dresses and even the wall paper in the house, had been imported from France and traveled "around the Horn". The ballroom was also reported to be the site of a private school at one time.

In 1913, many of the town buildings were dismantled, and the people and buildings moved twelve miles away to Harper. It was the location of the new railroad station on the route between Ontario and Burns through the now passable Malheur River Canyon.

Most ranchers survived the depression years. The area was overstocked, mainly by flocks of sheep passing through the area. Local Westfall ranchers attempted to protect their access to public grazing land by homesteading public land containing known sources of water. The Taylor Grazing Act came into law in 1934 through the effort of concerned ranchers. Drift fences appeared. By the 1950's, small ranches were bought up by larger ranches. Wells and sprinkler systems were utilized, and row cropping began. In the 1920's there were ranches up every canyon, but now less than ten families remain. The Westfall school closed in 1961, and the school children are now transported to Harper. On October 15, 1959, only two town residents remained, Mrs. Carrie Cammann, and Mrs. Rachel Looney, the postmistress at that time. Now, no one lives within the town.

Boundary Justification

A three acre boundary should encompass the Moses and Mary Hart Stone House and Ranch Complex, and its immediately adjacent structures, including the root cellar, pitcher pump, and hay storage shed to the north, the grain storage shed to the west, and the water pump and feed trough to the east of the stone house.

The branding corral far to the north along Bully Creek, and the hay storage corral some distance to the east of the house were excluded since those two structures are contemporary, and are not related to the historic nature of the stone house.




