PHYSICAL DESCRIPTION

c. 1914

This single-story stuccoed adobe is located on the southwest corner of Sacaton and First. The square plan has a diagonal corner entry with a curvilinear parapet above. The flat-roofed Mission Revival design imitates the 112 N. Sacaton building. This building has similar curvilinear parapets and a similar shed corrugated metal-roofed arcade along the Sacaton Street (west) facade. Under the arcade, double hung wood windows are symmetrically placed. The north facade has equal window treatment with a single centered vaulted parapet. A central door is infilled and stuccoed.
