

SUMMARY

The Hubbard Rice Dryer is located at 15015 Senteney Road (County Road 624). The main characteristic of the structure is the ten silos made of reinforced concrete, standing in five pairs, each approximately 50 feet high. The structure was constructed circa 1945, and was last used in the fall of 1979.

ELABORATION

The Hubbard Rice Dryer is located approximately 7 miles northeast of Weiner, AR, near the northeast corner of the intersection of Senteney Road and Evans Lane. The locale is rural – the middle of an agricultural area—and the only other structures in the vicinity of the rice dryer are a few smaller metal silos, a small farmhouse, and several small- to medium-sized metal equipment storage facilities.

Senteney Road is located immediately to the south of the rice dryer, and runs east to west. Standing on the road and facing north, one will see two of the dryer's concrete silos standing side-by-side. The 10 concrete silos are arranged in 5 pairs, each pair immediately behind the pair in front of it.

Within the spaces between the large concrete silos are 5 smaller, metal silos. These metal silos stand one behind another, and are approximately 40 feet high. They are not easily seen from the exterior of the structure.

A large, metal exit pipe protrudes from both the east and west side of the structure. These pipes are attached to the middle concrete silo on their respective sides, and are located approximately 15 feet above the ground.

The base (approximately the lower 15 feet) of each large silo is a solid concrete ring with one, two, or three door-sized entryways (except for the silo located in the northeast corner of the structure, which has no entryway). These doorways allow access to a network of small compartments located inside the base of the silos, and allow travel between these compartments throughout the structure.

The remaining height of these concrete silos consists of concrete tiles stacked on top of each other in a pattern consistent with the columnar shape of the overall structure. Also, several metal retaining rings wrap around this portion of each silo to provide extra stability for the column.

The smaller, metal silos located in the central part of the structure are made of sheet metal segments riveted together to form rings. Each ring-shaped segment is bolted to the segment below it to form the columnar shape. These metal silos are slightly elevated off the ground, and each has drainage spouts located at the bottom of the silo.

INTEGRITY

The rice dryer remains intact, and shows no signs of alteration. The structure illustrates its original design and materials, and thus maintains its integrity. The rice dryer is located in a rural area, with the only activity around it being that of the farm on which the structure resides. The structure was last used in the fall of 1979, and remains a good example of a rural farm rice dryer. Although the Hubbard Rice Dryer is located in a cluster of farm buildings, it is the only structure directly related to rice cultivation that retains good historic integrity.

SUMMARY

Constructed circa 1945, the Hubbard Rice Dryer is being nominated to the National Register of Historic Places with **local significance** under **Criterion C** as the best example of a rural rice dryer in the Weiner vicinity. The rice dryer is also being nominated under **Criterion A** for its associations with the development of agricultural practices in Poinsett County. This nomination is being submitted under the multiple-property listing "Get Down the Shovel and the Hoe!: Cotton and Rice Farm History and Architecture in the Arkansas Delta, 1900-1955."

ELABORATION

Poinsett County was formed February 27, 1838, and was the thirty-ninth county created in Arkansas. The county was formed from territory taken from Greene and St. Francis Counties. In 1859 Craighead County was created from the northern part of Poinsett County, and in 1862 Cross County was created from the southern portion of the county. Creating these two counties left the land that comprises Poinsett County today.

Poinsett County is located in the northeastern section of the state. It is bounded on the north by Craighead County; on the east by Mississippi County; on the south by Crittenden and Cross County, and on the west by Jackson County. The county is 756 square miles in area. Running north and south through the center of Poinsett County is Crowley's Ridge, a unique highland area. East and west of this highland are level, fertile valleys and prairies where cotton, rice, milo, wheat, corn and soybean farming occurs. Cattle farming is also very popular in the area.

The county was named for Joel R. Poinsett of South Carolina. Poinsett served as Secretary of War for President Van Buren, and was also the botanist who is said to have introduced the favorite Christmas flower, the poinsettia, to American horticulture.

The original county seat was located at Bolivar, a settlement named for General Simon Bolivar. The county seat remained at Bolivar until the winter of 1856-57. In the 1856 election, the citizens of Poinsett County voted to move the county seat to a site somewhere between townships 9 and 10, located in the central part of the county. Benjamin Harris, Sr., donated land for a new courthouse site, and so the county seat was moved to the western slopes of Crowley's Ridge, three miles south of Bolivar. The new county seat was named Harrisburg, in honor of Harris.

The first courthouse at Harrisburg, a brick structure, was built in 1858. The interior of this courthouse burned in 1873, destroying all county records. A new courthouse was completed in 1875, using the remaining walls from the previous structure. This time, a vault was built to protect county records. This courthouse was used until 1917 when it was totally destroyed by another fire. Only one record book was destroyed in that fire. The present courthouse was built on the same site in 1918, and is listed on the National Register.

Weiner, the town nearest to the Hubbard Rice Dryer, is located between Newport (Jackson County) and Harrisburg. The town is situated off of US Highway 49 near the Earl Buss Bayou DeView Wildlife Management Area. The first post office established in the area was at West Prairie, in 1874. Circa 1881, the Texas-St. Louis Railway Company built a railroad line through the area. It is likely that the town of West Prairie was relocated closer to that railroad, and the names of the post office and the town were changed to Weiner in 1884. In 1886, the St. Louis, Arkansas & Texas Railway Company was charted to acquire the properties of the Texas & St. Louis Railway Company, which had been sold under foreclosure. This acquisition included the depot located at Weiner.

Commercial rice drying in Arkansas was implemented around 1944 as a result of the increased usage of the combine-method of harvesting the crop. By 1946, driers were situated throughout the rice sections of the Arkansas Delta. Individually owned driers were most common in 1946, but corporate driers handled the most rice in that year, while farmer-owned cooperative driers (organized by the Arkansas Rice Growers Cooperative) were second.

There were several designs of rice driers in use by the mid-1940s, but the columnar type, which used gravity, screw-type conveyors and heated air was the most common. The Hubbard Rice Dryer is an excellent example of this columnar design. The columnar rice driers utilized one of two functional types:

- 1. **Berico Type** As rice moves down the column, it is subjected to forced, heated air from *outside* the column
- 2. **Hess Type** As rice moves down the column, it is subjected to forced, heated air from *inside* the column

According to an interview with the owner of the property, Mr. Clay Hubbard, the Hubbard Rice Dryer represents the Hess Type of dryer. Mr. Hubbard's father privately owned the dryer, which was last used in the fall of 1979. Although no longer in use, the Hubbard Rice Dryer remains a good example of a midtwentieth century rice dryer, and an important reminder of Poinsett County's agricultural history.

STATEMENT OF SIGNIFICANCE

Constructed circa 1945, the Hubbard Rice Dryer is being nominated to the National Register of Historic Places with **local significance** under **Criterion C** as the best example of rural rice dryer construction and design in the Weiner vicinity. The rice dryer is also being nominated under **Criterion A** for its associations with the development of agricultural practices in Poinsett County. This nomination is being submitted under the multiple-property listing "Get Down the Shovel and the Hoe!: Cotton and Rice Farm History and Architecture in the Arkansas Delta, 1900-1955."

ABSTRACT/SUMMARY COMMENTS:
The Hubbard Rice Dryer is locally significant under Criterion A for its association with agriculture in Poinsett County and under Criterion C as an excellent example of a Hess-type rice dryer. Built circa 1945, the dryer was one of many facilities of its kind that appeared in the Arkansas Delta as mechanization boosted rice production after World War II. The Hubbard Dryer reflects the increased importance that the rice crop assumed in the 1940s and 1950s. Last used in 1979, the dryer retains integrity from its period of significance and reflects the history of agriculture in Poinsett County.




