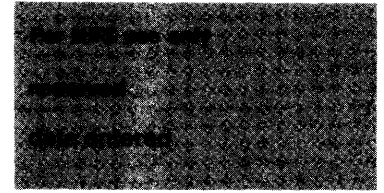

Description: Excellent, unaltered original site.

The Nuckolls House is a two-story, yellow brick home which was built in 1929. It is approximately 90' by 55', and is Mediterranean style architecture. The first story is decorated with rounded arch windows with keystones. The east and west ends of both the front and the back of the house have palladian-style windows. The main entrance of the house has both round and square columns, and a broken pediment above the door. The front door has a fan light above it and side lights on either side. There is a porte cochere on the east side of the house, with decorative brick patterns on the upper part of it to accent it. The back of the house has two double-hung windows on either side of the back door. There is a row of bricks turned sideways which runs even with the window sills on the second story. The front of the second story has double-hung windows paired in threes. However, the windows directly above the front door are fixed. The east and west sides of the house also have triple windows. The back of the house has windows in ones, twos, and threes. Also, there is a palladian style window in the center-back of the second story. The roof is covered with Spanish tile. The house has two brick, double-stack chimneys.

Significance: 1929 to present; Builder/Architect - Unknown; commerce.

The Nuckolls House, built in 1929, is significant because of its association with industrial growth in Shawnee. Alvin Nuckolls, owner and builder of the home, organized the Shawnee Garment Manufacturing Company in 1904. The company manufactured Round House Overalls, which were and still are very well known throughout Oklahoma. The overalls got the name Round House because a large railroad round house was located in Shawnee. Nuckolls built the house in 1929. He operated the garment company until the end of 1937 when he retired. In 1937, he sold the company; however, Round House Overalls are still being manufactured presently, and in the same building as when Nuckolls owned the company. Nuckolls continued to live in the house at 200 E. Federal until his death in 1948. The home was sold to Percy and Jeanette Brown. Percy Brown owned Brown Truck Lines in Shawnee. The Brown family still owns the home. The house continues to be known as the Nuckolls home because Alvin Nuckolls built the house, and because he was a prominent business man in the community.

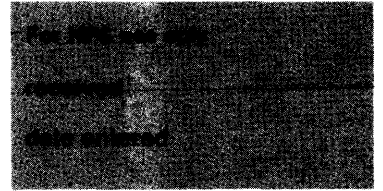
