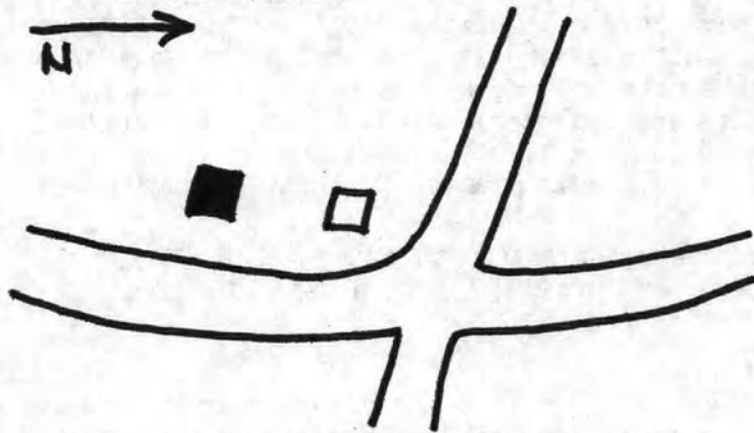

ARCHITECTURAL SIGNIFICANCE (Describe important architectural features and evaluate in terms of other buildings within the community.)

136 Hampstead Street is an excellent example of the broad-gabled Greek Revival house built in the rural areas of Methuen in the early 19th century. The five-bay main facade and four-bay eastern facade have well detailed central entries. The east facade retains the glazed transom and narrow pilasters of the original design. The clapboard-clad building rests on a granite foundation. The triangular pediment and simple cornice are of note.

HISTORICAL SIGNIFICANCE (Explain the role owners played in local or state history and how the building relates to the development of the community.)

136 Hampstead Street is significant as a well preserved example of a Greek Revival style dwelling built in the agricultural areas of outlying Methuen. Farms such as this provided produce for nearby markets including Lawrence and Lowell, and indicate that farms were still being developed in Methuen in early to mid 19th century, a period when the central industrial/commercial area began its growth. 136 Hampstead possesses integrity of location, setting, design, materials and workmanship and meets criterion C of the National Register of Historic Places.
