The John B. Curtis Free Public Library is a one-story Neo-Classical Revival style brick building that rests on a high granite block foundation. Its combination of gable front orientation, monumental front granite steps, and high platform impart an image of a classical temple. The library stands at one end of the small village center of Bradford.

Facing west, the library's symmetrically composed three-bay front elevation contains a centrally placed doorway flanked by six-over-six double hung sash windows. The doorway, which projects slightly from the end wall, is comprised of a six-panel door surmounted by a semi-circular fanlight. Its enframement features pilasters with Ionic capitals that support paneled impost blocks and a broad cornice. Slightly above the doorway is a rectangular stone plaque bearing the inscription "The John B. Curtis Free Library." Other important details on the facade are the keystones above the two windows (these appear above all but two ell windows), a stringcourse that extends around the building below the granite window sills, rectangular panels between the stringcourse and the granite basement, short cornice returns, and the original wrought iron stair railing which flares at the base (matching the broader width of the stairs).

The south side elevation features a trio of symmetrically placed windows consisting of a pair of six-over-sixes framing a central six-over-six with four-pane sidelights. Here, the decorative panels appear below the outer windows only. There are two fixed six-pane windows at the basement level located on axis with the six-over-sixes. The slightly recessed ell has a single six-over-six and a basement level window. On the north side there are five symmetrically placed six pane windows and three basement windows (located below the outermost and middle windows). Panels appear in the bays with both upper and lower windows. There are no openings in the ell wall. At the rear of the ell is a doorway to the basement and a six-over-six window above. A single interior end chimney punctuates the copper sheathed roof at the rear of the main block.

Inside, the library has one large room in the main block and a small room and stairs to the basement in the ell. At the entrance end of the interior is a vestibule that is flanked by segmentally arched alcoves corresponding to the window locations. A fanlight identical to the one over the main door is positioned above a six-panel door in the vestibule. Opposite the entrance is a fireplace with a Colonial Revival style mantelpiece comprised of eared surrounds and a shelf supported by corner blocks and scroll end brackets. Arches similar to those framing the vestibule are located above the doors that lead to the stairs at the northeast corner and the original office at the southeast corner. Narrow tongue and groove wainscot carries around the room. The wainscot and door and window trim are varnished. The only interior alteration is the acoustical tile ceiling that has been suspended from the original plaster over lath ceiling. Still extant above the tiles are the original lighting fixtures, now replaced with florescent lights.

An account of the library's dedication which appeared in the April 1, 1915, edition of the *Bangor Daily News* noted that the building "...is of grey brick construction with Deer Isle [Maine] trimmings, copper roof and built in the most substantial manner to stand for many years."

Designed by the Portland architectural firm of John Calvin Stevens and John Howard Stevens and constructed in 1914-15, the John B. Curtis Free Public Library is a distinctive one-story brick building which evokes the image of a classical temple. The building was given to the library association by John Bacon Curtis, a native son who prospered in a variety of business ventures in Bangor, Portland and later Nebraska. The library is eligible for nomination to the Register under Criterion A and C as more fully discussed in the Multiple Property Documentation Form titled "Maine Public Libraries."

The library's donor, John Bacon Curtis (1827-1897), was born in Hampden, Maine, but his family moved to Bradford during his childhood. He subsequently joined his father in the lumbering business during which time they conceived the idea of manufacturing spruce gum. In 1848 the family once again relocated, this time to Bangor where they continued to produce gum. At this time, John B. Curtis was principally involved in the marketing of their product through traveling sales. Recognizing the value of locating their business in proximity to rail connections, the Curtises moved to Portland about 1850 where they established the firm of Curtis & Son. Sometime thereafter, John B. Curtis is said to have invented a machine that greatly facilitated the process of shaping, wrapping, and packing the gum. After his father's death in 1869, Curtis broadened his business activities and for a time was involved in shipbuilding, and later established a steamship line to serve the islands of Casco Bay. In 1880 he ventured to Texas and then Nebraska where he purchased a large farm. He is also said to have had business dealings elsewhere in the country. At the time of his death, however, Curtis was residing in the Portland suburb of Deering.

In his will, Curtis left \$20,000 for the construction of a library building in the Town of Bradford. Of this amount, \$12,000 was designated for the building itself and the balance for an endowment to support the library. Nearly seventeen years elapsed between Curtis' death and the erection of the building, a fact that is apparently explained in part by the delay in forming a library association to receive and maintain the bequest. In a letter dated February 11, 1913, Leander H. Fobes (a trustee of Curtis' estate) wrote to Thomas H. Wentworth in Bradford to inquire as to whether anyone locally could prepare a plan for the library as well as build it. Fobes' wrote, in part:

In these small towns you sometimes find people that can turn their hands to anything, a kind of natural genious. I was thinking that you might have some one of that kind in your town that could make a plan for a building for us. Have you any one there that could take a contract to build or would we have to go to Bangor for a builder?

Ultimately, however, Maine's most prominent architectural firm was selected to design the library, and the Bangor contractor Otto Nelson was given the building contract. The trustees' records of expenses as reported to the Probate Court indicate that John Calvin Stevens was paid \$552.61 for plans and that the construction costs amounted to just over \$8,000. In addition, \$100.00 was paid to Helen V. Gerrity, a professional librarian, to catalogue the nearly 3,000 books that comprised the original collection. The library was dedicated on March 31, 1915.

The Bradford project was the fourth library building designed by the Stevens firm, although John Calvin Stevens himself had previously designed three others. Like all of the Stevens libraries, the one in Bradford is a very distinctive building unlike any others in the state. Its classical temple form in particular sets the Curtis library apart from others built in this period.
