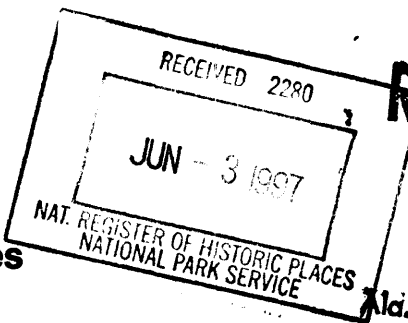

South East Lake Historic District Narrative Description

Primarily a residential neighborhood located in the eastern section of Birmingham, Alabama along the banks of Valley Creek, South East Lake Historic District is part of the East Lake development, one of the city's oldest planned communities (1886) and one of its earliest streetcar suburbs. As one would expect for a neighborhood nestled in the valleys between Rufner and Red Mountains, the terrain is undulating, particularly to the south and southeast as one approaches the foothills of the Appalachian mountains found in the Birmingham District. An economically stable middle class neighborhood, South East Lake Historic District contains a wealth of late nineteenth and early to mid-twentieth century architecture reflecting the development of the area from 1888 to 1948.

The developers of East Lake laid off the neighborhood in a typical grid pattern with broad avenues and cross-streets (see attached historic map). Today, the South East Lake Historic District is only a portion of the original East Lake development. In the 1960s, the district was severed from the lake and park, components of the original development scheme, which lie immediately to the north. The South East Lake Historic District encompasses twenty-seven whole and six partial city blocks and lot sizes are a uniform 50' x 165.' All lots back up to common alleys. Residences are uniformly set close to the street with secondary structures located to the rear along the common alleyways. This particular arrangement strengthens the visual appeal of the neighborhood, providing stretches of houses in the various styles popular during the district's period of significance. Too, by placing the primary residence closer to the street, homeowners typically have large and spacious rear lawns and yards. Throughout the area, one finds the Southern flora typically found in such neighborhoods, varieties of oak, pecan, dogwood, pine and sweet gum. Lots are usually embellished with attractive landscaping and portions of the district have over the years, been enhanced with the installation of sidewalks and curbs.

South East Lake Historic District contains a variety of architectural styles reflecting the trends in American architecture during 1888-1948. The district includes three religious structures: the Neo-classical Ruhama Baptist Church (#95), c. 1926; the Romanesque Revival style East Lake Methodist Church (#25), c. 1948; and the classically detailed East Lake Presbyterian Church (#505), c. 1925. All three buildings are of brick construction and are good examples of their respective architectural styles, particularly the elaborate and finely detailed East Lake Methodist Church. These structures rest on large lots and are visually appealing and well maintained.

The six commercial buildings found within the area are typically small and only one story, usually brick or brick-veneered. Since South East Lake Historic District is primarily a residential neighborhood, there are few commercial buildings in the area. Structures #152 and #97 are good examples of brick commercial buildings. Structure #97 (c. 1925), a corner store/market opposite of Ruhama Baptist Church, has large plate windows and brick veneer exterior wall material.

The styles found in the residential architecture of the South East Lake Historic District include Queen Anne, Craftsman/Bungalow, Tudor, Colonial Revival, Spanish Revivals, Art Moderne, Romanesque Revival, and various vernacular forms such as pyramidal roofed and L and T cottages. The primary form of construction is wood frame and the exterior wall materials range from simple weatherboard to brick veneer and stucco. The earliest houses constructed in the South East Lake District date from the late 1880s and reflect the late Queen Anne and Free Classic/Queen Anne styles which were then so popular. Buildings such as #477 and #478, both located on large corner lots on Eightieth Street, are in the Queen Anne/Free Classic mode which combine the overall form of the Queen Anne style with classical detailing such as columns, Palladian windows, fanlights, etc. from the Neoclassical and Colonial Revival styles. Perhaps more affordable for East Lake residents, and therefore, more prevalent in the neighborhood are the pyramidal roofed cottages, 60 of which dot the streetscapes of the district. Another form popular in the late 1890s and early 1900s was the L and T cottage, 25 of which are still standing in the South East Lake neighborhood.

The most prevalent architectural style in the South East Lake neighborhood is the Craftsman/Bungalow. Approximately 216 structures in the neighborhood can be classified as being in the Craftsman style or having Craftsman/Bungalow features. Typically these dwellings have wide overhanging eaves, decorative brackets, tapered posts on low brick piers, etc. Often, one finds the use of faux stone or pebble work used in the masonry of some bungalows. The great wealth of Craftsman/Bungalows, all constructed in the 1920s, reflects the prosperity and popularity of the area during the 1920s. Outstanding examples of the Craftsman Bungalow are buildings #298, 304, 315, 316, 329, 345, and 444.

The revival styles of architecture are also found in the South East Lake neighborhood and while not as prevalent as the Craftsman/Bungalow, add considerable charm and appeal to the area. The Tudor Revival is perhaps the most common revival style represented; twenty-four buildings can be classified as a Tudor or English cottage. While most are scattered throughout neighborhood, several are found along Eighty-Fifth Street, on the extreme boundary of the district, (#512, 513 and 514). Most of these dwellings are covered in brick veneer and have characteristics typically found on Tudor houses: front facing chimneys, arched openings, steeply pitched roofs.

The existence of houses in the Spanish Revival style is perhaps most interesting because the style is not particularly prevalent in the city of Birmingham. South East Lake Historic District is fortunate to have five really good examples of the Spanish Revival style within its boundaries. All of these houses are attributed to Birmingham architect George Turner who designed approximately 30 houses in this style in eastern Birmingham as well as the Hollywood section of Homewood. Of particular significance are three houses (#s 30, 31 and 457) located across the street from the East Lake Methodist Church.

One particular residence, which almost seems out of place is the small Art Moderne house located on Division Street (#10). This diminutive structure (c. 1940) has all of the characteristics of the Moderne style with corner windows, stucco exterior wall material, iron railings, and canvas awnings. There are isolated examples of other vernacular and architectural styles scattered throughout the neighborhood, including American Foursquare (#157), Dutch Colonial (#264) and a shotgun (#476).

East Lake experienced a boom in house construction in the 1950s and today the neighborhood contains approximately 27 houses which were constructed c. 1954. These houses are typically uniform with an L or T form, three bay facade, small porches and paired windows. Three of these buildings (#s 7, 14, 18) are located in the first block of Division street on the north western boundary of the district.

The majority of non-contributing resources (113) are modern ranch style houses which have been constructed on lots in the South East Lake Historic District. Some of these are brick veneered duplex-type dwellings. Other intrusions include Lake Villa, a modern concrete building located across the street from Ruhama Baptist Church. In addition, there is a six-unit modern apartment complex on First Avenue North.

Nevertheless, the South East Lake Historic District contains a wealth of historic architecture reflecting the period of significance 1888 to 1948. The buildings contained within the boundaries of the district clearly reflect the development of the neighborhood during that era. The South East Lake Historic District contains a total of 527 resources, 343 contributing and 184 non-contributing.

Archeological Component

Although no archaeological testing has been conducted, the potential for subsurface materials remains high. Properties of this type have the potential to yield information about various styles, forms, and trends in history and prehistory.

20. 8021 Division Street, c. 1925 - large and significant building in district, one and a half storied structure resting on full brick basement, front facing gable roof, principal floor has a five bay facade with centrally placed single leaf entrance flanked by paired 6/6 double hung sash windows, a band of five windows is located in the upper floor, the entrance is reached by a massive and elaborate series of brick steps with concrete caps and decorative urns. 25. East Lake United Methodist Church, 7753 First Avenue South, c. 1948 - religious building in the Romanesque Revival style consisting of sanctuary, belltower, and educational wing (c. 1960). The sanctuary has a front facing gable facade pierced by a recessed arched opening with double leaf entrance. A series of five arched windows and a large circular stained glass window are also located on the facade. The arched windows are repeated along each side of the nave and the flanking side rooms which resemble side buttresses. The soaring bell tower is capped by a low pitched pyramidal roof. The exterior is embellished with recessed brick work, radiating stone voissoirs, and decorative stone and tile work. The educational wing while modern is extremely sympathetic in design. Also located on the premises is a parsonage (7745 First Avenue South) in the Spanish style (c. 1948) (C) and a modern building (c. 1980) located to the rear of the main sanctuary (NC). The parsonage is a brick veneered structure with a cross gable roof, three bay facade, front facing gable wing and central single leaf entrance. The structure has brick

- and stone detailing which mirrors the main sanctuary. The modern building is a brick veneered structure, basically rectangular in shape with a mansard roof of sheet metal. The two contributing buildings, the sanctuary and the parsonage, are an integral part of the South East Lake Historic District being the focal point of the southwest section of the neighborhood. Both buildings are late articulations of the Romanesque Revival style. As such, both contribute to the historic architectural character of the district. The property contains two contributing buildings and one non-contributing building. (C, C) (NC) (4942-12, 13) (4941-5 parsonage)

**Statement of Significance
Criterion C - Architecture**

The South East Lake neighborhood is eligible for the National Register under Criterion C for its architectural significance. The properties encompassed in the district are representative local interpretations of their respective styles and also retain their architectural integrity. The South East Lake neighborhood contains an impressive collection of late nineteenth and early to mid twentieth century architecture reflecting the development and growth of this streetcar suburb from 1888 to 1948.

In 1886, Robert Jemison, Sr. and a group of industrialists planned the East Lake neighborhood as a residential community that would be free of the smoke and other annoyances of an iron manufacturing town. The developers of East Lake laid off the district in a typical grid pattern with broad avenues and cross streets. The focal point of the development was a fine park which boasted a lake, bath houses, pavilions, a hotel, zoo and boat houses. By 1910, East Lake contained a town hall, schools, fire department, churches and dummy lines which connected the community with Birmingham and other industrial sites within the Birmingham District. East Lake soon enjoyed the reputation as the most complete of the smaller towns in the District. Jemison had created an ideal suburban neighborhood for the average middle-class American.

The proposed South East Lake Historic District is made up of approximately 30 blocks within the historic neighborhood. This residential district lies southeast of Interstate 20/59, which severed this area from the northern section of the neighborhood encompassing the park and lake. Interstate 20/59 essentially divided the East Lake neighborhood into two sections: north and south. As such, the district is made up of most of the original plat and subsequent southeasterly historic outgrowth. Reflecting the historical development of this suburban neighborhood during the period of significance is a wealth of late nineteenth and early to mid twentieth century architecture. Included in the district are impressive examples of a variety of architectural styles, forms and trends including Queen Anne, Craftsman/Bungalow, Tudor Revival, Colonial Revival, Spanish Revival, Neoclassical, Art Moderne, Romanesque Revival, and vernacular pyramidal roofed and L and T cottages. Particularly significant is the collection of Spanish Revival houses designed by Birmingham architect George Turner. The majority of structures are generally one to one and a half stories and of frame construction. A number of structures have brick or stucco wall treatment. Generally, the dwellings are quite modest in terms of scale, materials, and design.

Commercial buildings are also quite modest and are typically, one story with brick exterior wall material. The three religious structures found within the district boundaries are excellent examples of Neo-classical and Romanesque Revival architecture. These structures rest on large lots and are visually appealing and well-maintained.

The neighborhood has a good degree of integrity. Overall, the South East Lake Historic District is a late nineteenth and early to mid twentieth century, middle class neighborhood in Birmingham. The wealth of historic architecture clearly demonstrates the neighborhood's historical development during the period of significance.

Period of Significance

The period of significance extends from 1888, the date of the earliest building in the district, through 1948, when residential building in the South East Lake Historic District ceased to rely on early-to-mid 20th century architectural designs and styles. South East Lake Historic District Historical Summary

In 1985, the Birmingham Historical Society conducted an architectural and historical resource survey of three neighborhoods which border Village Creek in Jefferson County. The results of that survey were compiled for the publication Village Creek: An Architectural and Historical Resources Survey of Ensley, East Birmingham and East Lake, Three Village Creek Neighborhoods, City of Birmingham. Marjorie L. White, Principal Investigator, and Carter L. Hudgins, Project Director compiled the following history of the East Lake Neighborhood for that survey. Their findings serve as the principal text for this historical summary. The text taken from the Village Creek publication and the original reference endnotes are found in quotes at intervals throughout the summary. Additional research by Jeff Mansell has been included in the text, and while footnoted, is found outside the quotes.

"In 1871 the site of the city of Birmingham was an old cornfield cleared of stumps and trees' waiting for the tracks of the South and North Alabama Railroad to cross those of the Alabama and Chattanooga Line. Surveyors employed by the railroads and the Elyton Land Company drew rights-of-way and streets on maps of land where only rabbits lived, but few men accepted the promoters' claim that the projected city would ever become the 'El Dorado of the iron masters' (The South, 5 April 1873)."

"Within a decade, however, Alice Furnace No. 1 on the city's western edge produced Birmingham's first pig iron and was followed quickly by imitators. Eleven companies put furnaces into production during the 1880s. Between 1886 and 1890, the height of the first iron boom, twenty-eight furnaces went into blast, and by 1890 Birmingham's mills produced 816,911 tons of iron, 8.8 percent of the nation's total production. Birmingham's share of the nation's iron production was at its peak."

"America's iron industry was then in the midst of its greatest period of expansion, and entrepreneurs by the dozens came to join the boom in Birmingham. Men, some already active in the Elyton Land Company and others...eager to emulate the land company's success, pooled their capital and acquired land near Birmingham which they hoped would also soon become bustling industrial towns. East Lake, East Birmingham, and Ensley...were founded by speculators during Birmingham's pig iron boom. Village Creek meandered through or near (these three towns). (While) East Birmingham and Ensley were, according to their promoters, 'favorably located for manufacturing enterprises' and offered ideal sites for 'residences for workingmen,'...East Lake

was planned as a residential community that would be free of the 'smoke, and other annoyances, of an iron manufacturing town' (DuBose, 1887, 264-265)."

"...(I)n 1886, a group of prominent Birmingham investors began plans for a community whose principal assent became its distance from sooty furnaces and the industrial haze. Promoters of East Lake, Alabama, wrote that Birmingham was 'destined to be...constantly growing.' Crowded with population and 'obscured by the smoke of furnaces, foundries, and factories,' the city would be 'ideal for business, but its centre will be by no means the best location for homes.' Noise and smoky air were 'distractions men willingly bare in business hours, and refer to with pride,' but they were not acceptable as part of normal home life. East Lake would provide a community of 'cheaper housing' where families of businessmen and workingmen could 'escape the smoke and other annoyances of an iron manufacturing town (East Lake Land Company, n.d.)."

"Principal investors Robert Jemison, Sr. and James A. Van Hoose, with the assent of 25 other men, incorporated the East Lake Land Company on July 7, 1886, with capital stock of \$200,000. M. F. Porter, R. H. Hagood, J. R. Boddie, A. A. Clisby, W. H. Wood, G. M. Hanby, George Morris, and T. R. Lyons were, along with Jemison and Van Hoose, appointed to the company's first board of directors (East Lake Land Company "Minutes," 1886, 7). Investment money ran toward iron production in late 19th century, Birmingham, and as a first order of business, the board of directors set priorities for their new company. The 'general purpose' of the East Lake Land Company as initially expressed was consonant with that espoused by other late 19th century industrial speculators. The East Lake Land Company proposed to 'carry on a general manufacturing and industrial business' and engage in the 'quarrying of limestone and other stones...the manufacture of pig iron, steel, and all other articles which can be made or manufactured with coal or coke and iron ore as from wood iron or steel either alone or in conjunction with any other material' (East Lake Land Company "Minute Book," 7)."

"It was soon apparent, however, that Robert Jemison and his associates would sink most of their capital into the development of a new town rather than new furnaces and mines. None of the investors and directors of this land company were industrialists. In the years preceding Birmingham's industrial boom, some of these men had been prominent local merchants and attorneys; others were well-to-do farmers from eastern Jones Valley. It seems that these men shared a proclivity to make their profits by buying and selling a portion of their property to the Sloss Furnace Company for development as a lime quarry (Birmingham Age, 5 December 1886). The principal business of the East Lake Land Company would be the 'buying and selling of lands, the improvement of such lands...into lots, streets, and tracts, the construction of lake, race tracks, and other pleasure resorts.' The land company would also construct the businesses, canals, tramways, water works, and railroads necessary to connect their community with Birmingham and provide the services necessary for the community's survival and expansion (East Lake Land Company "Minute Book," 7)."

"A reporter from the Birmingham Age wrote that much of the talk of the initial stockholders meeting of the East Lake Land Company concerned a plan to build 'an ideal residence town.' The men of the East Lake Land Company predicted that their town would 'quickly spring into the list of Alabama's finest.' It was, according to promotional pamphlets distributed by the company, the intention of its planners that their new town would remain 'strictly a residence suburb and pleasure resort' with 'genteel homes...ornamented with parks' (East Lake Land Company, n.d.)."

"Promoters of East Lake depicted their community as a place that would combine 'woodland graces' with the advantages of city life. Located beyond the eastern fringes of Birmingham, East Lake would be 'within easy reach of the finest farms in the county' and thus allow its residents to have 'first call on fresh vegetables and fruit, milk, butter, and poultry (Robert Jemison, Sr. Papers, n.d.). Well-established institutions would provide East Lake the amenities of urban life. Ruhama Baptist Church, a congregation established in 1818 and still active, would support spiritual and intellectual growth (erecting their imposing Neoclassical building in 1926). So would Ruhama Female Institute, the East Lake Atheneum and Howard College, a Baptist school of higher learning coaxed to East Lake from Marion, Alabama."

"This suburban paradise was not intended to be an exclusive development for the wealthy. Lots were to be kept to modest dimensions and houses built for 'the average purse...at prices within the reach of all.' Speculators were discouraged and social harmony was invoked by requiring every houseowner to improve his lot with ornamental plantings (East Lake Land Company, n.d.)."

"The community of East Lake was to be constructed on 2,000 acres of farmland located near Woodlawn 6 miles east of Birmingham among gently rolling hills near the headwaters of Village Creek (Birmingham Age, 5 November 1886). East Lake was...laid out as a rectangular grid three blocks wide between Underwood Avenue and East Lake Boulevard parallel to the old Huntsville Road, now called Second Avenue South (Schoel, 1888). This area had supported an isolated farming community since about 1818, but the isolation of the place came to an end when the East Lake Company completed a streetcar line to tie it to Birmingham."

In 1886, the Board authorized Col. Harding of Tuscaloosa "to make maps of the grounds, showing contour lines, creek, railroad connections, streets and avenues, park grounds and racetrack." Of the initial 1,982 acres, 202 were laid off into 777 lots and by 1887, the East Lake Land Company had sold 457 lots. Lots were a uniform 50' x 165' and sold for \$400 for inside lots, \$500 for corner lots. As mentioned, Harding utilized a common grid pattern when laying off the lots for the East Lake Land Company. The grid pattern was merely an extension of the same plan used for the central city core of Birmingham as well as Smithfield, Pratt City, Thomas, Ensley, Bessemer, Earle Place, Central Park and Ensley Highlands. It would be after 1903 that Robert Jemison, Jr., who also developed Earle Place, Central Park and Ensley Highlands, would abandon the grid pattern for plans which complemented the natural terrain of the hills and mountains surrounding Birmingham. Jemison's later subdivisions, Glen Iris, Mountain Terrace-

Forest Park, Mountain Brook, and Fairfield, were laid out according to the designs of professionally trained landscape architects. Indeed, by 1910, the East Lake Land Company would annex the Roebuck Springs addition, a residential suburb which included the city's first professionally designed golf course, pleasure drives, gardens, and clubhouses. For Birmingham's residential suburbs, however, the impact of professional landscape architects came after 1900. The developers of East Lake simply utilized the "tried and true" common grid pattern. (East Lake Land Company, "Minutes," 7; *Designs on Birmingham*, 6-23)

After the sale of the 457 initial lots in 1887, the Company's Board authorized the construction of 15 houses on 50 acres of land; each house had to contain a minimum of 2,500 square feet. 280 acres of the original tract were held in reserve for schools, parks, and churches. On June 24, 1887, the Board donated 60 acres of land for Howard College under the stipulation that the college had to be open by Oct. 1, 1888 and that the college's Board of Trustees authorize \$50,000 in construction and land improvements. Also, in May of that year, the Board approved the donation of 100 acres to the Methodist Episcopal Church for the erection of a polytechnic school. As the Baptists had been instructed to do for Howard College, the Methodist Church had to spend \$50,000 on buildings and improvements but the church was given three years within which to open the doors of the institution to students. This school is no longer standing. (East Lake Land Company, "Minutes," 7).

The success of the East Lake Land Company depended heavily on the construction of a railroad/streetcar line linking the suburb to Birmingham and other industrial sites. The first train on the line was to leave East Lake for Birmingham at 6 a.m. with trains departing every 30 minutes. The last train left Birmingham for East Lake at 9 p.m. As an incentive to relocate and build, residents of East Lake were given train passes for 1 year. The train fare was set at a nickel (East Lake Land Company, "Minutes," 7). "The East Lake dummy line opened on October 8, 1887. Developed as a promotional device to encourage the sale of East Lake Land Company's lots, this streetcar line linked East Lake to Birmingham and its furnaces and eastern fringe. A system of branch lines eventually emanated from a station built on 77th street. When in 1912 East Lake streetcars were tied to lines that extended 14 miles west to Bessemer, residents of East Lake streetcars were tied to lines that reached most of the industrial sites in the Birmingham District (Hudson, 18). Robert Jemison, Sr. played a key role in the development of this network of streetcar lines which his son called the best in the Birmingham District (Jemison and Company Magazine, 1910, n. p.)."

"In 1893 the letterhead of the East Lake Land Company crowed that its beautiful suburban property contained everything a homeowner could want. East Lake offered its residents and Sunday tourists superb recreational opportunities. In 1886, East Lake's promoters dammed Roebuck Springs on Village Creek to create East Lake, the heart of an amusement center that became the trademark of the community. Advertised as the 'finest artificial lake in the South,' East Lake covered thirty acres and was said to be surrounded by parks and drives (East Lake Land Company, 48.1.1.35). Two and a half blocks long and nearly a block wide, the lake offered rowing, fishing, and carriage rides along its shore. During the summer months band concerts,

fireworks, and theatrical productions, some promoted by streetcar companies, attracted large crowds (Bigelow, 270)."

In 1889, children heading to East Lake for an all-day outing, simply boarded the dummy line at First Avenue and Twenty-Second Street in downtown Birmingham which sped them away for a day in the suburbs (Atkins, p. 73). A 150-room hotel, heated by steam and lit by electricity, opened at the lake in 1889, and in 1892 Monsieur Montabaro opened a zoo near the park that contained a collection of deer, pelicans, eagles, groundhogs, racoons, prairie hens, and wolves. One enthusiastic newspaperman predicted that the East Lake zoo would soon "rival the famous zoological garden of Central Park" (Birmingham Age Herald, 15 April 1892). After 1900, Sunday excursion trains attracted thousands to the "popular pleasure resort." The City of Birmingham purchased the park in 1917, and a bath house was constructed there in 1932 at a cost of \$32,000 (Birmingham News, 10 January 1979). Neither the zoo nor the hotel are still standing.

"From 1905 until about 1921, East Lake was the site of another major recreation. Birmingham businessmen Robert E. Collins, J. D. Collins, and E. J. Smyer incorporated the Trotwood Park Land Company in January, 1905, and stated their intentions to buy and sell land, survey lots, construct houses and 'build or operate and maintain race tracks for speeding of horses thereon or for the speeding of vehicles or racing of any kind' (Jefferson County Records of Incorporation, Vol. 1, 368). This was not the first proposal for a horse track at East Lake. The East Lake Land Company, soon after it was incorporated, announced that it intended to construct a large park in their community to honor Charles Linn, a recently deceased Birmingham industrialist and banker. Linn's son Edward was one of the investors in the East Birmingham Land Company. Plans announce for 'Linn Park' included playing grounds for baseball and cycling, a fair ground, and a race track. The Age reported in 1886 that it was 'altogether probable that the fair grounds and race tract will be built' on a site just south of East Lake Park. (Birmingham Age, 7 July 1886)." Although this particular race track was never built, East Lake did soon have a racing park.

"The Trotwood Park Company's horse track was East Lake's first. The company named its oval for John Trotwood Moore, a native of Marion, Alabama who graduated from Howard College in 1878, and who was a school teacher for six years in Butler and Wilcox counties before he moved to Tennessee where he earned modest acclaim as a poet and author of short stories and great fame as an authority on thoroughbreds. (Dictionary of Alabama Biography, 1231; The South and the Building of the Nation, 205-206) Trotting horses and sulkey drivers practiced on Saturdays and raced on Sundays. Racing fans came to the track via streetcar to East Lake and then crossed Village Creek on foot over an iron bridge that was located at 7500 5th Avenue (Jefferson County Records of Incorporation, Vol. VII, 7)."

"The Trotwood Park Company was dissolved in 1921, and the races stopped soon afterward (Jefferson County Records of Incorporation, Vol. VIII, 300). The track and its grandstands were leveled and filled, and the site was subdivided and sold to several Italian families who raised 'swell beans and cabbage' on the site until the early 1950s (Brackner, 1984)."

"Despite the best intentions of the land company, East Lake did not grow as quickly as the rest of East Birmingham. East Lake may have enjoyed air that bore the scent of 'comfort and prosperity,' but East Birmingham had cheaper housing and a source of employment, being closer to the foundaries and factories. At the end of 1886, there were reported to be 15 'substantial, comfortable and roomy dwellings' in the community (East Lake Land Company brochure, n.d., Robert Jemison, Sr., papers)." Nevertheless, in the early years of the project, the East Lake Land Company was often short of cash. Indeed, Robert Jemison was having a hard time convincing some of his partners that the company needed to make further improvements. At the June 15, 1888 board meeting, Jemison advocated enlarging the lake and building an electric plant and waterworks. Too, Jemison cited the need for additional grading, the construction of an additional dummy line to service the North Highlands property, and the building of small parks and a floating boat house and dancing pavilion. He estimated the cost of making these enhancements to the East Lake property at \$100,000 to \$250,000. Announced at a time when board members of the East Lake Land Company were unhappy with the railway rates and unprofitable boat rentals, Jemison's plea for further investment was difficult for most members to understand or support. Board members had long argued that the company should have retained control of the railway, an idea Jemison opposed (East Lake Land Company, "Minutes," 7)." As White and Hudgins note "The collapse of the iron boom and the Panic of 1893 bore some of the blame for East Lake's slow start as did the company's slow progress of undertaking civic improvements such as sidewalks, curbs, gutters, sewers, and landscaping. Few of the improvements the company had promised were complete at the beginning of the 20th century (East Lake Land Company brochure, n.d., Robert Jemison, Sr. papers)."

"Perhaps [the] most telling [reason for the slow growth of East Lake] was competition with the Elyton Land Company which owned 4,000 acres in the heart of the Birmingham District. The holdings included the central business district, all the land on Birmingham's north and south sides, Lakeview Park, and the Highland Avenue area. All of it was closer to the industrial core and therefore, filled with residents first. East Birmingham, Avondale, and Woodlawn, all contiguous to the city's eastern border, filled with houses and local businesses during the late 1880s and early 1890s. East Lake, in comparison, did not begin to expand until late in the 1890s. In 1898, the city directory listed 491 households in the surrounding community. In 1902, one year after East Lake was incorporated as an independent municipality, the new town boundaries contained approximately 320 residences on lots whose average size was 50 x 165 feet."

"Robert Jemison, Sr., one of the original investors in the East Lake Land Company, managed the corporation until 1904 after which Webb W. Crawford assumed control. Crawford expanded East Lake with the initiation of streetcar routes and by offering more East Lake property for development and sale. By 1906, a system of branch lines in East Lake was completed and run by the East Lake Land Company as a free service (Jemison's board members had argued for this service since the inception of the streetcar service). By feeding into the older lines that then traveled between East Lake and Birmingham, the new lines...helped open new sections for residential development and East Lake boomed. Between 1909 and 1912 Crawford was assisted by Bradley J. Sanders, a developer who was also vice-president of the Lake Highlands and Rugby Land

Company subdivisions. Together, Crawford and Sanders guided East Lake toward the goals established by Jemison and his colleagues in 1886. A town hall was constructed on 77th street and by 1910, schools, a fire department, churches, and other 'modern conveniences' had earned East Lake a reputation as the 'most complete of smaller towns in the Birmingham District' (Jemison Magazine, May 1910, n.p.). The East Lake elementary school and the fire department are located near 77th Street and to the east of the historic district. When it was annexed into the City of Birmingham in 1910, East Lake's population was estimated to be 3,000 (Cruikshank, 1920,136)."

After the opening of new railway lines and incorporation into the City of Birmingham, home construction in East Lake soared. It was during the 1920s that the majority of standing structures were built reflecting the popular Craftsman/Bungalow, and Spanish and Tudor Revivals. "East Lake (continued) to be the city's favorite site for picnics and Sunday afternoon drives. The lake was used for fishing and boating and the park for outings and special events. East Lake was also the scene of political rallies and family reunions. Extra streetcars had to be added to the East Lake and Tidewater lines in 1923 to accommodate the crowds of curious spectators who came to watch the public initiation ceremony of Nathan Bedford Forrest Klan No. 60 of the Ku Klux Klan. About 50,000 people, many of whom had come from outside the county, gathered for a barbecue, car raffle, and fireworks display held during the Klan ceremony (Atkins, p 113)." Additionally, commercial buildings were constructed during the 1920s as well as the East Lake Presbyterian Church.

The post World War II building boom also impacted the East Lake neighborhood. Reflecting this period of marked growth was the construction of the East Lake Methodist Church, a late articulation of the Romanesque Revival style, and its adjoining parsonage, c. 1948. The Presbyterian, Ruhama Baptist and East Lake Methodist churches remain important cultural and visual entities of the historic district. By the 1950s, scores of small but attractive dwellings quickly rose on vacant lots, filling in the streetscape. East Lake could be described as a stable middle-class neighborhood filled with blue collar workers and professors associated with nearby Howard College. Indeed, many residents in the neighborhood supplemented their income by renting rooms to Howard College undergraduates. Unfortunately, the educational institutions which the developers of East Lake worked hard to attract to the area fared poorly. The East Lake Female Atheneum was short lived, lasting for only ten years, from 1896 to 1906. The land upon which the Atheneum was located, is now the site of a Catholic nursing home. Similarly, the Ruhama Female Insitute had long since closed its doors when in 1957, the trustees of Howard College announced that the institution was moving to a new site on Lakeshore Drive in the Homewood area south of Birmingham. The removal of Howard College, which was subsequently renamed Samford University, was a blow to the East Lake neighborhood. The buildings of the college, lying to the south east of the historic district, were demolished in the 1960s. In addition, during the 1960s, plans were laid for the creation of a major interstate highway linking Atlanta and Birmingham. The four lane interstate, I-20, was laid through the East Lake neighborhood, severing the southern half (and the original planned subdivision) from the lake and the later neighborhoods lying to the north.

Today, South East Lake is an economically stable, middle class neighborhood. Although separated from the lake from which the area takes its name, the district retains the character of one of Birmingham's older communities with its broad avenues and historic structures. Within the district boundaries one finds a wealth of late nineteenth and early to mid-twentieth century architecture, reflecting the development and evolution of one of the city's earliest streetcar suburbs during the period of significance.

Verbal Boundary Description

Beginning at a point on the southern corner of the East Lake Methodist Church plot (#25) and proceeding northwest to the rear alley behind structure #26, making a 90 degree turn and proceeding in a northeasterly direction to Seventy-Eighth Street, making a 90 degree turn to the northwest to the intersection of Division Street; the line then makes a 90 degree turn to the northeast running down the center of Division Street, proceeding easterly until it intersects with Seventy-Ninth Street; the line makes a 90 degree turn to the northwest running to the alley behind structure #11; the line makes a 90 degree turn to the northeast and runs until it intersects with First Avenue South; the line runs along the northern side of First Avenue South curving to meet the alley which runs behind structure #135; the line proceeds northeast to Eighty-Third Street, turns in a southerly direction till it intersects Second Avenue South and makes a 90 degree turn to the northeast running along the northern side of Second Avenue intersecting with Eighty-Fifth Street; the boundary line proceeds down the eastern side of Eighty-Fifth Street to a point just beyond structure #516; the line makes a 90 degree turn running in a southwesterly direction along the alley way behind eleven structures facing 5th Avenue South; the boundary lines runs to a point just northeast of structure #454 and makes a 90 degree turn to the southeast to Fifth Avenue South; the boundary line makes a 90 degree turn and runs directly south along Fifth Avenue South till it reaches Eighty-Second Street; the line makes a 90 degree turn to the northwest until it intersects with Fourth Avenue South; the line makes a 90 degree turn to the southwest running along Fourth Avenue South till it intersects with Eighty-First Street; the line proceeds southeasterly down Eighty-First Street till it reaches Fifth Avenue South at which time the line makes a 90 degree turn to the southwest running along Fifth Avenue South until that street intersects Seventy-Eighth Street; the line then makes a 90 degree turn to the northwest running along Seventy-Eighth Street until the intersection of that street with Second Avenue North; the line then makes a 90 degree turn to the southwest until it reaches the origination point just past the East Lake Methodist Church, Structure #25.

Boundary Justification

The boundary lines of the South East Lake Historic District were drawn to include that portion of the original East Lake development lying southeast of Interstate 59 and northeast of Opporto-Madrid Boulevard (Seventy-Seventh Street) and to include as many contributing and exclude as many non-contributing resources as possible. In addition, the lines were drawn to include that portion of the original plat of East Lake which lies within the defined boundaries of the South East Lake Neighborhood Association.
