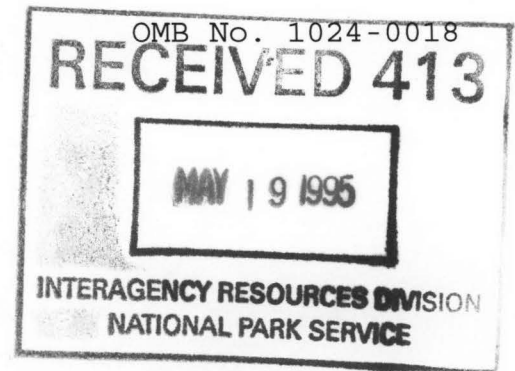

Summary

Located south of Paris off of Arkansas Highway 107 South, the American Legion Post # 121 is an L-shaped, single-story community hall constructed of saddle-notched logs resting upon a continuous stone foundation and covered by a composition-shingled gable roof. Also contributing to the nomination is a stone retaining wall constructed along the base of Pine Ridge Mountain.

Elaboration

Located south of Paris off of Arkansas Highway 107 South, the American Legion Post # 121 was erected in 1934 as a single-story community hall. Constructed of saddle-notched logs resting upon a continuous stone foundation, the irregular, though basically L-shaped building is covered by a composition-shingled, exposed-rafter, gable roof. The logs are painted brown and chinked with white cement mortar.

The front, or northeastern, elevation would be symmetrical in composition but for a non-fenestrated portion of the wall at the northern end that is inset from the remainder of the elevation. This section contains a centered projecting gable porch with a central double-leaf entrance underneath and two flanking wood-frame, six-over-six double-hung windows. The gable end of the porch is also constructed of logs and rests ungainly upon thin wood posts atop fieldstone piers, one of which is inscribed with "American Legion Post 121" and contains a list of officers at the time of construction.

The southeastern elevation is not fenestrated but features a superb cut-stone chimney in the center of the gable end (along with matching attic vents to

either side of the chimney). The rear, or southwestern, elevation contains a pair of small windows in the center of the gable end of the ell, but is not otherwise fenestrated. To provide more space and in order to span the length of the building on this elevation, projecting log bays are utilized on both the north side of the rear ell and the western side of the longer main section. The northwestern elevation is likewise non-fenestrated and contains only a solitary attic vent.

The simple interior has been altered by the addition of a dropped acoustical tile ceiling and simulated wood siding over a portion of one wall, yet still retains its essential integrity.

When originally constructed, the American Legion Post # 121 was part of a three-and-a-half acre, WPA-constructed park replete with Boy Scout and Girl Scout cabins, rock walls, and a stone stepped path leading to the pinnacle of Pine Ridge Mountain. Today, the Boy and Girl Scout cabins are gone, and only portions of the stone retaining walls remain. A modern concrete retaining wall has been built behind the building and is considered noncontributing. Additionally, a modern residence has been constructed to the north of the American Legion Post Building, but is excluded from the boundaries of this nomination.

Summary

The American Legion Post # 121 is locally significant under Criterion A for its association with the documented work relief activities of the Works Progress Administration in Logan County during the 1930's and the ensuing recreational aspect afforded to the county residents by its construction. Under Criterion C, the building is important as the best example in Paris and the surrounding vicinity of the style commonly known as "WPA Rustic."

Elaboration

American Legion Post # 121 was constructed in 1934 as a Works Progress Administration project. According to *A Review of Work Relief Activities in Arkansas, April 1st 1934 to July 1st, 1935*, this structure, referred to as a "community hall," was part of Projects 42-B15-2 and 42-B3-4 that operated from April 26th to October 13, 1934, utilizing 43 workers and entailing 9,122 man hours of work.

The report stated that approximately seven acres of land were acquired, "of which about three and one-half acres lie at the foot of a cliff on the south shore of the main branch of Hurricane Creek, about one-half mile below the water supply reservoir dam for the town of Paris." This area was also referred to as Coppeas Springs.

In addition to the community hall/American Legion Post Building, the WPA constructed a recreational park with Boy and Girl Scout cabins, stone walls, and a stone stepped path "from the base to the top of the cliff," which is also known as Pine Ridge Mountain. The pinnacle provided a splendid view for a 75 mile radius of the surrounding countryside.

On May 30, 1934, the opening of the new American Legion Post/community hall was celebrated with an all-day picnic, barbecue, games, and dancing. The immediate impact of the new facility and park was noted in the WPA report :

The value of this project is much greater than may appear on the immediate surface. Paris is the theoretical center of the mining area of Arkansas and the center for the concentration of mines and mining families within a radius of many miles. The agricultural activities in the county are of prominent nature only in the deep valley areas and activities indulged other than in this area are on marginal and sub-marginal lands. In consequence, the people in the country are, as a whole, classed as "poor" and prior to the construction of this park and community building, there was no place in the county in which assemblies of a public nature for amusement or entertainment might be had with the exception of a wholly inadequate courthouse and a still more inadequate moving picture theatre. It is true that there were several public dancing pavilions but none of them were of such type and character as to be conducive of the indulgence of community activities which would or might be made of general interest to the people as a whole.

The report concluded that "[w]ith the completion of these projects, a marked increase of social communication has been had and the facilities provided are

being used in a very satisfactory and highly appreciated manner."

The American Legion Post # 121 is being nominated under Criterion A and C with local significance. Under Criterion A, the building is important for its association with the documented work relief activities of the WPA in Logan County and the ensuing recreational aspect afforded to the county residents by its construction. Under Criterion C, the American Legion Post is significant as the best surviving example in the Paris vicinity of the simple and organic style sometimes known as "Rustic" or, depending on the builder, "WPA Rustic."

Beginning at a point created by the intersection of a line formed by, yet fifty feet from, the front, or northeastern, elevation of the building and a line formed by, yet fifty feet from, the northwestern elevation, proceed southwesterly along said line to its intersection with a line formed by, yet fifty feet from the rear, or southwestern, elevation; thence proceed southeasterly along said line to its intersection with a line formed by, yet fifty feet from, the southeastern elevation of the building; thence proceed northeasterly along said line to its intersection with said front elevation line; thence proceed northwesterly along line to the point of beginning.

Boundary Justification:

This boundary includes the American Legion Post # 121 building, the remaining portion of the historic stone retaining wall, and the noncontributing modern concrete retaining wall. This boundary does not include the modern residence to the north of the legion post building.

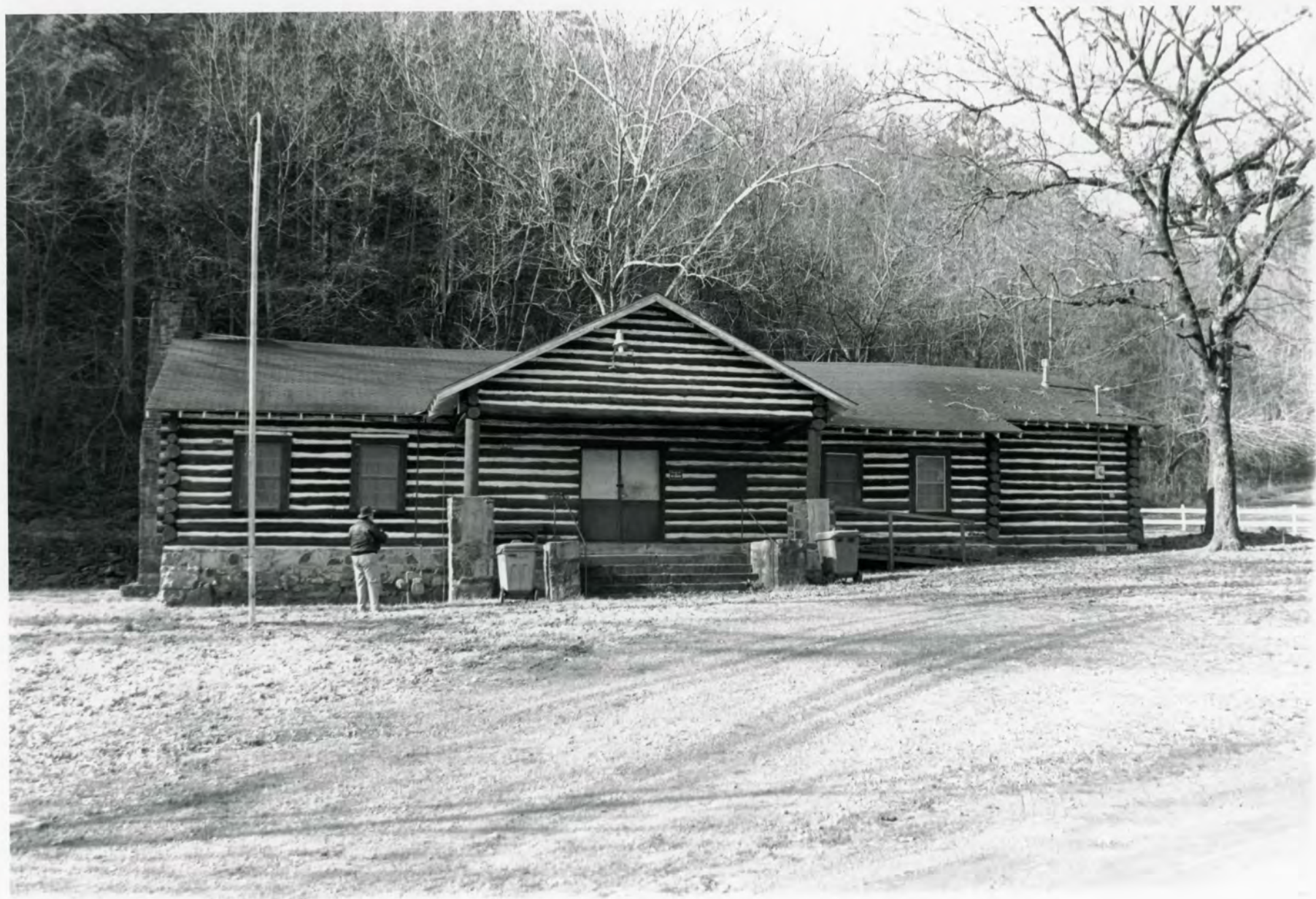
