ARCHITECTURAL DESCRIPTION:

The Scherer House is a two-story, four-by-three-bay, brick residential building with stepped gables. A narrow cast-iron balcony supported by simple wood braces extends across the facade. It was revealed intact when late-nineteenth-century galleries were removed during restoration. The two front entrances in the central bays have double-leaf doors each with six lights above and paneled below. Transoms have four lights. Windows and doors on the facade only are capped with cornice-type stone lintels. Windows are double-hung and in a six-over-six glazing configuration. The stucco walls of the building are scored to emulate ashlar masonry. Interior end chimneys with their corbeled caps are an especially rare feature in Biloxi. The interior trim, including mantels and medallions, is basically Greek Revival.

ALTERATIONS:

A double gallery with sawn millwork balustrades and spool-and-spindle friezes which was added in the late-nineteenth century was removed when the building was restored. Two-story rear addition.

STATEMENT OF SIGNIFICANCE:

Built in the mid-1840s the Scherer House is one of only four early brick buildings in Biloxi and among the first to have been finished with scored stucco. Its stepped gables are a unique feature not otherwise found on the Gulf Coast, and its facade is the first fully-developed example of the four-bay, double-entrance plan which became popular in the city.

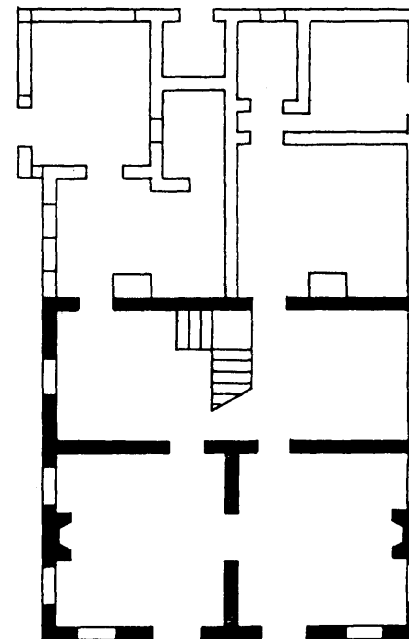
