SUMMARY:

The Sink-Crumb Post 72 American Legion Hut, located on the northeast corner of Second and Cherry streets in the small Clay County community of Knobel, is a tin-roofed square, cypress log building designed in the Rustic aesthetic common among Legion buildings erected during the early 1930s.

ELABORATION:

The Sink-Crumb Post 72 American Legion Hut, located on the northeast corner of Second and Cherry streets in the small Clay County community of Knobel, is a tin-roofed square, cypress log building designed in the Rustic aesthetic common among Legion buildings erected during the early 1930s.

The building sits atop a cedar-post foundation and is covered by a corrugated-metal, front-facing gable roof.

The front, or east, façade of the building faces Cherry Street. It is fenestrated by two openings that flank the wooden door, which is accessed by a four-step wooden stairway with a single railing. Above the door is a sign reading: AMERICAN LEGION/SINK-CRUMB/POST NO. 72. The fenestrations are covered by original wooden shutters. The windows here, as with all of the openings, have been removed because of vandalism.

The north façade features three openings, each covered by original wooden shutters.

The west façade features a door at its northern end and a shuttered window opening at its south end.

The south façade is fenestrated by two shuttered window openings.

INTEGRITY:

Despite the loss of its windows, the Sink-Crumb Post 72 American Legion Hut still retains a high degree of integrity. It sits on its original site, providing excellent integrity of location and setting. Its cypress log construction, shuttered windows and corrugated-metal gable roof all exhibit excellent integrity of design, materials, workmanship and feeling. Its Rustic design and entry sign clearly identify it as an American Legion hut, providing integrity of association.

SUMMARY:

The Sink-Crumb Post 72 American Legion Hut is eligible for listing in the National Register of Historic Places under Criterion C with local significance by virtue of its status as the best example in Knobel of a Rustic log meeting hall and under Criterion A with local significance for its association with the local activities of the American Legion in Knobel.

ELABORATION:

The American Legion was founded in France during the relatively quiet and uneventful days that followed the signing of the armistice that ended World War I. American enlisted men from all three of the principal branches of the service then in existence -- the Army, Navy and Marine Corps -- were billeted in various locations for the purpose of maintaining a military presence while the negotiators worked out the details of the treaty that would outline the political future of much of Europe for the next decade. These servicemen found life during the occupation uneventful and boring, and this only compounded the frustration felt by many at not being allowed to return home to family and friends. A small group of officers -- and especially Lieutenant Colonel Theodore Roosevelt, Jr. and Lieutenant Colonel George A. White -- met to discuss the possibility of establishing a veterans' organization which would include all branches of the military and which would serve the immediate purpose of providing an outlet for some of the energy and frustration felt by the occupation forces but which would also set as its larger goal the establishment of a nationwide veterans' organization that would provide its members with both a social organization and a vehicle for voicing their collective concerns about such issues as national defense, subversive activity, radical thought, domestic social programs and veterans' affairs.

Successive meetings over the course of the next several months in both Europe and America further defined the Legion's mandate and purpose. However, it was the shooting of four Legionnaires during an Armistice Day parade in the lumber town of Centralia, Washington, in 1919 by socialist International Workers of the World organizers and the subsequent coverage of the trial that followed -- in which the Legionnaires were portrayed as the aggressors -- that both galvanized and tempered the Legionnaire spirit. Both the public and the Legion press recognized the dangers of extremism by any party while admitting the need for responsible vigilance against any activity that threatened the democratic form of government. The American Legion began to grow steadily thereafter through an organization that elected officers on the national, state and local levels and provided a voice for its members regarding a variety of national concerns. During the Depression the American Legion distinguished itself in particular through the expansion of local programs targeted at youth. Of particular note were the founding of American Legion Junior Baseball, the American Legion Oratorical Contest and Boys' State.

The small town of Knobel, located in southwestern Clay County, was founded in the 1870s at the junction of the St. Louis, Iron Mountain and Southern Railway and a branch line that ran south along Crowley's Ridge to Helena. Like other towns around Arkansas, Knobel was home to many veterans, and when the American Legion began encouraging the creation of additional posts around the state in the late 1920s they decided to band together and create Sink-Crumb Post 72. The post was created in the spring of 1931, according to the *Arkansas Legionnaire*, which reported on April 4 that the post had formed recently with 17 charter members under the leadership of Post Commander Alfred Prince. November of that year, the *Legionnaire* reported that the post was meeting on the first and third Tuesday nights of each month.

A women's auxiliary for the post formed in 1932 after Miss Minnie Johnson, Fourth District President of the American Legion Auxiliary, met with members and families of Sink-Crumb Post 72 and organized a unit in Knobel. Charter members of the unit were Mrs. Taylor Fraine, Mrs. Roy Barnett, Mrs. Pearl Myers, Mrs. William Russell, Mrs. Clarence Chaffin, Mrs. Hazel Adams and Mrs. Eugene McGraw of Knobel, and Mrs. Alfred Prince, Mrs. Walter Baler and Mrs. Neil Goldman of Peach Orchard.

The members of the Sink-Crumb post determined that they needed a meeting place and almost certainly took advantage of funding available through the Civil Works Administration, one of the earliest of President Franklin D. Roosevelt's "New Deal" programs designed to put Americans back to work at the height of the Great Depression. Little is known about construction of the building outside of the fact that local men cut and notched the logs from which the building was constructed. The building was completed in early 1934 and the first meeting was held there on March 30. The *Clay County Courier* reported that "Sink-Crumb American Legion Post, No. 72, last Friday evening opened the doors of its new log hut, with a barbecue and special program attended by about 300 persons. . . . The lot on which the Legion hut is located was donated by Joseph Sellmeyer. A flag – made by the ladies of Knobel in 1918, with 24 stars, representing boys from Knobel who served during the World war – was dedicated and placed in the new hut." The *Arkansas Legionnaire* noted that there was "a large and enthusiastic crowd attending. A barbecue was served and speakers from other posts congratulated the Knobel Post on completion of its new clubrooms." Among the speakers at the event was O.C. Lynch, who until recently had served as Clay County's Civil Works Administration coordinator.

Though their numbers are declining, the Sink-Crumb Post No. 72 American Legion members continue to gather at their Legion Hut as they have for the past 74 years. The little log building at Second and Cherry stands as a testament to the efforts and accomplishments of Knobel's American Legionnaires.

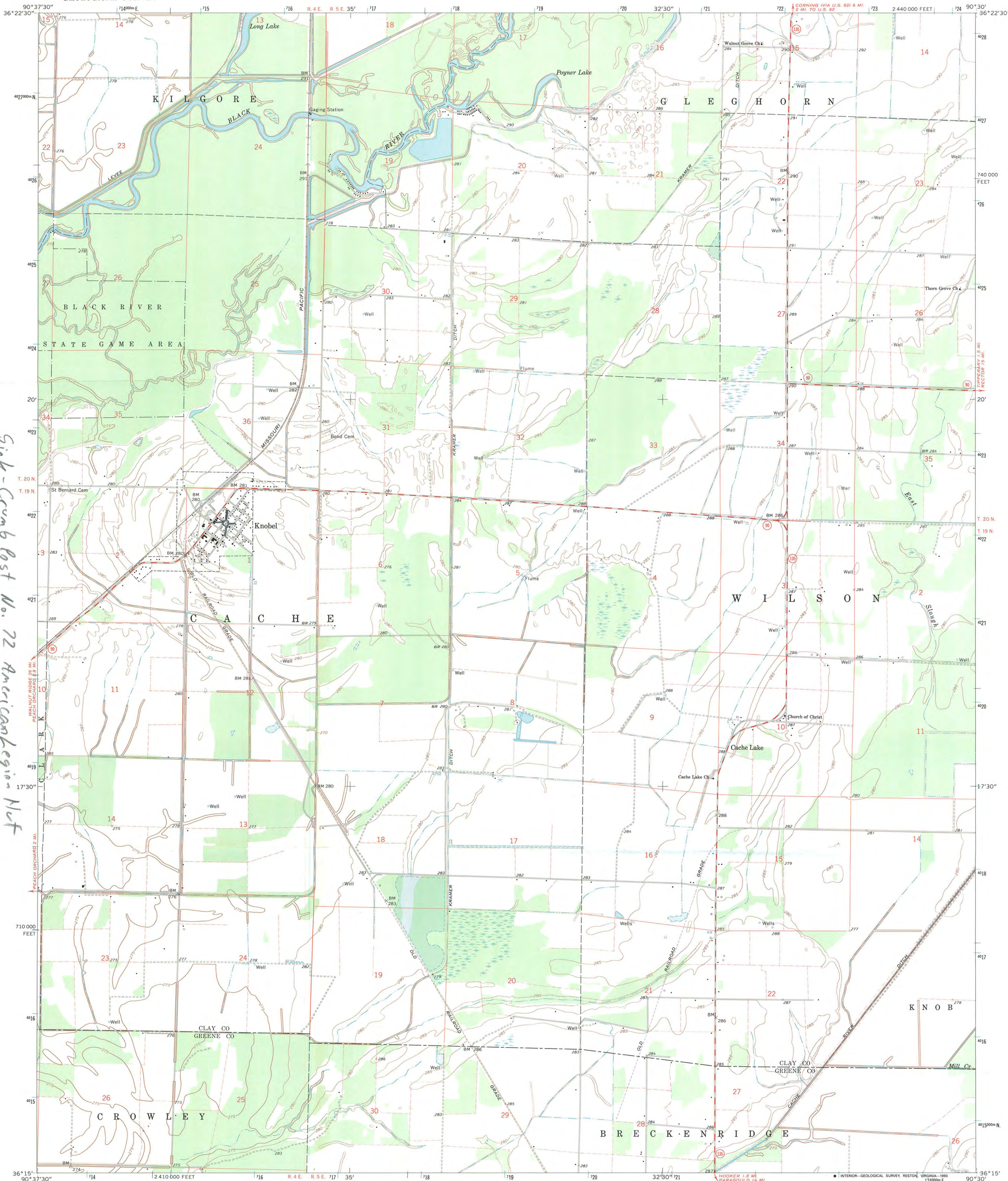

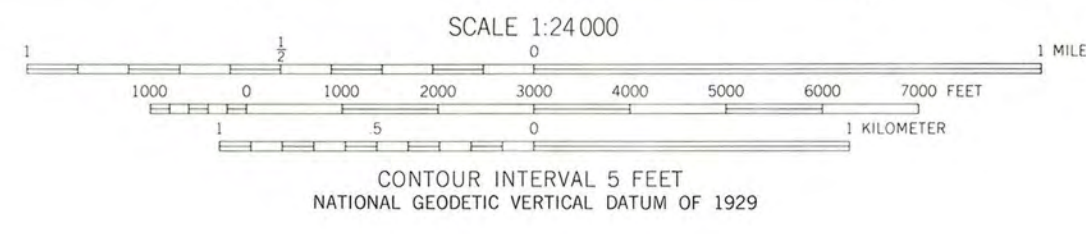

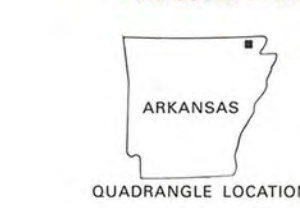
