Originally built in 1775 as an overseer's house by Michael Blocker, a Prussian emigre, later used by Blocker family after large plantation house burned. Two-story white clapboard with a one-story shed-roofed porch(2 rooms wide) which is supported by four original, square columns. Two original end chimneys and double front doors intact. Wide-board walls and floors. Magnificent, centuries-old magnolias and cedars, brought by Blocker family from Prussia. Path leads to family cemetery in which 85 Blocker descendants are buried. Oldest marked graves are Anna Loftar, wife of Michael Blocker (1725-1814) and their son, John (1749-1811).

Probably oldest surviving house in area which is still inhabited, an important visual example of 18th century living which Edgefield cannot afford to lose. The family cemetery, with its large graves, is a town landmark dating back to 1811. Impressive Prussian cedars and other old trees exemplify Edgefield's pastoral appearance and atmosphere.

Prominent families have been associated with the house. Michael Blocker, the builder, belonged to the same family as Prussian General Gebhard Von Blucher, who opposed Napoleon at Battle of Waterloo. In Edgefield, Blocker became known as "The Colonizer" because he sent his son John back to the Fatherland to persuade emigrants to settle in Carolina. Last member of Blocker family to own house was Mrs. Nancy Brooks Blocker, an aunt of U.S. Congressman, Preston Brooks. From Hughes family ownership of house (since 1871) are many family portraits, including one of Dr. William Crawford Gorgas, noted for control of yellow fever and malaria in Panama Canal Zone.

Present owner has beautiful collection of antique silver and books. Notable hand carved mantels, original wide-board walls and floors add to house's architectural significance. This is one of Edgefield's most prized homes.
