## NATIONAL REGISTER CRITERIA STATEMENT (if applicable)

The Andrew McCarron Three-Decker possesses integrity of location, design, setting, materials, workmanship, feeling and association. It is significant as a representative example of multi-family housing built in the Cambridge Street neighborhood in the 1920s, a period of continued industrial expansion in the area. It is also an unusually well-preserved and ornate example of local Colonial Revival three-decker construction. The McCarron Three-Decker thus meets criteria A and C of the National Register of Historic Places on the local level.

## ARCHITECTURAL SIGNIFICANCE Describe important architectural features and evaluate in terms of other buildings within the community.

Architecturally, 3 Pitt Street is a remarkably well-preserved example of the use of Colonial Revival style elements in local three-decker construction. The building is unusual for its massiveness and for the balance of its proportions. It is clad in wood clapboard, and has the characteristic side-hall plan, but is unusual in the four bay width of the main facade, and in its lack of bay windows or side-wall jogs. The pedimented, steeply pitched gable roof is also atypical. The main facade features a full length, one-story, projecting porch, which extends to three tiers in the entry bay. The three-tier extension is capped by a small, gable portico. The porch is supported by fluted, square columns. Corner pilasters on the main facade rise to a simple frieze band that is broken by the third story window openings. Windows are of 2/2 sash, and the first and second story surrounds have simple decorative caps.

## HISTORICAL SIGNIFICANCE Explain the role owners played in local or state history and how the building relates to the development of the community.

The McCarron Three-Decker is a relatively late (ca. 1918) example of three-decker construction in the Cambridge Street area. In a largely Irish descendant, working class residential area, the house was located near the South Works of American Steel and Wire, and next to the neighborhood landmark Church of the Sacred Heart. The first known owner of the house was Andrew McCarron, a woolsorter, who resided here, but who also owned a half dozen other buildings in the city. Early tenants included John McDermott, a helper; Michael McGuire, a driver; and Arthur McDermott, a driver. By 1928, the building was owned by Alexander Pisierski, a loomfixer, who also lived here. Tenants at this time included Edward Thompson, Patrick McPartlin, and Mrs. Winifred McElligott and family.

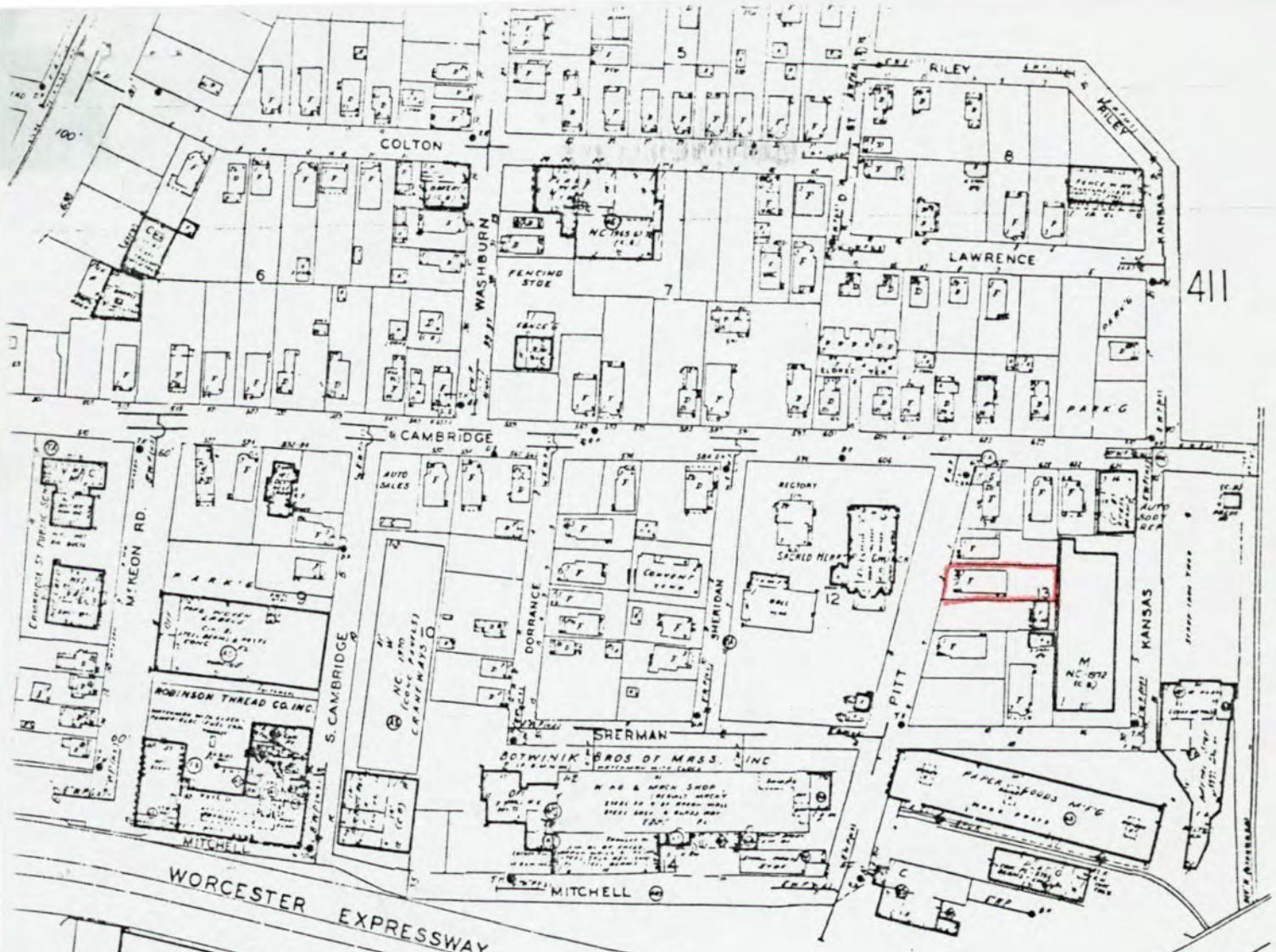

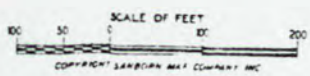
