The Norman and Florence B. Carmichael Residence was designed by Lilian Rice in 1930 as a large single story "U" shaped building sited on the flat of a ridge, overlooking a valley to the north. The house was sited to take advantage of the views of large boulders and adjacent arroyos. In 1935, Rice designed a second story which was added to the north wing. The Spanish Colonial Revival house is wood frame with white painted stucco walls. Medium pitched gabled roofs are red clay tile. In the rear patio area, roof lines overlap one another, much like large fans. Wood frame windows vary in size from single to multi-pane. Doors are dark wood and match the window frames in color. A chimney at the east end of the house has an interesting triangular spark arrester formed of red clay tiles. The patio, formed by the "U", is enclosed by a low wall and an entry gate covered by a tiled gable roof. Building records show the building has received few alterations. In 1987, a short balcony was added to the side of the house. No other changes are known to the main house, except for the removal of some interior walls to enlarge the kitchen. Also located on the property is the original garage built in 1930. The garage has received no obvious alterations or additions and is counted as a contributing building. In 1957, a swimming pool was installed and in the 1960s, a small cottage was built. These two resources, dating after the period of significance, are counted as noncontributing.

The Carmichael Residence is significant under Criterion C in the architectural history of Rancho Santa Fe as an excellent example of the domestic architecture designed by Lilian Rice in the Spanish Colonial Revival style and in the community planning and development history of California as a component of a carefully laid out group of buildings over a large planned area. The building exhibits Rice's careful and sensitive placement of buildings "which are conceived of as sculptural volumes, closely attached to the land, whereby the basic form of the building was broken down into separate, smaller shapes which informally spread themselves over the site." (Gebhard, 1967) The building exhibits the major characteristics of its property type, making it eligible for the National Register in the context of "The Work of Lilian Jenette Rice in Rancho Santa Fe During the Years 1923-1938."
