1. Name: William Redding House, survey number 68

2. Location: on the north side of a dirt road which turns east off Highway 61 just north of the Mimbres School and 1/5 mile east of Highway 61, Mimbres, N.M.

7. Description: Photo 33; map 5; 5 room, single file plan with shed roofed additions to rear; concrete foundation skirt; stuccoed adobe; corrugated gabled and shed roofs; 6/6 double hung windows singly and in pairs; 2 single doors to Turn-of-the-century vintage, ornamental wire, the front. pipe and cast iron fence in front of house. unstuccoed adobe room on the north, now used as garage, is thought to be contemporary with the rest of the house. This implies the balance of the building was originally unstuccoed and flat, or shed, roofed. Windows and gabled roof likely added later but still clearly historic period.

8. Significance: One of four unaltered historic buildings in the village of Mimbres. (See Sibole Store, #71, above for discussion of the development of Mimbres.) Farmer and rancher William Redding first paid taxes on this property in The house was probably built between then and 1902 1893. when the Redding ranch is noted in reports of the great flood of that year, and therefore meets Criterion A as a reminder of the early settlement of Grant County. The house is very good example of the single file plan of the New Mexico Vernacular type and, as a result, meets Register Criterion C .

UTM References: 13 221000 3638900 Verbal boundary: A rectangle, roughly 100' by 95', as shown on map 5, formed by lines parallel to and ten feet from the exterior walls of the building on the north, east and west and the ornamental fence on the south. Since this is an unplatted area, this boundary has been created to include only the building and the historic fence.
