


#### GENERAL DESCRIPTION

This is a 2-1/2 story, frame, single-family dwelling, conceived within the tradition of the American Colonial Revival. Dormer windows are situated on each slope of the building's hipped roof. The building also possesses a wrap-around porch on the south and east elevations, now enclosed but might originally have been open. The property is situated on a corner city lot and faces to the south and to the east. Although the house has been converted into a multiple-family dwelling, the integrity of its original fabric remains good.

#### HOUSE

Roughly speaking, the footprint of this house consists of a rectangle, which measures approximately 32' x 42' (width by depth). The building rests on a stone foundation. A 1-story, wrap-around porch is situated on the south and east elevations of the building. It contains an area of approximately 694 square feet. This porch (and the siting of the building, as discussed below) lends the feeling of a double facade to the building. This porch is covered with a low-pitched shed roof. The porch features a pedimented entrance on the south elevation and a semi-circular corner at the southeast of the porch. A porte cochere is situated at the rear of the building with an enclosed porch situated above it. This enclosed porch contains 280 square feet and is supported by wood columns.

This building is covered with a flared hipped roof. Dormer windows are located in each of the roof's four planes. These dormer windows are covered with hipped roofs with clipped corners. An exterior wall, brick chimney is situated on the east elevation of the building.

The house features numerous architectural details, including classically-inspired columns and capitals on the wrap-around porch, a pedimented entryway to that porch, a 1-story bay window on the west elevation, and wide eaves under the flared roof. The capitals of the columns feature a composite order design. The porch and the main block of the house both feature denticulation directly under the eaves. Original porch protectors remain extant beneath the deck of this wrap-around porch. They feature Roman-curia (or criss-crossed) decorative millwork and add another classically-inspired embellishment to the house.

In the interior, the first floor and second floors each contains a total area of approximately 1,403 square feet. The first and second floors feature mastic tile and softwood floors. The walls are plaster-finished. A full attic is situated between the roof and the second floor. The basement, which is also full, features a concrete floor and contains one apartment.

Although the house has been converted into a multiple-family dwelling, the integrity of its original exterior fabric remains good. A metal fire-escape ladder is situated on the facade between the dormer window and the roof of the wrap-around porch. Although this element is visually distracting, it is reversible. On the interior, some partitions of wood studs and panels were constructed during the building's conversion to multiple-family, but these additions are probably reversible as well.

#### SITE

This house is situated on Lot 7 and Lot 8 in Block 3 of Grimes Addition to Fairfield, Iowa. These parcels of land are located on the northwest corner of the intersection of West Adams Avenue and 5th Street. The house stands on the west side of South 5th Street and faces both south and east. The 2-lot size of this site adds dignity to the appearance of the house. This visual impression is strengthened by the fact that the site also occupies the corner of an intersection.

The immediate surroundings of the Louden House are generally level in topography. The overall feeling of the immediate area is residential. Most of the dwellings in the neighborhood date from the late Nineteenth and early Twentieth Centuries. West Burlington Avenue, which is an east-west artery in Fairfield and serves as the route of U.S. Highway 34 through the community, is located two blocks to the north. The neighborhood was never mapped for fire insurance purposes.

This house is located within walking distance of the Louden Machinery Company. The site of that office and factory at 607-609 West Broadway Avenue is about three blocks to the north. This house is also located near the house of Bruce's parents. The William and Mary Jane Louden House is situated at 501 West Washington Avenue, one block to the north.



### **ARROW LOCATES PROPERTY**







#### SUMMARY OF SIGNIFICANCE

Completed and first occupied as a single-family dwelling in 1905, the R. Bruce and May W. Louden House is historically significant, under Criterion A, because it calls attention to R. Bruce Louden for his leadership of the Louden Machinery Company through a critical period in the firm's history. Louden served as the company's third president from 1940 until his death in 1951. During that time, the company foresaw, prepared for, and successfully supplied vast quantities of overhead handling equipment to American industry during World War II. (See cover document.)

The period of significance, under Criterion A, for the R. Bruce and May W. Louden House is circa 1905 through 1948. This period reflects the time in which R. Bruce Louden served the Louden Machinery Company and lived in this house. The period of significance, under Criterion C, for the Louden House is circa 1905, the time when its construction was completed.

The property contains one resource for this nomination--the house itself.

### **INDUSTRY**

The R. Bruce and May W. Louden House is historically significant as the home of R. Bruce Louden (1885-1951) and calls attention to his career at the Louden Machinery Company. A son of William Louden (and known as "Bruce"), he became the third president of the firm in 1940 and served in that office until his death in 1951.

R. Bruce Louden's career also illustrates the entrance of the Louden family's second generation into the management of the Louden Machinery Company. Bruce had began his employment with the firm in 1903. He subsequently served in various capacities before assuming the presidency.

The R. Bruce and May W. Louden House is also historically interesting because of its siting. Situated only several blocks south of the Louden Machinery Company factory and only one block south of the William and Mary Jane Louden House, this location calls attention to a common pattern among Eighteenth and Nineteenth Century industrialists in America--the owner living near his factory. Such proximity facilitated monitoring the security of business property and provided convenient access to it. Bruce's decision to build his new home at this location was also undoubtedly influenced by its proximity to his parents' home and calls attention to the clan spirit among the Loudens. Bruce and May's house is situated on the same site as the parental home, except one block south.

Bruce and May continued to live in this house until circa 1948, when they sold the property and moved into smaller quarters at 1106 South Second Street in Fairfield. Bruce lived there until his death.

### ARCHITECTURAL BACKGROUND

The R. Bruce and May W. Louden House is a large and very good example of a residence influenced by Colonial Revival styling. The house features numerous architectural characteristics of this influence, including classically-inspired columns and capitals on the front porch, a pedimented entryway to that porch, a 1-story bay window on the west elevation, an outside brick chimney on the east elevation, and wide eaves with a flared roof. Original classically-inspired trellis-work remains extant beneath the deck of the wrap-around porch. This decorative detail adds distinction to the building because it is often replaced.

A study of this house and the William and Mary Jane Louden House at 501 West Washington Street illustrates the transition from the Free Classic styling to that of the closely related Colonial Revival taste in Fairfield. William and Mary Jane's house was constructed about five years earlier. It shows more attention to picturesque architectural elements—the 2-story bay windows on the east and west elevations, for example, add notes of irregularity to the building's design. Bruce and May's House, in contrast, is more tightly massed. The projecting bay windows are absent, and more attention is paid to symmetry of design. For example, the pedimented entryway on the wrap-around porch is centrally placed. This symmetrical design is further accented by a small projection immediately above it on the second floor and embellished with three ribbons windows. In contrast, the pedimented entryways on William and Mary Jane's house are strongly offset at the ends of the wrap-around porch.

#### REPRESENTATION IN OTHER CULTURAL RESOURCES SURVEYS

This house was surveyed in the early 1980s as part of a reconnaissance architectural survey of Fairfield, Iowa. At that time, this house was evaluated as not eligible for nomination to the National Register. (Area XV Regional Planning Commission)

This house was also surveyed in 1996 as part of the "Louden Machinery Company, Fairfield, Iowa" hybrid reconnaissance and intensive surveys of that historic context within Jefferson County, Iowa. As one resource within that survey, this house was evaluated as individually eligible, under Criteria A and C, for nomination to the National Register of Historic Places. The State Historical Society of Iowa was informed of this determination through the survey report.

#### POTENTIAL FOR HISTORICAL ARCHAEOLOGY

Although the site's potential for historic archaeology is, as yet, unevaluated, the site identification of other ancillary structures associated with this property is limited. Evidences of a barn, which might have stood at the rear of the property, might be uncovered.
