The Dawkins house is a two-story clapboard dwelling with a hipped metal roof. The facade consists of a veranda which is five bays wide. The veranda is enclosed by a balustrade and supported by six chamfered columns. Front door has a transom with sidelights while windows throughout the house are 9/9 double sash. East side of the house has a screen porch that is covered by a low gabled roof (added at a later date). Two exterior end chimneys are located on either side of the dwelling. The only major alteration to this antebellum house is a one story rear addition. Interior has high ceilings with large central hall which contains the stairs.

TATEMENT OF SIGNIFICANCE

The Dawkins house served as the residence of Judge Thomas N. Dawkins, a well-known political leader in Union County. As a young lawyer who was a Unionist during the nullification controversy, Dawkins was surprisingly popular with his constituency. Despite his Unionist beliefs, he was elected to the state legislature and was appointed solicitor of the middle circuit. After the War Between the States, Judge Dawkins served as a member of the state convention for the reorganization of the state government. In 1865 he was named to a committee that appealed to President Johnson for the release of Jefferson Davis, and in 1866 Judge Dawkins served as chairman of the state judiciary committee of the House of Representatives.

According to strong local tradition, the home of Judge Dawkins was used for several days in February, 1865, as Governor Andrew G. Magrath's head-quarters for executing the affairs of state. Governor Magrath had been forced to leave Columbia when General Sherman occupied the city and burned the State House.
