DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

St. Anthony's Church is located on Market Street in Louisville's Eest End, just outside the Russell Historic District (National Register- May 1980). Historically, Market Street was an important commercial and residential thoroughfare, but the past several decades have seen a decline in the economic vitality and architectural condition of the area.

The cornerstone of the High Victorian Gothic church was laid on May 18, 1884. A <u>Courier-Journal</u> article which appeared the same day gave the following description of the plans of the architect, W.H. Redin:

The design of the building is Twelfth century gothic. L'The foundations are of city quarry stone laid upon a heavy bed of concrete) and this part of the building will be unusually massive and substantial. The base of the church above ground is of North Vernon stone laid in range work, and the body of the building is brick, ornamented with pressed brick and stone.... The pinnacles and buttress-caps are of carved stone. ... The three doorways are gabled; their hoods are of stone, and they are decorated with pressed brick and terra cotta. The central doorway, which is in the tower, is surmounted by an elaborate foliated cross, and the side doorways are surmounted by decorated finials.... The interior is also designed after the Twelfth century Gothic, and is a very pure specimen of this style of architecture. The arches are groined, ribbed, and foliated, and the whole is decorated in the highest style of art. Twelve cluster columns, made of cast-iron, will support the clere-story, and from these arches spring over the side aisles.... The sanctuary is separated from the nave by a fine gothic arch and cluster-columns.... The side altars sit in dome-shaped alcoves on each side of it.... The windows of the church will be filled with stained and antique glass, and the five sanctuary windows are to contain Biblical figures. The organ and music gallery will be over the front entrances, and will give ample accomodation to fifty choristers.... The cost of the building completely furnished will be about \$80,000.

The church's most notable architectural feature, its stone filigree spire, was added about 1900. It was not part of Redin's original design, and its architect is unknown. At the same time, corner pinnacles were added to the tower and open stonework placed in the openings of the octagonal lantern. The spire and cross rise to a height of 250 feet,

In 1939, St. Anthony's suffered a great fire which completely gutted the church's interior and heavily damaged the convent and school buildings. Only the rectory escaped untouched. However, the church's exterior was saved except for the roof. Under the supervision of Louisville architect Walter C. Wagner, reconstruction of the three buildings was completed in 1940. The church roof consists of a single span, without a clerestory. Inside, the vaulted ceiling is steel-reinforced, eliminating the need for supporting columns. The walls are finished in smooth Bedford sandstone and pierced by Gothic windows containing the original stained glass. The floor is terrazzo. The main altar, composed of five types of imported Italian marble,

STATEMENT OF SIGNIFICANCE

The St. Anthony's Church complex--including, in addition to the church, the rector, school and convent, is one of the finest examples of Victorian Gothic architecture in Louisville. The outstanding stone filigree spire, reminiscent of the great cathedrals of Germany, is the only one of its kind in the city.

The sixth German Catholic church to be founded in Louisville, St. Anthony's Parish was established in 1866 to answer the needs of an expanding, post-war city. The original stone church sat very near the present site and served as the school and rectory as well. The cornerstone of the present church was laid on May 24, 1884 and work was completed in May of 1887. The commission for the design was awarded to the prominent local architect, William H. Redin. As well known during his lifetime as an artist, this native Englishman practiced architecture in Louisville from the mid-nineteenth century until 1891. Redin was especially noted for his ecclesiastical designs, including Grace Episcopal (1855), ¹ Anchorage Presbyterian (1869), St. James in Pewee Valley (1870), and the facade of Christ Church Cathedral (1870). Among other surviving works are the tower and gatehouse of Cave Hill Cemetery (1882) and the Cornwall House on Fourth Street (1879).

Redin's original plans envisioned a slate-covered steeple which was never built. It is not known who was responsible for the present one, which was added just after the turn of the century. However, it was undoubtedly inspired by the nineteenth-century, open stonework spires of the German cathedrals of Cologne, Ulm and Regensburg. Actually, St. Anthony's spire is closest in scale, if not detailing, to the first steeple of this type to be executed in Germany, that of the fourteenth-century Minster of Freiburg-im-Breisgau.

Walter C. Wagner, Sr. (1893-1977) oversaw the entire reconstruction of the parish buildings after the 1939 fire. Even the altars, communion railing and pulpit were executed from his drawings. Skilton & Sullivan Construction Co. was the general contractor. During his career, Wagner received many commissions from the Catholic Church, including designs for Holy Spirit and St. Francis of Assissi churches and two buildings on the campus of Ursuline College.

is surmounted by a statue of Christ the Worker. The side altars, contained within arched alcoves, have statuary of Cararra marble. The communion rail, of Rose Corallo marble and bronze, bears diamond-shaped panels depicting scenes of the life of St. Anthony of Padua. The pews are of golden oak.

To the east of the church, the red brick, Victorian Gothic rectory (1891) is richly decorated with pressed brick, rough-faced stone and terra cotta detailing. The gabled entry, capped by a trefoil stained glass transom, is contained in a central, gabled pavilion. The two stories have different types of pointed arch windows, which all have stone voussoirs linked by broad stone bands. The gable contains a pair of narrow windows separated by a slender colonette. A corbeled arcade embellishes the cornice line.

The three-story convent and two-story school adjoin one another to the west of the church. The recessed, arched entry to the convent is contained in a central, projecting pavilion. The wooden double doors are capped by a stained glass transom. Paired windows have brick voussoirs and pronounced sandstone keystones. Areas of textured brick and terra cotta medallions enrich the facade. The school is quite similar in its detailing. Large arched openings contain multi-paned, sash windows topped by areas of textured brick. The buttressed, central pavilion contains the arched entry. Above the triple doorway is a stone panel bearing an inscription in German and the date 1897. Both the convent and school are crowned by a crenelated parapet trimmed in stone which replaced the original gabled roofs after the 1939 fire.
