Description

The Centenary Avenue Historic District began developing around the turn of the twentieth century. The area was first inhabited by professors and administrators of Centenary Academy (now Lee College) which was located adjacent to the district. Centenary Avenue was named for the Academy.

The first property in the Centenary Avenue area to be constructed was the P. J. Craigmiles home (site #80, NR 11/20/75) on Ocoee Street. It was constructed circa 1866 on a large farm, just outside the city limits of Cleveland. Ocoee Street formed its front property line. The land surrounding the house remained agricultural into the early 20th century.

In 1873 the Centenary Female Academy was constructed on six acres of land just outside Cleveland. The first building was complete in 1873, and classes began that fall.

It was during the 1870s and 80s that Cleveland joined the industrial revolution. During these two decades many textile mills, stove works, chair factories and other industries began to develop. In 1886 Cleveland experienced a real estate boom, especially to the north of the city. This land was relatively level, and the property owners were willing to sell to speculators and developers. The property owners on the south and west side of town were not willing to sell. In 1886 most of the land east of Centenary Academy was platted and developed by a J. H. Parker, a real estate speculator. By July, 35 houses were under construction.

It is unclear when Centenary Avenue (which is west of the Academy) was constructed. There are references circa 1900 which refer to the Avenue, and there are houses along the Avenue which appear to have been constructed in the last decade of the 19th century. Who developed the property is unknown.

In the early 1900s John Bowman had purchased the Craigmiles property from Centenary Avenue to Eighth Street, and from Ocoee Street to Harle. Bowman made improvements on the land in the area of Eighth Street, including constructing a swimming pool and tennis courts. The City of Cleveland had annexed the area into the city around this time, and a city ordinance discouraged farming within

the city. Farm outbuildings, such as barns, were still extant following World War II. They were located along what is now Bowman Avenue.

Centenary Avenue and Harle Avenue (which runs perpendicular to Centenary) were almost fully developed by 1925 with only a few vacant lots. These were developed later (between 1925-1948). The streets are lined with houses in the Colonial Revival and Tudor Revival styles which were popular in the early twentieth century. The buildings maintain a regular setback from the street allowing for small front lawns and larger back yards. A variety of outbuildings have been located behind these houses, some of these outbuildings, especially garages, remain.

Between 1925 and 1930 Bowman Avenue (also known as Ninth Street), Milne Street and Oak Street were constructed. Housing construction quickly occurred on Oak Street, and by 1930 it was almost fully constructed. Bowman Avenue did not develop quite as fast, most of the houses located along it were constructed between 1930 and 1950, although many are also in the Tudor Revival and Colonial Revival styles.

There are many Bungalow and Craftsman style houses in the area, Ocoee Street, which separates the district from Lee College, has several examples of the Craftsman houses and there are Bungalows throughout the district.

The district was historically all residential buildings, and remains that way. However, commercial concerns have moved into some of the buildings, especially along Eighth Street. There are no religious or educational buildings located within the district, and few multi-family homes are in the district. The Cleveland Public Library (site #80) which was listed on the National Register (11/20/75) is an anchor for the district.

Some of the buildings in the district have had additions or alterations. Most of these additions are not intrusive. The most noticeable alteration is a change in the doorway of the Prairie Style house (site #35) on Centenary Avenue. On this house the original double doors have been replaced by a single door and a plate glass window, and the door surround has been altered. Additions have been made on the rear of some buildings along Centenary Avenue, they are mostly one story additions of the same

material as the historic building.

The Centenary Avenue Historic District retains a high degree of integrity of individual buildings and as a cohesive example of early twentieth century development. Buildings which contribute to the integrity of the district are counted as contributing (c), those which do not add to the integrity of the district because of alteration or construction within the last fifty years are counted as noncontributing (nc). There are 78 contributing buildings, 18 contributing outbuildings, 19 noncontributing buildings, 1 noncontributing outbuilding, and 1 building previously listed on the National Register.

The buildings which are not yet 50 years old will contribute to the integrity of the district when they reach that age if they maintain their current integrity. They add the examples of styles popular just after World War II to the district.

Statement of Significance

The Centenary Avenue Historic District in Cleveland, Bradley County, Tennessee is eligible for the National Register under criterion "C" for significance in architecture in Cleveland.

Although the Craigmiles House (#80) was built in the 1860s, the Centenary Avenue area began developing as a residential area as a result of the opening of the Centenary College (now Lee College) in 1884-85. Before the development of the College, the lands where it and Centenary Avenue are were unused. Shortly after the development of Centenary College, residential development began to occur along Ocoee Street and Centenary Avenue.

Centenary Avenue was laid around 1890, and the first extant residences on the street were constructed soon after (c1895). The neighborhood continued to develop through the early part of the twentieth century. Houses were designed in styles popular at the time, the Tudor Revival and the Colonial Revival were very popular, and later the Bungalow was also common.

At the same time as Centenary Avenue was developing other Cleveland neighborhoods were developing as a result of growing industrialization in the city. Many neighborhoods of housing for factory workers were being developed in the late nineteenth and early twentieth century. These neighborhoods consisted of buildings in traditional forms with little architectural ornamentation, later additions were frequently simple Bungalows.

None of the neighborhoods surrounding the industrial plants exhibit the architectural diversity of Centenary Avenue. They tend to be very simple with streets of practically identical buildings constructed to minimize costs of individual buildings.

The buildings of Centenary Avenue have diverse styles, but brick is the most common building material for the Colonial Revival and Tudor Revival. Brick is common for the Bungalow, although weatherboard siding is also found.

The Colonial Revival style, which is represented by about 40% of the district, where constructed throughout the period of significance of the district. Because the style remained popular until after World War II there are several Colonial Revivals from

the 1950s and the 1970s. Historic Colonial Revival houses are predominantly brick, sometimes painted or stuccoed, many are two story. Most have door surrounds and classical pediments, and multi-light windows. The post World War II Colonial Revival houses tend to be a smaller scale then those built before the War. They are one story, have weatherboard, vinyl or asbestos siding, and central entrances with classical surrounds. A few of the post World War II Colonial Revivals are two story. The Colonial Revivals are located throughout the district.

The Bungalow is the second most common style of house in the Centenary Avenue area. There are examples throughout the district but there are significant concentrations on Eighth Street and Harle The Bungalows are one story, frequently brick or weatherboard, with full front porches, many extending into portcocheres, with brick columns and piers. They have multi-light or single light windows. The Bungalow style is represented by about the buildings in the district. The Bungalow differentiated from the Craftsman because the Craftsman houses along Ocoee Street are a minimum of two stories (most are 2 1/2), use multiple building materials (stone, stucco and weatherboard; brick and stucco) in the same building. These houses all have full front porches and port-cochere, massive porch columns and piers, wide overhanging eaves, exposed rafters, and multi-light windows, sidelights, and transoms.

The Tudor Revival, which is represented by about 20% of the buildings in the district are exclusively brick, some with stuccoed front gables. Typical features of the Tudor Revival is an off center front gable, usually with the entrance, high pitched roofs, casement windows are common. The Tudor Revival is most common along Centenary Avenue but there are some modern examples along Eighth Street.

The other styles found in the Centenary Avenue area include the Queen Anne, Prairie, Italian Villa, and Ranch. There are few examples of these styles, and they are scattered throughout the area. Combined they are less then 10% of the buildings in the district.

Centenary Avenue is the only intact example of a primarily early twentieth century development in Cleveland. Other areas which developed around the same time do not exhibit the architectural NPS Form 10-800-a

diversity of Centenary Avenue or have the integrity of the district. Most of the industrial neighborhoods have been substantially altered over time, and do not retain their integrity.

Boundary Description & Justification

The Centenary Avenue Historic District is bounded on the south by Eighth Street, on the east by Ocoee Street, on the north by the rear property lines of properties on the north side of Centenary Avenue (marked 13th Street), Harle Street between Eighth and Willow, and the rear property lines of properties on the west side of Harle between Willow and Fourteenth Streets. See accompanying Cleveland, Bradley County, Tennessee Tax Maps 49-L and 49-K.

These boundaries represent the concentration of early twentieth century development in the area, they contain as many contributing resources as possible while excluding as many non-contributing resources as possible. Ocoee Street was chosen because of change in land use on the opposite side and the heavy traffic flow on Ocoee makes it a barrier. Eighth Street was chosen because of changing land use on the opposite side, and the historic buildings on the other side have been substantially altered. Harle and Thirteenth Streets were chosen because beyond them is mostly post World War II development.
