It was great talking with you last week.

Here is what I came up with:

12 of your existing wayside exhibits need minor updates: fonts, image links, etc.

12 of your existing wayside exhibits need updates: Grids, arrowheads, black band, images, fonts, and text changes.

4 wayside exhibits need to be recreated using old exhibits as reference.

Estimated cost for IDIQ contractor: \$26,000

Estimated cost for HFC to COR: \$4,000

This estimate is based on all high res images, existing InDesign layouts, text, and maps to be provided by the Government.

If there were someone available in house, the cost would be considerably less.
