## Description of present and historic physical appearance:

The H. Frank Jarrell House is a one-story, wood-framed Greek Revival style house built ca. 1849. It is located in LaGrange, county seat of Troup County, in central western Georgia, in a residential neighborhood of mixed style and age but with commercial property only one block away.

The house is set on 7-foot-high brick foundation piers. On the exterior there is clapboard siding with wood moldings and trim. Four large paneled columns support the recessed front portico. The house contains multi-paned windows, symmetrically arranged, with very heavy blinds and original hand wrought hardware. The front doorway is centered on the front facade.

On the interior, there is a 14-foot-wide central hall with 3 rooms on each side. Each room is approximately 15 x 20 feet in size. There is one fireplace centrally located in each room. The interior walls are plaster with wood trim and moldings. The hand-shaped trim reflects fine craftsmanship. The ceilings are 14 feet high.

The wide central hall has a divider, added in 1885, at the front to form an open foyer. On this divider is a central pier mirror surrounded by two wooden Ionic columns and two smaller marble Ionic columns.

The house was built using hand-hewn beams and large pegs. The lath under the plaster is hand cut.

Originally the house had only 6 fireplaces for heat. The hot air furnace and air conditioning were added in 1956.

The grounds have been landscaped during the recent rehabilitation.

Originally there was a detached kitchen, a barn and a two-room servants' house, as well as an original "garden pavilion," a sort of long rectangular gazebo in the rear. All of these original outbuildings are gone and a new garden pavilion has been built during the recent rehabilitation.

Earlier changes to the property included the destruction of the original back portico and its replacement by an assortment of lean-to rooms which housed a make-shift kitchen, a bath and a furnace room. A second bath was added in the west center bedroom in 1956. All of these additions were removed during the recent rehabilitation which transformed the house into a gift shop. Major additions were new lighting and a large desk in the center hall.

Significance of property, justification of criteria, criteria considerations, and areas and periods of significance noted above:

## Narrative statement of significance (areas of significance)

The Jarrell House is significant in <u>architecture</u> as an excellent example of the Greek Revival style. Built around 1849, the house exhibits all the major characteristics of this style, including a symmetrical front facade with a recessed front porch with square columns, pilasters, central entrance with transom and sidelights, flush weatherboarding under the portico and fluted and dog-eared moldings. The interior contains classical features including moldings, mantels, columns set in antis, and a ca. 1885 room dividing screen between the entrance hall and the central hall, as well as the symmetrical central-hall floor plan. Construction materials and techniques including heavy hand-hewn timber framing and hand-split lath are typical of this period in residential architecture.

## National Register Criteria

The Jarrell House meets National Register Criterion C because its antebellum Greek Revival styling shows the distinct characteristics of an important American architectural style. All of the components evidenced in this house—the columns, pilasters, symmetrical arrangement, central hall with flanking rooms and architectural detailing—are elements of this style which became popular in the deep South around 1830. This house is an almost perfect example of a one-story cottage in this style.

#### Period of significance (justification)

The period of significance is given as only the date the house was built, since its significance derives primarily from its Greek Revival architecture. While it was the home of many prominent local people from its creation until it became a church reading room in the 1950s, significance is not being claimed on behalf of any of them in this nomination.

#### Developmental history/historic context (if applicable)

The history of the H. Frank Jarrell House begins with the supposed building date of 1849. Troup County had been opened for settlement for twenty-two years, since 1827, at the time the house was built. During these decades, Lot 85, a 202 1/2 acre lot, had changed hands several times. The large lot was not divided until 1849 when only two acres were sold for \$322.87 to Sylvanus Bates. It is on those two acres that this house was built and the house's lot remains approximately that same size today.

Bates, who owned these two acres for five years, is considered the owner/builder of this house. He was headmaster of LaGrange High School and a teacher there in the 1850 census. Bates and his family of six lived off campus in this house.

Bates sold the house and 2 acres in 1854 for \$1,550 and moved to Macon, Georgia, where he was living in the 1860 census. The five-fold jump in price indicates major improvements, presumably due to the building of this house.

The new owner, John L. Stephens, an attorney, swapped the property in 1855 with William F. Dansby (1811-1899), a merchant, planter, and member of the Board of Trustees of LaGrange High School. Dansby was living there in the 1860 census. After 10 years, he sold in early 1865 the 2 acres for \$10,000 (This large price could reflect inflationary values in Confederate money at the close of the Civil War) to John Pope Culberson, a local planter, builder and lawyer. Culberson had served in the Georgia legislature during 1849-1850 and founded the LaGrange to Oxford (Alabama) Railroad. In 1868 he sold this house and lot for \$5,000 to Richard Floyd Thomason (1815-1877), a farmer, justice of the peace, city council member from 1876-1877, and former captain in the Confederate Army.

In 1873 Thomason sold the place to William P. Edmondson (1829-1907), a planter and merchant. His wife was Sarah Birdsong Edmondson (1832-1903). The Edmondsons' daughter, Lola (ca. 1859-1955), married in 1888, H. Frank Jarrell (1852-1929) and thus the house later became known as the Jarrell House. During the Edmondsons' ownership, they added a large pier mirror in the entrance way around 1885. When the front doors were open, it reflected the light outside and could be seen by people who passed by from the street.

In 1903, Mr. Jarrell moved to LaGrange and established the LaGrange Hardware Company, a business he headed for 26 years until his death in

1929. Two of the Jarrell sons who grew up in this house attended the U.S. Naval Academy. One was Albert Edmondson Jarrell, who became an admiral, and was Senior Military Representative of the Allied Powers in Korea and Chief Negotiator for two years at Panmunjom, Korea, for the settlement ending the Korean War. The other, Henry T. Jarrell,

Captain U. S. Navy retired, was born in the house in 1903.

Throughout the years, from the Bates through the Jarrell family, this house has served as a principal residence for many prominent citizens of LaGrange. When this house was constructed, it was considered on the fringe of the city. The high school and a few other homes were all that stood at the time in the area. Farm land surrounded it. As the 1880s led to further residential development on this street, it became one of the elite addresses of LaGrange. The construction of various Victorian mansions at the turn of the century, added to the few antebellum ones, created this status. As the 1930s developed into the 1950s, this street fell into slight decay. The construction of smaller, albeit neat, homes began to crowd the once spacious lawns and gardens. In the 1960s, this house and only a few others, mostly newer ones, were maintained. Rentals and apartments appeared up and down the street and eventually everyone financially able to do so moved.

This house continued as a place of residence until Mrs. Jarrell's death in 1955, when it was purchased by the Christian Science Society of LaGrange in 1958 and used as a church and meeting place.

It remained as such until 1989, when it was purchased by the current owners and rehabilitated for use as a gift shop.


