Describe present and historic physical appearance.

Building 6981 is currently unoccupied. It is located on a wooded undeveloped area of Camp Shelby. It appears to have undergone little or no modification since it was built in 1918. The single room building is essentially square with walls 20 feet 4 inches in length on the east and west sides and 20 feet on the north and Interior wall length is 19 feet 2 inches. south sides. The walls are constructed of concrete poured over a wire mesh frame. Interior walls are paneled in horizontal unfinished pine boards to the height of the tops of the door frames. The building is seated on a poured concrete slab which rises three feet from ground surface. Interior wall height from floor to ceiling cross beams is approximately thirteen and one half feet. There are eleven cross beams. A poured concrete loading platform 20 feet long and 5 feet 10 inches deep abuts the north facade of the building. A double leaf wooden door is centered in the north The leaves of the north door are constructed of a double facade. layer of 1 inch by 6 inch boards clad in galvanized metal. These doors do not appear to be original to the building. A second pair of double wooden doors which appear to be original to the building are centered in the south facade of the building. The doors are double leaf. Each leaf contains two panels of 3 inch diagonal beaded board. The doors are 6 feet 5 inches tall. Each door opening is 4 feet 6 inches wide. A set of 5 poured concrete steps provide access to the south door. The step risers are 1 foot deep x 5 inches high x 4 feet 6 inches long. The roof, which is also constructed of concrete poured over wire mesh is a modified clerestory type with a raised center section to provide interior ventilation.

With the exception of one recent set of doors, Building 6981 does not appear to have been substantially altered since it was built in 1918. As noted previously, the double-leaf doors in the south facade appear to be original elements of the building. The building is in fair to poor condition as evidenced by holes in the outer walls and major cracks in the walls and foundation slab. There are no other buildings associated with this property.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

Building 6981 at Camp Shelby is significant at the state level under Criterion A for its historical association with the development of Camp Shelby as a military mobilization and training center during World War I. It is the only building on the installation that survives from World War I.

Camp Shelby was established in 1917 as a facility for mobilizing and training US Army forces. About 6000 National Guard soldiers from Indiana, Kentucky, and West Virginia were sent to the new post, which was named in honor of Isaac Shelby, a Revolutionary War hero and the first Governor of Kentucky. These troops formed the nucleus of the 38th Division, which took the nickname "Cyclone Division" after a tornado occurred during their training at Camp Shelby. Some 36,000 troops were eventually stationed at Camp Shelby during World War I.

During the World War I period Camp Shelby's cantonment area was largely a vast array of tents. Few permanent buildings were constructed. One early map indicates that four small ammunition storage buildings were the only permanent buildings on the entire installation. Three of these were eventually demolished, leaving the structure now called Building 6981 as the only surviving building from the World War I years.

Camp Shelby was inactivated shortly after Word War I. In 1934 the State of Mississippi acquired the property for use as a National Guard camp. It became a federal installation in 1940, and was a major training center during World War II. Construction of new facilities in World War II obliterated most traces of the original camp. Most of this later construction was demolished or substantially altered after World War II. The existing facilities were largely built after 1954, when the post was designated as a permanent training site for reserve forces.

Building 6981 is the only surviving building associated with the World War I era at Camp Shelby. Few, if any, other properties directly associated with the military mobilization for that war survive in the entire state of Mississippi.
