bays with a center door and faces east, has a full shed porch with chamfered columns, asphalt shingled gable roof, decorative apron and scalloped shingles in the gable end, a stone foundation, stone step up to a paneled side door, rear, two-over-two sash, south side single light double hung windows and a interior brick flue (photos 9-6,7,9). The cistern with metal pump is located directly southeast of the front of the store near the road intersection. The building maintains excellent integrity and is in very good condition.

The nominated area includes one contributing building and one contributing structure.
