#### 7. Description

Condition: Excellent

**Description:** The Administration Building is a three-story brick Collegiate Gothic Revival style building with a steeply pitched slate roof and pointed pedimented gable ends. Windows are 6/6 double hung grouped together with concrete lintels and sills. Entries have cast concrete pointed arches and wood doors with lites. Exterior details include shallow relief shields/coat-of-arms between floors. The building was designed by Orville R. Walker and built in 1931. There was an addition to the building in 1936. Its historic and current use is administration. The shape of the building is rectangular.

Statement of Significance, Criterion C: The Administration Building is the only building on the campus of Eastern New Mexico University included in this nomination. The Administration Building is significant because it was the first building constructed on the new campus. The first wing was completed in 1931, two years before the school began its first session of classes. The building was completed in 1936 using WPA funds. The building was to be constructed using the "Old English type of

architecture". Orville Walker, an architect from Lubbock, Texas, designed the Administration Building using the Collegiate Gothic Revival style. This style has become the dominant architectural style at ENMU. The only other New Mexico campus to use a similar style is the New Mexico Military Institute, which uses a consistent Gothic Revival Style. Both ENMU and NMMI are located in eastern New Mexico and have established campus styles consistent with each other, but different from the other campuses in New Mexico. These schools have established a collegiate style for the eastern region of New Mexico.

**Description:** The Administration Building is a one-story brick Mediterranean style building with a hipped roof of French tile and soffitted wood overhang decorated with built-up dentil course. Windows are metal casement with a concrete sill and lintel that forms a continuous banding around the building. Entry has flat roof with concrete coping over metal casement windows with fan lites and 24 lite metal door. Each brick arch over the windows shares concrete springer bases. The building was renovated in 1941 and 1980. The windows may have been changed in 1941 remodel. There is a brick soldier course added to form a wainscot from grade to just below window sills in 1980 remodel. A handicapped ramp has been added at the entrance. The building has a rectangular shape. This building was designed by the architectural firm of Trost and Trost in 1918. 8. Significance Areas of Significance: Architecture Date: 1918-1920 Builder/Architect: Trost and Trost Statement of Significance. Criterion C: 7

Statement of Significance, Criterion C: The Administration Building is significant as the only extant building of those designed at NMSVH by the firm of Trost and Trost between 1912 and 1920. It is a good example of the style that Trost and Trost established on the campus during this period, and the only remaining building in the Mediterranean Style, which as used here is similar to the Decorative Brick style of later campus buildings. The Administration Building illustrates the Trost style which influenced all subsequent campus building. The overall impression of the campus is one of having a uniform style with individual variations among the buildings.
