

This house, while having been altered through the years, still retains a sufficient amount of its original fabric that it should be recognized and retained. We are therefore including it for its architectural significance, for its association with the exploration and settlement of the Bergen County area, and for its remaining historic fabric. As such, it is included in the Thematic Nomination to the National Register of Historic Places for the Early Stone Houses of Bergen County, New Jersey.

FLOOR PLANS



Peter and Margaret Pulis Winters owned this house at the time of their daughter Susen's birth in 1833. She married John Demarest, and these two celebrated their seventy-fifth anniversary in 1925. It is their sons and grandsons who are [were then?] operating Spring Lake Farm in Wyckoff.

The year 1876 finds William M. Coerter in residence here. "Uncle Willie" served in the Civil War, and was one of the few residents of Bergen County to receive a bayonet wound, as Company C of Bergen County's Twenty-Second Regiment never engaged the enemy in actual combat, but was held in reserve. Mrs. Eleanor Coerter Pulis is William Coerter's daughter and was born in this house.

The living room of the "Winter's farm house," as it was called, is thought to be the oldest section. Some of the glass panes in the rear of the house are still the original panes. The ceiling of the living room consists of the heavy wide boards of the second floor, supported by massive beams. Some of these still have bits of bark on them. Another unusual feature of the house is the extraordinary broad staircase, and the square headed nails. There is a built-in cupboard as well as a fireplace in the dining room.

The stone walls of the first floor are $1\frac{1}{2}$ feet thick. Straw and clay are found in the basement foundation.

The barn was across the street, and has been remodeled. Mr. and Mrs. E. Freshwater live[ed?] here at 830 Circle Avenue. Mr. Freshwater is [was?] the Post Master of Franklin Lakes.

Mr. and Mrs. Joseph Laciura are the [then] present owners of the "Winters" farm house, located on the road leading from Leaser's corner (formerly Hammond's) directly on the next turn of that road (Circle Ave. and Mountain Ave).
