Belview Heights Historic District Narrative Description

A residential neighborhood located in the western suburbs of Birmingham, Alabama, the Belview Heights Historic District is part of the Ensley community. Once a separate municipality, Ensley was founded in 1886 by Colonel Enoch Ensley who laid off the town utilizing a typical grid pattern which was common for city planning in the late 19th and early 20th centuries. Ensley experienced rapid growth and by 1907 was a town of more than 10,000. In 1910, Ensley was one of the eight separate towns that were consolidated to form the greater Birmingham municipality. U. S. Steel, the giant conglomerate that purchased the Tennessee Coal, Iron and Railroad Company in the 1910s, dominated the economic and social worlds of Birmingham in the early 20th century. In 1915, the City of Birmingham erected a fire station at the corner of Avenue Q and 44th Street and soon after, in the 1920s, Belview Heights was developed as a neighborhood for the professional employees of U. S. Steel.

Belview Heights consisted of 30 square blocks laid out in a continuation of Ensley's grid system with five avenues running north and south and five cross streets running east-west. The present historic district includes 20 of the original 30 square blocks. Avenues throughout Ensley were simply delineated alphabetically; today, Avenues M, N, O, P, and Q run through Belview Heights. Streets were given numerical titles; 41st, 42nd, 43rd, 44th, and 45th Streets run through the district. Avenues are 50' wide while cross-streets are 60' wide. Each block contains 22 residential lots. Throughout Belview Heights Historic District, residential lot sizes are uniform, 50' x 140', and houses, with few exceptions, were constructed facing north and south along the cross-streets. Residences are uniformly set close to the street with secondary structures located to the rear along the common alleyways. This particular arrangement strengthens the visual appeal of the neighborhood, providing stretches of houses in various styles popular during the period's significance. Too, by placing the primary residence closer to the street, homeowners typically have large and spacious rear lawns and yards. Throughout the area, one finds the Southern flora typically found in such neighborhoods, varieties of oak, pecan, dogwood, pine and sweet gum. Lots are usually embellished with attractive landscaping and the district contains curbs and sidewalks. Occasionally, a dwelling may boast attractive stone or cobblestone retaining walls.

As one would expect from a neighborhood located in the rolling foothills of the Appalachian Mountains, the terrain of the Belview Heights Historic District is slightly undulating, providing a pleasant setting for neighborhood lots on a rolling plateau. An economically stable middle-class neighborhood, Belview Heights Historic District contains an impressive collection of architecture dating from 1920 through the 1950s, reflecting the creation of this specific area within the East Lake development, as well as the continued growth and popularity of the Ensley area through the mid-twentieth century.

Two non-residential buildings, the Central Park Fire Station #24 and Central Park Presbyterian Church, are located in the Belview Heights Historic District. Restored in the mid-1980s, the fire station, ca. 1915, is an excellent example of utilizing early twentieth-century revival-style architecture in the design of a municipal building. The Tudor Revival style fire station blends-in with the surrounding residential architecture of the district. Central Park Presbyterian Church, ca. 1950, is a large religious structure incorporating Spanish and Mediterranean elements, including buttresses, spiral colonettes, palladian windows, a tile roof, and an octagonal lantern resting atop a three-tiered square bell tower. From the 1920s through the 1950s, George Turner, the architect of Central Park Presbyterian Church, designed scores of dwellings throughout Birmingham in the Spanish and Mediterranean Revival Styles, including a number of churches.

The styles of residential architecture found in the Belview Heights Historic District include Tudor, Colonial and Spanish Revival, Bungalow/Craftsman, Minimal Traditional, Ranch, and Modern. The primary form of construction is wood frame while the exterior wall material ranges from simple weatherboard and wooden shingles to brick veneer and stucco. Most dwellings are one-story although there are some one-and-a-half and two-storied dwellings in the district. The topography of the district allows for the accommodation of basements and, indeed, a number of the dwellings constructed in the 1920s and 1930s rest on full basements.

The most interesting architectural aspects of the Belview Heights Historic District are the 154 single-family residences that were designed and constructed in the Tudor Revival style. Comprising almost half of the total number of contributing resources, these Tudor Revival style dwellings architecturally dominate the streetscapes of the district. The Tudor Revival was popular in the district from the late 1920s through the early 1940s. Often found lining entire city blocks, the Tudor Revival houses typical feature brick veneer exteriors, complex rooflines, and front-facing brick chimneys. Red brick veneer is the standard exterior wall material although occasionally, a particular house may be

embellished with rough stone quoins or stone voissoirs. Stone work is occasionally used to embellish a chimney, which may be capped by an elaborate chimney pot. Almost all of the Tudor Revival style dwellings have front-facing gable wings, incorporating both a porch and/or an entranceway. These front-facing gables are often embellished with stucco exterior wall material and faux half-timber detailing. The single-leaf entrance is usually rounded and set in a gable-roof entranceway. The majority of these houses have some type of porch, usually supported by arched piers. Windows are typically double-hung sash although some houses have casement windows with diamond-shaped panes.

In addition to the Tudor Revival style, another prevalent architectural style in the Belview Heights Historic District is Bungalow/Craftsman. One hundred and four of the 423 resources in the district were designed in the Bungalow/Craftsman style, reflecting the popularity of that particular style in the 1920s when building in the district really began to take off. These structures are primarily frame with cross-gable roofs, wide overhanging eaves with exposed rafter ends and partial or full-width porches supported by tapered posts on low brick piers. While some Bungalow/Craftsman dwellings have brick piers, some of the Bungalows in the Belview Heights Historic District have cobblestone foundations, balustrades, and piers. Only one dwelling is characterized as an American Foursquare structure that has Craftsman detailing.

Five houses in the district were designed in the Spanish Revival style. These dwellings are also attributed to George Turner, the Birmingham architect who drafted plans for over 30 Spanish Revival style houses in eastern Birmingham as well as a number of homes in the Hollywood section of Homewood. The five one-story houses have ceramic tile gable or flat roofs that are hidden behind low-lying parapet walls. The exterior chimneys are typically capped with elaborate chimney pots or roofs. These dwellings are embellished with partial-width porches with spiral columns, semi-circular arches, tiled floors, and curving garden walls. The two Colonial Revival dwellings in the Belview Heights Historic District are one-story frame cottages covered in wooden shingles. They have symmetrical facades, side gable roof, exterior end chimneys, and small porches supported by classical colonettes.

Ninety-five houses in the district that are categorized as Minimal Traditional reflect the continued popularity of Belview Heights in post-World War II Birmingham. Mortgage records indicate that many of these dwellings were built between 1948 and 1950. Typically, these one-storied houses have three- to five-bay facades, cross-gable roof with front-facing gable wings, partial-width porches, and single-leaf entrances. These frame dwellings typically have weatherboard exterior wall material.

Most of the fifty-four ranch houses located in the Belview Heights Historic District were constructed in the mid-1950s and 1960s and, like the minimal traditional houses of the late 1940s and early 1950s, these dwellings reflect the continued popularity of Belview Heights. These houses were constructed on the remaining vacant lots in the neighborhood. While most ranch houses have brick veneer exteriors, some in this district are covered with asbestos shingles. All of these ranch houses have low-lying, cross-hipped roofs with wide overhanging eaves, picture windows, and small recessed porches. Four houses are classified as modern dwellings and three are classified as having no style.

Today, the Belview Heights historic district contains a significant collection of resources that clearly reflect the development of the neighborhood during the period of significance 1920 to 1950. The district includes 20 of the original 30 city blocks of the Belview Heights development. The nomination contains 423 resources, 35 5 contributing and 68 non-contributing.

Archaeological Component

Although no formal archaeological testing has been conducted, the potential for subsurface material remains minimal. Subsurface remains could reveal information that may be useful in interpreting the district.

Belview Heights Historic District Statements of Significance

Criterion A – Community Planning and Development

The Belview Heights Historic District is eligible for listing in the National Register of Historic Places under Criterion A – Community Planning and Development. In the 1910s, Robert Jemison, Jr., noted Birmingham real estate developer, and his Corey Land Company developed Belveiw Heights as a planned neighborhood for the professional employees of U. S. Steel, the industrial giant which dominated the social, economic, and financial atmosphere of Birmingham in the first half of the 20th century. Consisting of 20 of the original 30 square blocks, Belview Heights Historic District is laid out on a grid system, an extension of the plan first used in the development of Ensley in 1886. The district reflects the industrial and residential growth in the Birmingham District due to the rapid expansion of the coal, iron, and steel industries throughout the first half of the 20th century. Belview Heights is an excellent example of a planned subdivision utilizing the grid system, a plan used throughout the Birmingham District during the early development of the region.

Criterion C - Architecture

The Belview Heights Historic District is eligible for listing in the National Register of Historic Places under Criterion C – Architecture. Containing an impressive assemblage of architectural styles popular in residential suburbs throughout the United States in the first half of the 20th century, Belview Heights boasts one of the largest saturations of Tudor Revival architecture in Birmingham, reflecting the popularity of that particular style from the 1920s through the 1940s. The district contains examples of Colonial and Spanish Revival, American Foursquare, minimal traditional, and ranch houses as well as a large number of Bungalow/Craftsman dwellings. Of the 423 resources located in the historic district, 154 can be classified as Tudor Revival-style. Included in the district are a Spanish Revival church and a Tudor Revival fire station. The district remains intact and there is very little in-fill housing. Alterations and modifications have been minimal and the houses are attractive and well-maintained. The district retains a high degree of integrity in regard to design, feeling, materials, craftsmanship, and sense of place, clearly reflecting its period of significance, 1915-1950.

Belview Heights Historic District Historical Narrative

In the 1910s, the Corey Land Company developed Belview Heights in Ensley, Alabama, as a neighborhood for the professional employees of U. S. Steel. U. S. Steel had purchased the holdings of the Tennessee Coal, Iron and Railroad Company (TCI) in 1907 including substantial holdings in the industrial boomtown of Ensley. Enoch Ensley, a wealthy planter and entrepreneur from Memphis, had acquired large tracts of land in Jefferson County in the early 1880s. In December of 1886, at the height of the Birmingham iron boom, Ensley began construction of monumental industrial facilities and a town six miles to the west of Birmingham. Contemporary accounts described the site in Opossum Valley as "rough, sterile, full of scrubby pine and blackjack." More important from an industrial viewpoint was the fact that the wide valley bordered on the southern edge of the Pratt coal seam. Ensley intended to fill this site with blast furnaces, steel mills, rod, wire and hoop mills, and car works, cheaply converting Birmingham's mineral resources into finished iron and steel products. Ensley described his vision for the new industrial center to Alfred M. Shook, fellow Tennessean and general manager of TCI, asserting that the new center would be like a "brindle cow sucking herself," and ultimately dwarf her sister city, Birmingham. Enlsey named the new center of TCI's industrial operations after himself. He pushed the work of constructing the furnaces, opening ore mines, coal mines and quarries and building a new town as rapidly as man and money could to it.1

On December 7, 1886, the Ensley Land Company was incorporated to carry on general manufacturing and industrial business and to buy, sell, and hold lands and improve the same by dividing them off into lots, streets, parks, racetracks and lakes, to build tramways, railroads, and waterworks. Incorporators were Thomas D. Radcliff, T. T. Hillman, William A. Walker, and Enoch Ensley, president; capital stock was a highly watered \$10 million, 51 percent of which was retained by TCI, from whom the land company purchased 4,000 acres. Devoting one year to preliminary improvements, Ensley had the 4,000-acre tract surveyed, plotted and laid out in a rectangular grid pattern flanking the plants. Noted sanitary engineer George Edwin Waring, Jr. from Newport, Rhode Island, laid out streets and avenues and installed a complete sewage system providing separate pipes for storm water and sewage. Waring had previously installed a system for Memphis, where he introduced the European "separate system" into the United States, where it remains common practice today. Streetcar service was extended to the community from Birmingham in 1887. During 1888, Colonel Ensley completed a land company office on the corner of 19th Street and Avenue E and a wood frame hotel directly across the street. That same year, he began construction of four major blast furnaces, each of 200ton daily capacity. The last of "the big four" was lighted on April 4, 1889, under Ensley's personal supervision. At this time, the group of furnaces was acclaimed to be the largest in the world. Despite his auspicious start, however, the colonel's energies in Ensley were diverted first by the illness and death of his wife and then by other investment concerns in the Forence-Sheffield area. In 1891, he died before ever selling a lot or completing another structure in the new town. In 1892, industrial facilities at Ensley were consolidated with Henry DeBardeleben's holdings in the Bessemer area to form the largest single industrial enterprise in the Birmingham district, owned and operated by the Tennessee Coal, Iron and Railroad Company, 2

Throughout most of the 1890s, the town of Ensley remained essentially a pine barren. Several Victorian cottages were built along 17th Street, the original entrance to the mills, and intended to be the heart of the community. During the economic panic of 1893, the Ensley Land Company collapsed financially and went into receivership while TCI suffered through an extended depression in the pig iron market. After many difficulties, receivership and the sale of the entire property at a sheriff's sale for less than \$16,000, the company was finally reorganized in 1898 and the first lots sold. Coal operator and investor Erskine Ramsey and Paschal G. Shook were prominent members of the new Ensley Land Company. During 1898, active industrial development in Ensley increased. Pig iron production picked-up. TCI engineers discovered the open-hearth steel-making method; the Semet-Solvay Company put the nation's second coke by-products plant in operation; Birmingham Cement Company started processing blast furnace slag as cement. The Alabama Steel and Wire Company established a rod, wire, fence and nailworks; and the Ensley Brick Company, producing brick from shale underlying TCI coal beds, was increasing orders. In 1900 and 1904, the

fifth and sixth blast furnaces were blown in. By the end of 1902, the Ensley works started producing rails from open-hearth steel. Production records were established by 1906, with more than 400,000 tons of finished steel produced in Ensley in that year. 3

Before these industries were established, a few small dwellings, scattered among the trees, made up the town of Ensley. The erection of the industrial plants attracted large numbers of workers and created an acute demand for houses, store, and services. As workers flocked to the mills, homes, churches, and places of business began to rise from the vacant land and Ensley's scheme for an industrial town began to take shape. During 1898, TCI constructed 200 houses to accommodate its industrial workers. According to *The Age-Herald* of August 5, 1900, the Ensley Land Company also built 200 "neat and comfortable houses, and these were taken as rapidly as the keys could be turned over by an industrious, wide-awake, and most excellent set of people." Within two years of its formal incorporation on February 12, 1899, the city grew from a small settlement of fewer than 600 into a developed urban area of more than 10,000 people. In 1907, 14,000 men were employed at the Ensley mills. By 1910, the post office estimated Ensley's population at 20,000 to 25,000 people. 4

After receiving its charter from the state in 1900, the City of Ensley elected its first public officials and began providing municipal services. In 1906, with matching funds from Andrew Carnegie, the city constructed a classical style Carnegie Library. By 1908, more than 30 miles of streets and sidewalks had been paved; water, light, and storm and sanitary sewer systems extended; and a city hall, post office, schools, and a public library built, giving Ensley more public improvements than any municipality in the area other than Birmingham itself. The Ensley First Methodist Church (1903), Bush School (1901), Ensley High School (1908), and Minor School (1907), all of which remain today on Pike Road, testify to the vigor and quality of Ensley's early community building.5

In conjunction with these public and semipublic improvements, private investment in Ensley boomed. After U. S. Steel's takeover of TCI in 1907, improvements at blast furnaces and steel and rail mills and construction of additional facilities in adjoining Fairfield, just to the west of Ensley, continued the Ensley boom. The Ensley Land Company owned a large amount of property next to Avenue E between Fairfield and Ensley. Here the company built houses for "skilled workmen and high-class" mechanics. Many, together with privately built residences, remain today along Avenues E to I, between 23rd and 35th Streets. TCI purchased all of the stock of Ensley Land Company in July 5, 1899. In 1929, the Ensley Land Company conveyed all its remaining property to the Tennessee Land Company, a subsidiary of U. S. Steel. Ensley residents took justifiable pride in the accomplishments of their city and vigorously opposed a movement that developed in 1908 to merge with the City of Birmingham. More powerful forces prevailed, however, and on December 31, 1909, Ensley joined its neighbor. Bitter opponents erected a mock grave and tombstone noting the death of the City of Ensley. The stone remained in the yard of J. R. Perkins' real estate office (now the site of First National's branch bank) for two years. 6

Throughout the 1910s, construction at the mills and in the commercial and residential area proceeded at a fast pace. In 1913, additional streetcar service opened to East Lake. The 14.2 mile line that carried throngs of workers to mines and mills opened a new axis of development, and residential communities sprang up along its path. By 1926, the annual production of TCI's Ensley mills included 1.1 million tons of steel ingots (both, according to Ensley boosters, the cheapest in the world), 590,100 tons of "the best steel rail in the world," and 1.9 million tons of coke. Ensley prided itself as a community with a backbone of steel and a regional businesses and shopping center serving Ensley Highlands, Bush Hills, Fairview, Oak Hill, Central Park, Pratt City, Wylam, Fairfield, Belview Heights, and outlying areas. Aggressive promotion and development activities fostered a strong sense of separate identity that endures today. In 1934 the U. S. Department of Commerce estimated Ensley's population at 41,042 persons which included 10,306 families. 7

From its inception, Ensley's urban organization was shaped primarily by the location of the plants and the street railway system. Back in 1887, while Enoch Ensley was surveying streets and lots for the new town, William A. Walker, an Elyton merchant also active in real estate

promotion, was busy too. He was buying rights-of-way for a rail line to connect Birmingham with Thomas and the Pratt Mines as well as the proposed new town of Ensley. The route paralleled the Kansas City, Memphis and Birmingham (later Frisco) Railroad line to Pratt City, turned, crossed Village Creek and followed the Avenue E right-of-way to 19th Street. There it terminated directly in front of the Ensley Land Company office. Shortly after the line was opened in 1887, it was extended from the original terminus down 19th Street and over a private right-of-way to the horse racetrack at Fair Park, now the Alabama State Fairgrounds. Although this roundabout route carried very few of Birmingham's racing fans, it determined the location of Ensley's business district. Shops and offices were established along 19th Street, the stem of the municipality which later led to the plant entrance. Eventually, along 18th and 20th Streets, residential areas flanked either side of the main thoroughfare. The Bank of Ensley, founded in 1899, and important stores concentrated at the busiest corner, the intersection of Avenue E and 19th Street. Commercial development along 19th Street continued through the 1920s and reached its culmination in October 1929 with the construction of the 10-story Ramsay-McCormack Building. For almost 40 years, this was the tallest office building outside downtown Birmingham. 8

Individual citizens also erected homes, some reputed to cost as much as \$10,000; most, however, were more modestly scaled worker housing. Many homes for foremen and superintendents were built along Pike Road in Shadyside and in Ensley Highlands on the ridge overlooking the city. Following U. S. Steel's takeover of TCI in 1907, plans were laid for further development of new production facilities one mile west of Ensley and for increased private development of residential communities. With the growth of the iron industry came the rise of white-collar management and professional class, U. S. Steel hired teachers, supervisors, physicians, lawyers, and accountants. The company recognized the need for suitable housing for their middle- and upper-middle-class employees. The Corey Land Company, a group of socially prominent local businessmen headed by Robert Jemison, Jr., was organized on November 5, 1909, to undertake the private residential development. Jemison was not new to this type of venture, having been engaged in real estate development in the Birmingham district since 1903. Jemison's subdivision of Earle Place, Ensley Highlands, Central Park, and Glenwood and Mountain Terrace (both now sections of Forest Park) were all distinctive and successful real estate ventures. The Jemison Magazine, a publication of Jemison's companies, noted a distinct improvement in the "class of housing" being built in Ensley at this time. Jemison developed homes along Ensley Highlands and later, in the 1910s, a section further south that became known as Belview Heights. Belview Heights was one of Jemison's smallest residential developments, consisting of only 30 square blocks. Belview Heights is located at the southeastern edge of the Ensley's original grid layout. By extending the grid system across the undulating topography of Ensley, Jemison created a neighborhood with rolling streets and avenues, occasional steeply pitched lots, and captivating views. Belview Heights would be one of the last subdivisions that Jemison would create using the grid pattern. In the development of nearby Fairfield and later, Glenwood, Mountain Brook, and Mountain Terrace, Jemison would abandon the grid pattern in favor of more naturalistic and picturesque plans. 9

In 1915, the City of Birmingham erected a Tudor Revival-style fire station at the corner of Avenue Q and 43rd Street on the eastern edge of Belview Heights, which also served the Central Park Highlands neighborhood lying to the east. The erection of a fire station in the Tudor Revival style may have set the architectural tone for Belview Heights. While the homes built in Belview Heights were indicative of what was being built in streetcar subdivisions around the country in the first half of the 20th century, the Tudor Revival style dominates the neighborhood, overshadowing the Bungalow/Craftsman, Minimal Traditional, and Spanish Revival dwellings. The 1920s witnessed the biggest boom in residential construction in Belview Heights with the erection of scores of Tudor Revival dwellings. Indeed, the Belview Heights neighborhood is one of the most saturated areas of this particular style in Birmingham. During the Great Depression, while developments throughout the United States witnessed a dramatic decline in home construction, Belview Heights remained a popular residential neighborhood and home construction remained steady throughout the 1930s up to the advent of World War II. Mortgage records indicated that numerous houses were being built in Belview Heights in the mid-1930s, the depths of the Great Depression. In the late 1940s, the Ensley community recovered its economic vitality and Belview Heights remained a popular residential neighborhood. The Central Park Presbyterian Church, designed by Birmingham architect George Turner, was completed in 1950 and brick veneered ranch houses began

to appear along side the bungalows and Tudor Revival residences. Unfortunately, the 1960s and 1970s brought dramatic changes to the steel industry and the economy of the Birmingham district. In the 1970s, U. S. Steel concentrated new operations at nearby Fairfield and newer, cleaner, more fashionable residential and shopping centers siphoned off many of Ensley's businesses and much of its population. In December 1978, the last of Ensley's open-hearth steel furnaces was shut down and U. S. Steel began making cutbacks at Ensley plants. Despite the drain, many members of the Ensley community have remained loyal and support a series of efforts to diversify industry, improve the area, and restore its vitality and attractiveness. Today, Belview Heights remains an attractive subdivision with rows of well-maintained houses.10
