Agana Spanish Bridge or Sagan I Tolai Acho is the only remaining Spanish bridge in Agana. It was constructed in 1800 during the administration of Governor Manuel Muro. At that time the Agana River had been diverted from its natural mouth and made to flow parallel to the sea for some distance to the south before it reached the sea. Thus the bridge over which passed Padre Aniceto Street was used to reach the landing at the Agana Boat Basin and connected the

districts of San Ignacio and Bilibic.

In July, 1944, the bombardment of Agana damaged the bridge. In addition, when new Agana was laid out after the liberation, the course of the Agana River was diverted to flow directly to the sea thus the bridge was not needed. Eventually, the site became a park and in 1966 the bridge was restored, although not to its original condition.
