STATEMENT OF SIGNIFICANCE

One of the surviving examples of Gothic Revival architecture in South Carolina remaining as originally constructed and containing handmade interior woodwork.

Church organized 1842 by Thomas Parker, Thomas Jackson and Thomas Walter Thomas.

Building consecrated by Bishop Thomas F. Davis in 1860, built after plans by George E. Walker, architect, of Columbia, by Blease and Baxter, contractors, of Newberry. The solid walls are more than two feet thick. Cost including bell and organ, \$15,665.00.

Installed soon after church was built, the organ, is one of two known in South Carolina, made by John Baker of Charleston.

Magnificent stained glass altar window from England ran the Union blockade in 1860s and then was carted to the upcountry.

Major Armistead Burt, vestryman for many years and Congressman from Abbeville (1843-53), at whose home Jefferson Davis held his last Council of War meeting was confirmed in the church in 1861 along with his wife, Martha Calhoun Burt, a niece of John C. Calhoun. The large bishop's chair still in use in the chancel was given by Mrs. Burt.

Col. John A. Calhoun, nephew of John C. and a signer of the Ordinace of Secession was a long-time member of the vestry.

Edward Noble, son of Gov. Patrick Noble, and J. Townes Robertson, Colonel in Orr's regiment were also active in church affairs.

Churchyard and cemetery contain boxwood gardens, towering old magnolia trees and graves of early church leaders.

The building still serves a tiny but active congregation.
