Describe present and historic physical appearance.

The Pospeshil Theatre is located at the northwest corner of Broadway and Grant, at the edge of the business section. Constructed in 1906 by John Pospeshil, the Two-Part Commercial Block structure is described in the Feb. 15, 1906 *Bloomfield Monitor* as having a facade of "pressed brick." The building itself is approximately 114 feet long by 50 feet wide. It has red brick arches over all of the windows and red brick ridges along the top of the building. Otherwise, the building is utilitarian in appearance. The first-floor auditorium is raised about half a story above the street level. Entrance was through double doors at the center front of the building, into what was probably a spacious lobby some 28 feet deep. Unfortunately, this particular space was converted to living quarters at some time after the building no longer functioned as an opera house. Current entrance is through a garage-width door, up a ramp filling what was the stage left wing. Two ticket windows remain at the rear of the auditorium space, although one may have been used to serve refreshments at dances and sporting events.

The auditorium is 47 feet wide by 61 feet long from the proscenium opening to the back of the auditorium. Double doors with a transom above once provided entrance to this space from the lobby. The balcony is some 28 feet deep; it extends behind the auditorium space about 23 feet. The balcony curves inward. away from the stage; this is the reverse of most other Nebraska opera house balconies. Permanent pew-style benches remain in the tiered balcony (see photo #5), which has four large windows on the east end and two on the south. A kneehigh rail with vertical posts set about six inches apart delineates the edge of the balcony. This balcony has "boxes" with permanent bench seats at the front on both the north and south sides (photo #6). It is reached by staircases on either side which come up along the outside of and behind the balcony boxes. Six attractive pillars support the ceiling of the balcony; the top third of these pillars is a large wainscoted triangle (see photo #3). Wainscoting is used extensively throughout the rest of the auditorium as well, including the entire area around the entrance under the balcony; at the tops of supportive arches placed at the edge of the balcony and at the midpoint of the auditorium; below the stage level; and circling the auditorium to a level of approximately three feet. The auditorium has a marvelous pressed tin ceiling in shades of rust and dark green. This ceiling, which along with the walls shows water damage, has a double border of pressed tin in two distinctive styles circling the auditorium (see photo #4). Condition of the floor is difficult to ascertain because of commercial storage.

The proscenium arch measures 24 feet wide by about 16 feet high, with wings of 11 feet, 6 inches. The stage left wing no longer exists; it was replaced by a cement ramp. Current access to the stage area is by a narrow door on the extreme stage right side; it can safely be assumed that another such door once existed on the stage left side. Due to the style of the auditorium and the fact that it is located about half a story above ground level, it can be assumed that dressing rooms once existed under the stage, although this area is no longer accessible. The stage is 22 feet deep from the proscenium opening to the back wall; it is approximately 5 feet above the auditorium floor level. A two-foot apron extends beyond the proscenium arch. Some scenery remnants, apparently elaborate draperies, remains suspended on the stage. The original advertising curtain featured "a street scene in Bloomfield with paintings of five of Bloomfield's big brick buildings," and advertising spaces "went like hotcakes; there didn't seem to be enough to go around" (*Bloomfield Monitor* 23 Aug. 1906).

The structural and historical integrity of the building and theatre, except for the removal of the stage left wing area, has been preserved.


The large rectangular brick two-story building with raised basement, has a center raised entry on the main (east) facade and a flat roof with parapet wall. The building is divided into bays by full-height brick pilasters visually supporting a corbelled wall cornice. Fenestration consists of segmentally arched window openings capped with brick window hoods. The main (east) entry displays double doors, transom, fanlight and round-arched brick window hood visually supported by wall pilasters with corbelled wall cornices. The building has seen few alterations on the exterior. Some windows on the south facade are now boarded up and other lower level openings have glass block infill.

The building originally housed the opera house and various retail businesses, including a restaurant on the lower level (converted to a garage in the 1920s), tailor shop, and professional office space. The building is currently used as a bar and apartment units, and the opera house space is used for commercial storage.

#### State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The Pospeshil Theatre is significant for its association with and in reference to the historic context "Aesthetic Systems: Itinerant and Local Performing Arts in Nebraska" and the property type of "Opera House Buildings in Nebraska, 1867 to 1917." Under Criterion A, this opera house is significant in the areas of the performing arts; entertainment/recreation; and social history, on a state level, as a well preserved example of an opera house building in Nebraska. The building retains a high degree of historical integrity, possessing the physical and associative characteristics to make it an eligible member of its property type.

This opera house is significant in the area of performing arts for bringing a variety of entertainment to the community of Bloomfield. As a facility for the performing arts, it offered productions such as touring stock companies, musical concerts, dialect comedies, grand and comic opera, Shakespeare, minstrel shows, classics like *Uncle Tom's Cabin, Monte Cristo*, or *Lena Rivers*, and home talent shows. (See following table of Representative Entertainments 1906-1917.)

This opera house is significant in the area of entertainment/recreation, since it provided a place where the whole community could gather to attend dances, and edifying or humorous lectures. (See following table of Representative Entertainments 1906-1917.)

This opera house is significant in the area of social history because it gave Bloomfield a neutral, nonaffiliated location for school entertainments, basketball and other athletic events, and church socials and bazaars. (See following table of Representative Entertainments 1906-1917.) In the days before radio, television, and sound movies, activities at the opera house were anticipated for days or weeks ahead of time. It provided a place for people to get together to have a good time and forget their troubles over crops, weather, taxes, the railroads, and the generally hard life of settling the Great Plains.

The period of significance is derived from the original construction date of the building, 1906, when it replaced the earlier Bloomfield Opera House. The press celebrated it as "one that would be a credit to any city of 25,000 inhabitants and is a magnificent monument to the enterprise and faith of one of our foremost citizens" (*Bloomfield Monitor* 6 Sep. 1906). The period of significance continued through 1917, the year considered to signal the end of the opera house era in Nebraska, based on declining numbers of touring companies nationally and rising numbers of movie houses and automobiles. The Orpheum (Movie) Theatre and the Star (Movie) Theatre took most of the business away from the Pospeshil Theatre, leaving only sporadic events dwindling in quantity from year to year.
























Describe present and historic physical appearance.

The Pospeshil Theatre is located at the northwest corner of Broadway and Grant, at the edge of the business section. Constructed in 1906 by John Pospeshil, the Two-Part Commercial Block structure is described in the Feb. 15, 1906 *Bloomfield Monitor* as having a facade of "pressed brick." The building itself is approximately 114 feet long by 50 feet wide. It has red brick arches over all of the windows and red brick ridges along the top of the building. Otherwise, the building is utilitarian in appearance. The first-floor auditorium is raised about half a story above the street level. Entrance was through double doors at the center front of the building, into what was probably a spacious lobby some 28 feet deep. Unfortunately, this particular space was converted to living quarters at some time after the building no longer finationed as an opera house. Current entrance is through a garage-width door, up a ramp filling what was the stage left wing. Two ticket windows remain at the rear of the auditorium space, although one may have been used to serve refreshments at damage and sporting events.

The auditorium is 47 feet wide by 61 feet long from the proscenium opening to the back of the auditorium. Double doors with a transom above once provided entrance to this space from the lobby. The balcony is some 28 feet deep; it extends behind the auditorium space about 23 feet. The balcony curves inward. away from the stage; this is the reverse of most other Nebraska opera house balconies. Permanent pew-style benches remain in the tiered balcony (see photo #5), which has four large windows on the east end and two on the south. A kneenigh rail with vertical posts set about six inches apart delineates the edge of the balcony. This balcony has "boxes" with permanent bench seats at the front on both the north and south sides (photo #6). It is reached by staircases on either side which come up along the outside of and behind the balcony boxes. Six attractive pillars support the ceiling of the balcony; the top third of these pillars is a large wainscoted triangle (see photo #3). Wainscoting is used extensively throughout the rest of the auditorium as well, including the entire area around the entrance under the balcony; at the tops of supportive arches placed at the edge of the balcony and at the midpoint of the auditorium; below the stage level; and circling the auditorium to a level of approximately three feet. The auditorium has a marvelous pressed tin ceiling in shades of rust and dark green. This ceiling, which along with the walls shows water damage, has a double border of pressed tin in two distinctive styles circling the auditorium (see photo #4). Condition of the floor is difficult to ascertain because of commercial storage.


The proscenium arch measures 24 feet wide by about 16 feet high, with wings of 11 feet, 6 inches. The stage left wing no longer exists; it was replaced by a cement ramp. Current access to the stage area is by a narrow door on the extreme stage right side; it can safely be assumed that another such door once existed on the stage left side. Due to the style of the auditorium and the fact that it is located about half a story above ground level, it can be assumed that dressing rooms once existed under the stage, although this area is no longer accessible. The stage is 22 feet deep from the proscenium opening to the back wall; it is approximately 5 feet above the auditorium floor level. A two-foot apron extends beyond the proscenium arch. Some scenery remnants, apparently elaborate draperies, remains suspended on the stage. The original advertising curtain featured "a street scene in Bloomfield with paintings of five of Bloomfield's big brick buildings," and advertising spaces "went like hotcakes; there didn't seem to be enough to go around" (*Bloomfield Monitor* 23 Aug. 1906).

The structural and historical Ategrity of the building and theatre, except for the removal of the stage left will area, has been preserved.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The Pospeshil Theatre is significant for its association with and in reference to the historic context "Aesthetic Systems: Itinerant and Local Performing Arts in Nebraska" and the property type of "Opera House Buildings in Nebraska, 1867 to 1917." Under Criterion A, this opera house is significant in the areas of the performing arts; entertainment/recreation; and social history, on a state level, as a well preserved example of an opera house building in Nebraska. The building retains a high degree of historical integrity, possessing the physical and associative characteristics to make it an etigible member of its property type.

This opera house is significant in the area of performing arts for bringing a variety of entertainment to the community of Bloomfield. As a facility for the performing arts, it offered productions such as touring stock companies, musical concerts, dialect comedies, grand and comic opera, Shakespeare, minstrel shows, classics like Uncle Tom's Cabin, Monte Cristo, or Lena Rivers, and home talent shows. (See following table of Representative Entertainments 1906-1917.)

This opera house is significant in the area of entertainment/recreation, since it provided a place where the whole community could gather to attend dances, and edifying or humorous lectures. (See following table of Representative Entertainments 1906-1917.)

This opera house is significant in the area of social history because it gave Bloomfield a neutral, nonaffiliated location for school entertainments, basketball and other athletic events, and church socials and bazaars. (See following table of Representative Entertainments 1906-1917.) In the days before radio, television, and sound movies, activities at the opera house were anticipated for days or weeks ahead of time. It provided a place for people to get together to have a good time and forget their troubles over crops, weather, taxes, the railroads, and the generally hard life of settling the Great Plains.

The period of significance is derived from the original construction date of the building, 1906, when it replaced the earlier Bloomfield Opera House. The press celebrated it as "one that would be a credit to any city of 25,000 inhabitants and is a magnificent monument to the enterprise and faith of one of our foremost citizens" (*Bloomfield Monitor* 6 Sep. 1906). The period of significance continued through 1917, the year considered to signal the end of the opera house era in Nebraska, based on declining numbers of touring companies nationally and rising numbers of movie houses and automobiles. The Orpheum (Movie) Theatre and the Star (Movie) Theatre took most of the business away from the Pospeshil Theatre, leaving only sporadic events dwindling in quantity from year to year.
