Description New Hope A.R.P. Church is a one-story, weatherboarded, frame church with apsidal plan and a narthex pavilion. A bracketed belfry with bellcast roof, gablets, and finial surmounts the front-gabled roof. The gable end features a boxed cornice with returns and a blind oculus. Facade (west elevation) fenestration with shelf architraves has a double-leaf door surmounted by a ten-light transom flanked by single, large-paned, four-over-four, shuttered windows. Side elevations have windows identical to those of the facade. Interior walls are plastered above narrow-beaded-board wainscot. Rear balcony displays a turned balustrade. Altar furnishings are original as is the chandelier, now electrical. Alterations include a 1970 left wing and the front steps. The Session House, which sits to the left of the church, was also constructed ca. 1886. This is a 10 by 12 foot weatherboarded frame building with gabled roof. The gable end has a boxed cornice\*

Significance New Hope A.R.P. Church and Session House were constructed ca. 1886.<sup>1</sup> Despite the small-scale addition, this church, with its highly decorative belfry and its intact session house, is an interesting example of local interpretation of high-style elements of late-nineteenth-century religious architecture.
