

Describe the present and original (if known) physical appearance

Woodlands is located on a gentle rise in a large bend of the Alabama River. It faces southeast onto an unimproved road .4 of a mile north of U. S. 82. It is a 1½ story, braced frame house with the gabled roof, recessed porch and five bay facade typical of the Creole cottage. It measures 62' x 56' and rests on a foundation of brick piers which are extended as a solid wall across the front of the house. There they have been stuccoed, scored and painted grey. The rear shed roof porch has flanking end rooms (which appear to be original) and has been partially enclosed. The roof is modern shingle material and the four in-wall chimneys appear to have been rebuilt above the roofline. The end walls of the house have been covered with asbestoes shingles.

Greek Revival influences are most apparent in the frontispiece and in the 8 fluted, cypress columns which support the heavy entablature with a defined frieze, architrave and cornice. The facade is faced with flush siding, the windows are 6/6 with large panes, floor lenght shutters, and paneled jib-doors beneath. The narrow balustrade with simple square balusters is original but the front steps were replaced with concrete block around 1925. The most notable feature of the house - the vaulted ceiling of the porch and its oval window-is not visible from the walk.

Interior: The plan (see attachments) has had only minor alterations. In the 1930's the north corner room (one of the flanking rooms of the rear porch) was extended several feet to allow additional space for a kitchen and the matching rear room was converted to a bath. Around the same time the porch was enclosed with glass. Walls are the original plaster, floors are of varying width heart pine, ceilings are original and most of the hardware is intact (silverplate downstairs, brass upstairs). Interior trim is severe and of the Greek Revival period with two long vertical panels in the doors, simply designed mantels, and moulded architrave trim for windows and doors. Windows of the main rooms have jib-doors or stationary panels. The plaster cornice is heavily proptrtioned but restrained. Attic closets of the upper floor are probably original. The house is in excellent structural condition and is extremely well-maintained by the present owners.

Statement of Significance (in one paragraph)

Constructed as the seat of a 2,000 acre plantation, Woodlands is one of the finest of the few remaining antebellum homes in predominantly rural Clarke County. Based on the story-and-a-half Creole cottage, it is enriched with Greek Revival details and is a surprisingly sophisticated example of the type, equalled only by a few Mobile houses. Fluted Greek Doric columns, paneled jib-doors beneath the facade windows, a deep and well-proportioned entablature, silver-plated hardware and an entrance treatment probably based on a plate from Asher Benjamin's The Practical House Carpenter are evident refinements. The most noted feature, however, is a small elliptical vault in the porch ceiling which allows space for an oval bullseye window above the entrance. This sophisticated design is unique in Alabama.

The house was built for Frederick S. Blount (1806–1885) and his first wife, Emily James, daughter of a wealthy Clarke County landowner. Blount was a native of Newbern, North Carolina and was educated at the Newbern Academy and the state university. He was admitted to the bar in that state in 1829 and, like many of his contemporaries, migrated to the old southwest. In 1831, he established a law office in the bustling port city of Mobile. He married Emily James in 1835 and four years later began acquiring large tracts of land in Clarke County where he moved, probably in late 1839 or early 1840. There he operated a large plantation and apparently served the county in some official capacity. Sir Charles Lyell, on his second visit to the United States (1846), visited briefly at Woodlands and noted it in his journal. In 1851, Blount sold the house to Sara Thomas and returned to Mobile where he is chiefly remembered for a daughter who married a French baron, Henri Arnous de Riviere . The house remained in the family of Sara Thomas until it was purchased by George E. Wilson in the early 1920's. It is still owned by descendants of this family.




