

Description The Beriah Magoffin Monument in Harrodsburg is a cast zinc monument approximately ten feet tall that consists of two parts, a base and a bust. The base is two stepped with the very bottom part cast to resemble rough cut stone. The second tier has the name "Magoffin" in raised letters on it. The whole of the pedestal portion of the base is cast to resemble rough cut stone, save areas that where plaques are placed. These are roughly in the center of the body of the pedestal. Each side of the monument has a plaque, and all of them are inscribed. The east side (front) reads: "Our War Governor Beriah Magoffin born April 15, 1815 Died February 28, 1885;" the south side reads: " What attitude shall Kentucky occupy in the deplorable conflict looking to the constitution of the United States, the nature of our institutions and the causes of the war, I think Kentucky has a right to assume a neutral position;" the west side (rear) reads: " While opposed to the policy of the government and the measures used to preserve the constitution, we would not exchange the government of our fathers for any experiment on earth. We differ only as to the best means to preserve the Union;" the north side reads: "Ann Shelby wife of Beriah Magoffin born August 15, 1818 died May 7, 1880. 'My children are my jewels'." Above the base of the monument is a bust of Beriah Magoffin. The bust is a classical design draped in a toga and the hair and beard styled after works of antiquity.

Statement of Significance The Beriah Magoffin Monument in Harrodsburg meets National Register criterion A and is significant within the context of "Civil War Monuments in Kentucky, 1861-1935." The monument was erected ca. 1900. It is a transitional monument. Though it was placed in a cemetery, it does not evoke mourning or sadness. This monument is a tribute to Magoffin and his stand in the early days of the Civil War. When President Abraham Lincoln called for troops to crush the rebellion, Magoffin refused and declared Kentucky neutral. The inscriptions on the monument justify Magoffin's actions. The monument, which is made of zinc, was probably erected 15 to 20 years after his death at a time when justifying/celebrating the "Lost Cause" and Kentucky's role in the Civil War was part of the monument building process. Also the other zinc monuments erected in the state date from 1902 to 1907, which falls within the time period of celebration rather than mourning. The monument is an excellent example of the property type "statue."

Verbal Boundary Description - The Confederate Monument whose boundaries form a circle with a radius of ten feet centered on the monument located in Springhill Cemetery in Harrodsburg, Kentucky.

Verbal Boundary Justification - The area associated with the monument is restricted to the ground on which the monument sits and a small buffer around it. The setting outside such a restricted area is not seen as critically important to maintaining an integrity of association. Because the focus of the multiple property submissions is the significance of the monuments, their proposed area of listing will reflect that they have been considered by-and-large, in isolation from their surrounds.
