Describe present and historic physical appearance.

The Mathers, William, House is located on the northwestern boundary of Carlisle, on State Route 36. The house began circa 1812 as two rooms of brick construction, executed in the Flemish bond pattern. The bricks were fired in the yard from local clay brought from Pleasant Valley, a small town approximately 10 miles north of Carlisle. The house is part of a large farm that once served as a picnic ground for the locals at the turn-of-the-century. A decorative stone wall encloses a large yard for the house, and separates it from the fields. A fork of the Brushy Fork Creek meanders through the middle of the farm, visible from the front porch. Several barns and outbuildings are associated with the site, but are not included as part of the nomination. Several head of cattle are still raised on the farm. The house is the sole building included in the nomination.

The house is composed of two distinct sections, built approximately 40 years apart. The house faces east toward Brushy Fork Creek. The first section of the house is a one and one-half story brick construction of flemish bond. The side-gabled roof is decorated with beaded, tapering vergboaards. The four-bay, two room section has two exterior end chimneys. The main facade is composed of two central wood doors with glass transoms. The doors are flanked by double-hung sash windows. A one-story brick shed-roofed addition has been added to the rear of this section, circa 1960.

The second section of the house was built circa 1858. The two-story Greek Revival section repeats the flemish bond masonry pattern of the original house. The "L-shaped" center-passage plan section is composed of three bays. The central door is sidelighted. Double-hung sash windows with wood lintels and sills flank the entrance on the first-story. The second story is composed of three evenly spaced double-hung windows. A Colonial Revival porch was added over the entrance, circa 1920.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The William Mathers House is eligible for National Register under Criterion A, for its association with local religious history, and C, because it is the best local example of a nationally important architectural style. The Mathers house was built in two main sections, approximately 40 years apart. The Federal style main block was built circa 1812 by William Mathers. A major two-story Greek Revival addition was made to the house by his son, Barton W. Mathers, circa 1848. William Mathers figured prominently in the Christian Revival Movement of the early nineteenth century, as did several of his children, including Barton. Local sources say that Barton Stone, an influential agent in the movement, conducted gospel meetings on the Mather's farm circa 1821. These meetings mark the beginning of the Christian Revival Movement in Nicholas County.

William Mathers was a recognized leader in the Revivalist Movement, the religious movement begun in northeastern American in 1791. The movement had reached Nicholas County by 1803. The Revivalists were part of the Second Great Awakening period in American Prostestant religions. Revival meetings led by itinerant preachers were widespread during the period. Emotional preaching and mass conversions were commonplace at church services. The Mathers farm served as the site of camp meetings for Nicholas County Revivalists.1

On his death, William Mathers was eulogized as being ..."among the number of those who went into the organization of the original Christian congregation established at old Concord (the first organized church in Nicholas County) upon the Bible alone, after Barton W. Stones's withdrawal from the Synod of Kentucky in September 1803, and now that he is gone the last link that connected this church with the original organization in 1803 is gone."2

The south facade of the house is three bays deep. An entrance with a circa 1890-1900 porch occupies the furthest bay west. Double-hung sash windows occupy the other first and second story bays.

The 1960 addition follows the ell of the plan, and simply made the house one room deeper. A one story aluminum porch overhang rests in the ell. These additions to the rear of the house have not altered its appearance from the front.

Project budget and deadlines precluded interior investigation of the house.

The two-section Mather's House is the only brick example of Federal and Greek Revival styles in Carlisle. The original section of the house is today thought to be the earliest remaining example of Federal style architecture in town. Several Federal-style frame houses are present in Carlisle, but none exhibit the detail of the Mather's House. The Mather's House also retains its original integrity, where the other buildings have been altered.

Greek Revival was the dominant American architectural style during the period from 1830 to 1860, but the Mathers House is one of only two residences in Carlisle designed in the Greek Revival style.3 The Mathers House was built mid-way through the peak period for Greek Revival, in 1848, and the two-story, frame, Anderson Cornwall House was built circa 1855 at 361 West Main Street. Both houses exhibit an abundance of detail and ornament, and both are located on the outskirts of the original town. The houses are also associated with prominent figures in the community. It is unclear why so few Greek Revival buildings exist in Carlisle.

The William Mathers's House has remained in the Mathers's family for six generations. William Mathers (1785-1858) and his wife Margaret Ardery Mathers raised a family in the house and lived there for the remainder of their lives.

Barton W. Mathers (1809-1889) is presumably named after Barton Stone, the catalyst of the Revivalist Movement in Nicholas County, and a friend of his fathers. Barton Mathers took possession of the house in 1858, on the death of his father. He and second wife, Emily Todd Mathers, added the two-story brick Greek Revival section to the house circa 1858.

Silas W Mathers (1845-1925) was the son of Barton and Emily Mathers. Silas and his wife Virginia Boone Rice Mathers took over the house on the death of his parents. Taylor B. Mathers (1876-1943) was the fourth owner of the house. Taylor was married to Bertie Dallas Mathers. Taylor Mathers and William Dinsmore founded Dinsmore and Mathers Furniture and Undertaking circa 1900. Current owner of the house is Taylor T. Mathers, son of Marion Taylor Mathers (1903-1965).


