SUMMARY

The National Guard Armory in Pine Bluff, Jefferson County, is a buff brick and concrete structure built in 1931. The Art Deco style building is located at 623 West Second Avenue and consists of a two-story head house with a large single story drill hall attached to the rear of the building. The T-shaped building sits atop a continuous concrete foundation and is crowned with a castellated parapet. Symmetrically placed windows along with the centrally located pilaster and central entryway give the building a balanced appearance.

ELABORATION

The National Guard Armory in Pine Bluff, Arkansas, is a buff brick and concrete structure built in 1931. The Art Deco style armory is located at 623 West Second Avenue and consists of a two-story head house with a large single story drill hall that projects from the rear of the head house. The T-shape building sits atop a continuous concrete foundation with distinct vertical lines that rise up from the foundation in the form of pilasters. A castellated parapet located above the centrally located front entryway crowns the building. The head house forms the cross arm of the T. One brick chimney, abutting the rear of the building to the north, rises from the eastern slope of the drill hall's gambrel roof. Composition shingles cover the gable roof of the drill hall, while a built-up tar roof covers the flat roof of the head house that is hidden behind a brick and concrete parapet.

South Elevation

The façade of the armory fronts south toward Second Avenue. The first floor façade is fenestrated by eight six-over-six windows that are placed symmetrically in four groups of two on the façade. A projecting entryway is located centrally on the façade and it allows access to the building through a glass doorway that replaced the original door at an unknown date. The entryway dominates the face of the building. It is composed of two large pilasters that project out from the building with the entryway receding back four rows of brick from the building's face to the door. The second story is identical to the first story to both the east and west sides of the entryway. Directly above the first floor entryway is a pair of four-over-four windows. Near the top of the building above the entryway a concrete inset reads "National Gvard Armory" [sic.]. The top of the building has a small parapet that spans the length of the facade with a castellated parapet that crowns the building's central projection.

East Elevation

The east elevation consists of ten bays. The four southern bays are part of the head house. Each bay is fenestrated with both a first and second story six-over-six window. The six bays to the north side of the elevation make up the east wall of the single story drill hall and are each separated by a pilaster. The first bay is comprised of a triple-hung six-over-nine-over-nine window and a doorway that was created by removing a

window. The next four bays are each fenestrated with a pair of triple- hung six-over-nine-over-nine windows. The northernmost bay originally had matching windows also, but has had one removed to create a doorway.

North Elevation

The rear elevation faces north with no ornamentation. It is sheathed in red brick and is fenestrated with four evenly spaced six-over-nine-over-nine, triple-hung windows.

West Elevation

The west elevation is identical to the east in form. The only difference between the two elevations is that the four southernmost bays of the drill hall on the west elevation of the building still have all original windows. The north bay contains a large, overhead, rolling, garage door. Although the entry is original the door is not.

Interior

The interior of the armory is of the simplicity and functionality typical of such structures. The auditorium is floored with wood strip flooring and the ceiling is covered with an open, metal truss. The head house and a small room in the northeast corner of the building have been converted to classrooms for the Jefferson Area Vocational Center that currently holds classes in the building. The drill hall remains unchanged for the most part, but now serves as a welding and metal shop class for the school.

Integrity

There have been some small alterations to the National Guard Armory. The front door has been replaced as well as two windows that were removed to create door on the east elevation. There are also two windows on the east elevation that have had the top section of their triple hung window replaced with sheets of metal. These alterations were needed to increase the building's functionality as a learning center. The alterations that have occurred do not detract from the splendor of this building. The building holds integrity of feeling, association, setting, location, materials, design, and workmanship.

SUMMARY

The National Guard Armory, a 1931 military building at 623 West 2nd Street in Pine Bluff, Arkansas, is being nominated to the National Register of Historic Places with local significance under Criterion C for its Art Deco architecture and because it is the largest extant example of Art Deco architecture in downtown Pine Bluff. The building is the first State-owned building to be constructed in Jefferson County, Arkansas, for the sole use and benefit of the Militia.

ELABORATION

Pine Bluff was established on a high bluff above the Arkansas River. The bluff chosen was the first location of any pine trees above the mouth of the river. The bluff furnished a safe haven for the settlers who encountered annual flooding along the river. Joseph Bonne, a half French and half Quapaw (Arkansas) Indian, is said to have settled on the "pine bluff" in 1819. After the Quapaw signed a treaty in 1824, relinquishing their title to all of the lands they claimed in Arkansas, other settlers began to join Bonne on the bluff. At an August 13, 1832, election, Pine Bluff was chosen as the County seat and John Pullen donated two acres of land for county purposes. The Quorum Court accepted the donation on October 16, 1832, and voted to name the village "Pine Bluff Town".

As was the case with a relatively small number of Arkansas counties in the nineteenth and twentieth centuries, Jefferson County could boast of several State recognized militia units subject to call for service in an emergency. Such organizations drilled regularly and were occasionally called into state, federal, or Confederate service. On July 31, 1920, Jefferson County's remaining unit was reorganized and federally recognized as a company of infantry at Pine Bluff. Today Jefferson County's National Guard Unit is classified as Company C, 212th Signal Battalion.

It was not until 1931 that the unit obtained a facility of its own. In 1931 the Arkansas General Assembly provided appropriations from the Military Fund for the building's construction. John J. and Mary Holland Craig donated land for the new armory building. Durward F. Kyle served as architect and Quinn & Quinn as contractor. The Art Deco style armory was completed that same year and totaled 9,262 square feet. It is not surprising that the armory was designed in the Art Deco style since that style was very popular in the United States from 1918 throughout the mid-30s; however, the movement was largely abandoned due to economic hardships caused by the Great Depression. The National Guard Armory in Pine Bluff, was built the same year as more notable Art Deco buildings such as the Empire State Building and the McGraw-Hill Building, both in New York City. The signature vertical lines that rise from a building's foundation to roofline largely defines Art Deco architecture. The projecting entryway, buttresses, and tall narrow symmetrically placed groups of windows all add to the armory's vertically designed appearance. Although the armory is not as

grand as the Empire State Building, it is a unique building in its area and is the largest extant, Art Deco building in downtown Pine Bluff.

In the early stages of WWII the building served as temporary administrative office for the United States Army Arsenal that was being built on the outskirts of Pine Bluff. The armory was home to units that saw action in both WWII and Korea. In 1957 the unit was mobilized for the integration crisis at Little Rock Central High School. The unit as a whole spent 32 days at Central High. One officer and nineteen enlisted remained on active duty for the remainder of the school year.

The building served as an armory for Jefferson County's National Guard units until January 14, 1974, when the building was sold for \$25,101 to Ten-Ark Inc. Today the Arkansas River Education Services Cooperative owns the building. The armory now serves as welding and metal shop classrooms for the Jefferson Area Vocational Center allowing the building to still serve the community.

Significance

The National Guard Armory in Pine Bluff, Arkansas is being nominated to the National Register of Historic Places with **local significance** under **Criterion C** for its Art Deco architecture as the largest extant, Art Deco building in downtown Pine Bluff.


