

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The James Sparks House is a <sup>1/2</sup>two-storey brick Victorian Romanesque style residence having a rusticated stone base with a round, three-storey, corner tower and a veranda which sweeps around the base of this tower. The original steeple roof is missing from the tower and the ornate porch posts and decorative trim are also missing. However, the main entry, as well as an entrance to the balcony above, is flanked by two small columns with composite capitals supporting a rusticated stone semicircular arch. An unusual three-quarter circular keyhole-shaped front window contains a single-light, double-hung sash window surrounded by stained glass panels with an unusual semicircular iron flower box at the base of this window. A semicircular fan-shaped window in the original library is glazed entirely with stained glass. Other windows in the house have rusticated stone sills with segmental arched brick heads supported by corbelled brick and stone shoulders with stone keystones. The attic gable windows have semicircular arched head windows with rusticated stone sills and stone keystones. The chimneys are decorated with corbelled brick as well as corbelled brick corners on the main house plus brick corbelling topping the round tower just under the cornice.

The interior is original except for floor and wall coverings. Each of the four main rooms have their original handcarved oak fireplaces with one inch bevelled mirrors and Italian marble trimmed hearth. Two of these fireplaces have the original brass fire shields of ornate design built into them.

The four main rooms still have their original, solid brass, combination gas and electric chandeliers. Two of these have ornate scroll designs with four gas jets and four electric light arms with hand-etched satin glass shades on all. A third chandelier which is in the original dining room has a Tiffany glass shade comprised of four multicolored panels of antique German stained glass together with four gas jets. The fourth chandelier has a large globe of vaseline opalescent glass with a swirl design, topped with solid

7. Description

brass panels of lace design including a brass floral drape which falls from the center of the lamp around the globe itself.

The main rooms downstairs may be opened up by sliding nine-foot, oak-panel doors into the walls. The openings are decorated with bent wood and handcarved wood lattice. All of the interior doors are panelled and all woodwork has an oval cut and bead design. The original floors are an inch and one-quarter oak, not tongue and groove, but surface nailed. The ornate design, original front doors are of oak and feature handcarved panels on both the exterior and the interior of the doors, including heavy plate glass windows with one and one-quarter inch bevelled edging. The transom is of stained glass.

Alterations from the original design include major modification in the kitchen area necessary for its present adaptive use as a restaurant, and on the exterior a composition shingle roof has replaced the original roof covering.

The James Sparks House is one of the finest historical restorations in Arkansas, lacking only a restoration of the tower steeple and the ornamental porch posts and porch trim.

STATEMENT OF SIGNIFICANCE


James M. Sparks, the builder of the house, was the son of Mitchell Sparks, a native of Ireland. Mitchell Sparks was educated at Trinity College, Dublin, and was graduated with a degree in medicine, although he never was to be a practicing physician.

In 1843 Mr. Sparks came to the United States and Arkansas. In 1847 he married Hannah Bennett of Massachusetts who had come to the frontier to visit her uncle. After their marriage, Mitchell and Hannah Sparks settled in Fort Smith, then a bustling border city and a debarkation point for westward immigration. He engaged in business up and down the Arkansas River and was a prosperous merchant. He died in 1864.

James M. Sparks and his brothers continued in the family tradition. James became a successful druggist and a director of one of the largest banks in Fort Smith. David Sparks, a brother, was a prominent wholesale merchant; and another brother, George, held a prominent position in local financial circles. It is for George's wife, Annie Sparks, that the Sparks Regional Medical Center is named.

The James Sparks House is an unusually good example of a moderate sized Victorian Romanesque style residence. The combination of red brick and rusticated stone as building materials is typical of the style, however, the detailing of these materials particularly for window and door openings is unusual and rather ornate for a house.

8. Significance

no larger nor more pretentious than this particular house is. Extensive use of brick corbelling for decoration around window openings and other points around the cornice of the tower and particularly the chimney caps is unusually appropriate to the overall design of the house.

The fact that the interiors are almost totally original is important. The original natural finished old woodwork has never been painted. The fireplace mantels and bevelled mirrors have not been mutilated and most importantly, the original solid brass combination gas and electric chandeliers have been restored and preserved.

The James Sparks House was an outstanding residence of its day. As the result of a careful restoration and preservation the house is now one of the best surviving examples of the Victorian era of architecture in the City of Fort Smith, Arkansas.


