Describe the present and original (if known) physical appearance

Anderson Place is a small turn-of-the-century residential area situated along a very quiet, tree-lined avenue (15th Ave.) and portions of four equally peaceful intersecting streets (15th, 16th, 17th and 18th Sts.). The district is located on Birmingham's south side at the base of Red Mountain. The streets are laid out on a modified grid-iron pattern. Those streets in the northwestern corner of the neighborhood are situated on relatively flat terrain, but the remainder of the area is sloping due to the close proximity of the mountain directly to the south.

The district is made up of 95 structures, 86 of which are contributing. The buildings within the district boundaries are all either single family homes or multiple unit apartments. The individual houses are primarily two-story, although there are a few, one-story, Bungalow-type residences. The homes along 15th Avenue tend to be built on large lots set well back from the street on well landscaped lawns. The houses on the intersecting side streets tend to be more densely spaced and are situated closer to the street. Scattered throughout the district are a few modern two-story apartment and condominium complexes.

Architectural style is predominantly vernacular heavily influenced by Queen Anne, Arts and Crafts and Tudor elements. A few buildings, however, are clearly high style Tudor, Arts and Crafts and Bungalow representations (inventory #'s 33, 41 & 4). A few of the houses are brick, but most are wood frame with cut stone or, more commonly, stone rubble porch supports and chimneys. The Arts and Crafts styled homes feature exposed timber porch decoration and the Queen Anne styles exhibit wood shingles.

8. Significance



Statement of Significance (in one paragraph)

Criterion C, Community Planning

Anderson Place Historic District is significant as one of Birmingham's first streetcar suburbs. Conceived and initiated by one of the city's leading building developers, J. Cary Thompson, between 1905 and 1912, it originally encompassed a three-block area (along 15th Ave. S. between 16th and 17th Streets S.) with distinctive, large, well landscaped lots with houses placed far back from the street. A later expansion (1913-1925) primarily developed by building contractors, Dearborn and Evans, has more closely spaced houses on smaller lots.

The district gains further significance as a representative of a common development pattern in the city. It is one of a number of similar small Birmingham subdivisions which once formed a patchwork pattern development rather than a single comprehensive residential plan on the city's southside.

Criterion C, Architecture

Anderson Place is significant for its fine collection of early 20th century houses. A few of the homes were designed by prominent Birmingham architects, D. O. Whilldin and S. Scott Joy. These structures exhibit Tudor Revival and Arts and Crafts architectural styles. The majority of the houses, however, are very good examples of popular, turn-of-the century, building contractor, pattern book styles of the period. Most are large two-story vernacular homes influenced by Queen Anne, Tudor Revival, Arts and Crafts and Colonial Revival styles. A small percentage of the contractor houses are early Bungalow variations.

Historical Summary:

Anderson Place is an essentially intact district of residential properties dating from about 1907 to 1912 and representing good examples of the Craftsman and bungalow styles prevalent during those years of home-building. Though named "Anderson" after the original owner of the land, the area was the development of the Jefferson Land Development Company, organized in 1905 by local developer J. Cary Thompson, his father N. F. Thompson, and Richard Randolph. J. Cary Thompson was the guiding influence behind the building of Anderson Place, and it is to his unified plan that is attributed its present cohesiveness, despite incursions in recent decades by apartments and their attendant parking lots.

The core of Anderson Place, as originally surveyed in 1905, runs along 15th Avenue South between 15th and 17th Streets; the area was expanded in 1912, and records indicate that J. Cary Thompson built most of the homes from 15th to 18th Streets along 15th Avenue South and along the 1600 block of 14th Avenue South, as well as on 16th and 17th Streets crossing 15th Avenue a block in either direction. Because of the visual continuity of contiguous Craftsman and bungalow residences along 18th Street South, the present historic district has been expanded beyond the original boundaries of Anderson Place to include 18th Street.

Situated along the valley floor and up the north slope of Red Mountain, Anderson Place was practically in the country when it was begun. It was accessible by street car after 1907, however, which was surely an important element in Thompson's far-sighted decision to develop this district. Like Edward N. Cullom a few years before, Thompson offered attractive terms to his prospective home-buyers, offering houses for cash (\$2,000 to \$5,000) or assumable mortgages. A 1908 advertisement in the Manufacturer's Record tells us that at least ten of the houses were designed by prominent local architect D. O. Whilldin.

Both J. Cary Thompson and his father N. F. Thompson purchased and lived in houses along the 1600 block of 15th Avenue in what is the most distinctive part of the district; here the houses were set far back from the street as the lots sloped up Red Mountain, their settings thereby adding to their architectural quality. Anderson Place was advertised in its day as a place "where Nature was lavish in her endowment, and the art of man has produced some of the finest homes in the South." Despite incursions and neglect over the years, that rather extravagant description still has validity; the area's charm and cohesiveness have not been eroded.
