Trinity Episcopal Church is a one-story wooden structure built on ground level. Short flight of steps leads to porch which extends full width of building. Porch has slender, square posts which support a triangular pediment. Vertical planks of pediment, pointed at base, form zig-zag design. Triangular louver at center of pediment is both decorative and functional.

Inset steeple, covered with white shingles, has decorative louvers. Double, three-panel entrance of facade is surmounted by elaborate, semi-circular fanlight. Windows, flanking entrance, have smaller, semi-circular fanlights above and shutters. Side walls have four windows identical to those at front. Building's only chimney, located between pairs of windows on north side, protrudes above eaves to the extent that its top is almost even with peak of roof.

STATEMENT OF SIGNIFICANCE

Edisto is one of South Carolina's earlier-settled sea islands, the Earl of Shaftesbury (Lord Ashley Cooper) acquiring plantation lands there in 1674 (when it was called Locke Island for John Locke) and South Carolina's Colonial Governor Joseph Morton building a home there in the 1680's. A number of residences and several historic churches remain from the island's flourishing plantation period, the late 18th and first half of the 19th centuries, when wealth from long staple sea island cotton produced elegant homes for an educated cultured society. Already on the National Register, as a National Historic Landmark, is Edisto's Brick House.

This present Episcopal Church was built in 1876 as a replacement for an older structure which was burned accidentally. It is the only Episcopal Church and the only example of Victorian church architecture on Edisto Island.

This building with its white boards and shingles contrasted with its dark green roof, shutters and louvers fits in well with its parklike surroundings. The balancing of shingles in the steeple with the verticals in the gables and horizontal lines of the lower facade enhance appearance. The highly decorated character of the area above the eaves is more than offset by the area below, which is that of an essentially rural church as is borne out by the fan-lighted clear glass windows and fanlighted double entrance door.
