

Physical Description

The McDonald House, built c. 1875, is an example of a vernacular stone farm residence from the latter part of the stone building era in Madison County. It is one of several extant asymmetrical massed rectangle houses with a raised basement, and it is one of two with a centered, gable front entrance. The water table on its north gable end, which is the public facade, is the house's most notable feature; the ashlar stones have margin lines surrounding a textured finish produced by a small, round-ended tool. The plan of the house and its masonry bonding suggest that it was probably built by stone mason David Harris, and that it was probably one of the later houses he erected.

The 1 1/2 story, 3 x 1 bay, gable front house measures 23 x 23 feet, and is constructed of locally quarried limestone. The north gable front has a center bay door flanked by two windows, with another window in the gable over the door. The east and west walls each hold a single window toward the rear of the house. A "walkout" entry to the basement extends from the east wall near the south corner of the house. The south gable end has a right bay entry with a window to the left, and a window in the gable. All windows are 1/1 light replacement sash, except the two basement windows on the south gable end which are fixed 4/4 light. The gable roof is covered with asphalt shingles. A brick chimney faced with concrete stands in the center of the roof ridge.

The main facade is composed of finished cut limestone blocks with exaggerated quarry facing. The remaining walls are constructed of rough-cut coursed limestone rubble interspersed with some finished cut blocks with exaggerated quarry faced finish. Masonry bond is predominately two-against-one broken bond, and grapevine joints cover the whole. Quoins and jambs have exaggerated quarry faced finish. The stone lintels and sills have margin lines and texturing like that found on the water table. Stone steps descending from the two doorways have the same margin lines and tooled faces.

Windows openings are splayed and the sashes are flush with the walls. The window reveals have been plastered, whereas most other stone houses in the area have wood faced window reveals. The doors are recessed and lined with a single wide board at the top and sides of the reveals, and the transoms have been covered with painted plywood. Moderately overhanging eaves are open, with closed rafters and unmitted soffits. A narrow, plain fascia board lies against the stonework along the eaves.

A living room occupies roughly the north half of the ground floor; a kitchen and dining area are in the southern part, with a bathroom in the southwest corner of the ground floor. The upper half-story contains two bedrooms; stairs to the bedrooms are along the east wall near the northeast corner of the house. Interior woodwork is simple and predominately oak.

The exterior integrity of the McDonald House is high, and the structure is in excellent condition. No additions are present, and the only replacements are the asphalt shingles on the roof, the front and back doors (both of which appear to predate World War II), and the modern sash windows. The brick chimney may be original.

Two other buildings are associated with this house, both 1 story, gabled outbuildings. The garage southwest of the house is very recent, and the eavefront, drop-sided machine shed west of the house appears to be c. 1950. Both buildings are ineligible for nomination due to age, and they are not included within the boundaries of this nomination.

Historical Background and Statement of Significance

The McDonald House, probably built between 1869 and 1875, is significant under Criterion A as a good example of a vernacular stone farm house constructed after initial settlement but before the end of the stone building era in Madison County. The house falls toward the end of the stone building period, and similarly, its historical association is primarily with William S. McDonald, who came to Madison County during the Civil War. He and his wife, Barbara Combs McDonald, probably moved to this property in the early 1870s and they owned it for over fifty years. This house appears to reflect the tendency of Madison County farm families to construct stone houses relatively soon after establishing their holdings.¹

Small in size, simple in form and decoration, the McDonald House is significant under Criterion C as one of a range of stone buildings in Madison County. It is one of the more inexpensive stone houses built in the county, but its modest appearance belies a quality of workmanship. The McDonald house is also significant under Criterion C for its probable association with master craftsman David Harris. Harris was one of the few master stone masons still in business in Madison County during the 1870s, and the McDonald House exhibits several features that are characteristic of his work. These are the asymmetrical massed rectangle plan, slightly raised basement, two-against-one broken bond, and textured stone similar to that in other buildings attributed to him. With its good condition, high exterior design integrity and the fact that it displays "trademarks" of a locally significant stone mason, the McDonald House is an important contribution to Madison County's stone heritage.

The historical background of this farm residence is clouded. County atlases between 1875 and 1933 identify William S. McDonald as the owner of the property. William accumulated several hundred acres of land over the course of his lifetime, and while this farm is probably the first that he owned, it is unclear whether he resided here for all or most the fifty-plus years he owned it. Thus, the historic name of the house on this nomination form is the McDonald House rather than William S. and Barbara Combs McDonald House.

William S. was the son of Thomas McDonald, a Pennsylvania native who moved his family from Guernsey County, Ohio, to Madison County in 1862-1863. Thomas had seven children, six of whom were sons who eventually owned farms near their father's homestead. (Indeed, the 1879 <u>History</u> notes the high concentration of McDonald farms in Thomas's neighborhood in the southeastern Douglas Township as an unusual fact.) The location of the original family homestead is unknown, except that it was near the Howerdon Branch of the North River and formerly known as the Martin Baum place.² In 1869 J. J. Davies listed Thomas and his three eldest sons, Cyrus B., Joseph F. and Robert F. McDonald, as farmers and registered voters in Douglas Township. This farm is not shown on Davies map of the township, however.

William S., fourth son of Thomas McDonald, finished his schooling in Madison County in the 1860s before turning to farming. He married Barbara Ellen Combs in 1872, and by 1875 he was listed as the owner of this farm. He was a Republican and a member of the Presbyterian church, but nothing is known of his participation in local politics or community activities. He eventually became a large landholder in Douglas Twp., owning 690 acres by 1915.³ After his death in 1933, the farm remained in the family for at least 10 more years. William S. is buried in the McDonald Cemetery located less than 1/4 mile west of this property, and McDonald descendents still live along nearby roads.


