DESCRIPTION

The Lamme Hospital is a two-and-one-half-story building of Eclectic Style, representing a number of stylistic influences available in the early 20th century. Built of local sandstone, its rectangular, symmetrical plan and hipped roof are typical of the popular Foursquare Style, but its gabled dormers with fishscale shingles are a holdover from the Queen Anne Style. The simple battered porch posts foreshadow the Craftsman.

The property is located on Main Street just one block from the center of the commercial district. Behind the main building are a garage and planter also of cut stone. In 1985 a cottage was built at the back of the site, which reflects the style of the hospital and the stucco finish of the back porch. The original stone buildings are in good condition and look much like they did in 1925.

Comprising four lots, the Lamme Hospital site has 100 feet of frontage on Main Street. It is just south of the La Veta Public Library (5HF 334) and just east of the Fort Francisco Plaza, which is listed on the National Register of Historic Places (5HF 519). One-half block north is the beginning of the retail district. The Library and Lamme Hospital mark the beginning of a residential area which extends along Main Street to the south.

The hospital, built in 1909 by E.R. Coleman, is constructed of load-bearing ashlar coursed sandstone. The hipped roof is covered with asphalt shingles. Dormer gables on the front and side elevations have woodshingled ends. The front porch, added in 1911, has a wood cornice and wood posts resting on a cut sandstone base. The floor of the front porch is wood decking. The two enclosed back porches, added about 1925, have a sand-colored stucco finish.

Inside, the hospital has twelve rooms and is approximately 2500 square feet. The ground floor has a living room and dining room on the south side and a sitting room (now used as a gift shop), bedroom with bath, and a powder room on the north. At the back of the building is the kitchen, with an enclosed porch at either side. On the second floor are five bedrooms and three full baths. Up a few steps is a small porch over the front porch, within the center gable. A furnace room partially above grade at the back of the hospital still houses the original coal-burning iron furnace (no longer in use).

DESCRIPTION (continued)

The original high quality woodwork of the interior is seen in the door and window trim, stairs, wainscoting, and built-in shelves. Interior details include beveled glass transoms above the windows and doors on the ground floor. Several original light fixtures have been recovered and reinstalled in the building.

In the early 1980s, alterations were made to reverse those made in the 1950s and 1960s, returning the property to much the same condition it was in during the late 1920s. Screens enclosing the front porch were removed. Surface mounted fluorescent light fixtures were removed and replaced with the original where available or with other fixtures consistent with the hospital's period of construction. Doors and door hardware were replaced in the same manner.

In addition, a corridor was closed between the upstairs operating rooms to create a bathroom. Lavatories were installed in small bedroom closets. The plumbing and electrical systems were upgraded to comply with current building codes. A soffit was added in the kitchen to enclose a required range exhaust hood.

Spalling of the sandstone has occurred, and mortar joints have deteriorated primarily at the steps of the porch and, to a lesser extent, near grade at other areas of the building. Otherwise, the building is in very good condition.

The gabled roof, stone garage, built in 1920 also by E.R. Coleman, is about 570 square feet. The garage is located on the northwest corner of the site. It is a two-car garage, square in plan, accessed by an alley directly off of Main Street. It is considered contributing.

A cottage, built in 1985 at the southwest corner of the site, is approximately 456 square feet. It has one bedroom, a combination living room/dining room/kitchen, and one bath. Its stucco finish matches that of the back porch of the hospital. The cottage's gabled roof with gabled dormer and its windows reflect the style of the hospital. A cut sandstone planter is located just north of the cottage. Because of its recent construction, this is considered noncontributing.

SIGNIFICANCE

The Lamme Hospital is considered eligible to the National Register of Historic Places under Criteria A. The building was an early medical facility and La Veta's only hospital for a number of years. Many local citizens were born and received treatment here. It also provided medical services for the local coal camps of Oakview and Ojo.

HISTORICAL BACKGROUND

The land which is now the Town of La Veta, Colorado, was part of the Vigil-St. Vrain Mexican Land Grant of 1844. Colonel John M. Francisco, a Virginia merchant, had an agreement with Ceran St. Vrain to acquire a part of St. Vrain's share of the grant. Francisco chose Henry Daigre as his partner to oversee his claim. In 1862 an expedition led by Daigre established Francisco Fort or "Francisco Plaza" at the center of what is now La Veta, Colorado, attracting employees and settlers from New Mexico.

Francisco Plaza was one of a few communities in southern Colorado that served both Anglo and Latin communities. Construction of a grist mill was soon begun at what is now the south end of Main Street. The first buildings constructed after the adobe fort were log, wood frame, and adobe structures. Later, brick and concrete block were also used. Around 1890 the first cut-stone buildings were erected.

Around 1865, the settlement became known as "Las Cucharas," after the Cucharas River adjacent to the plaza. In 1871, it was designated "Spanish Peaks, Colorado Territory." In 1876 the Denver and Rio Grande Railroad arrived and used the northeast corner room of the plaza as a depot. D & RG officials platted a town on 200 acres of land donated by Daigre and Francisco and named the new railroad terminus "La Veta." The town was officially incorporated on October 9, 1876. La Veta was the division point for the railroad, and its general offices, telegraph office, and roundhouse helped the local economy grow.

Construction of the Lamme Hospital was begun in July, 1909, by E.R. Coleman. Peter Smith, a newspaper editor, and his wife Selina had commissioned it as a residence, but before its completion in December of that year, the Smiths traded homes with Dr. S. Julian Lamme.

SIGNIFICANCE (continued)

Dr. Stephen Jullian Lamme, who always used the name Jullian, grew up in various southern Colorado mining camps, attended high school in Walsenburg, and went on to obtain his medical degree in 1904 from the University of Colorado in Boulder. He and his new wife moved to La Veta the same year and opened his medical practice. An expanding clientele necessitated his move into what became the Lamme Hospital. Dr. Lamme used this building as his family's residence as well as his office and drugstore between 1909 and 1918. The downstairs housed the office and dispensary; upstairs were the clinic and living quarters.

Jullian's younger brother, James McGrew Lamme, joined the practice in 1911. James too grew up in southern Colorado, attending high school in Canon City before following his brother to the University of Colorado for a medical degree. For several years the brothers supplemented their private practice by working under contract to the company mining towns of Ojo and Oakview, a few miles north of La Veta. They agreed to treat the medical needs of all the communities residents for a modest monthly fee. During the violent 1913 mining strikes, the brothers tried to remain neutral as they removed bullets from victims on both sides of the dispute.

The influenza epidemic of 1918 swept through Huerfano county and the lack of a hospital caused the brothers to set up cots for additional patients in their living quarters and in the upstairs offices. In November 1918, the entire building was given over to hospital functions, including an operating room. The following year the Lammes moved to Walsenburg and sold the hospital to Dr. A.J. Chisholm. The Doctors Lee (Earl, Lewis W., and Paul) leased the hospital from 1921 to 1923, and purchased it in 1923. With partners and assistants, they continued operating it as a hospital until 1937.

In 1944, the building was sold to Pete and Kate Gross, who used it as a private residence with occasional roomers until ca. 1955. It served as a private home from 1955 to 1980, until sold to Marilyn Hall, the current owner. She restored it for its present use as a bed and breakfast inn.

The firm of E.R. Coleman (made up of the Coleman brothers along with William Fey) built most of the stone structures in and around La Veta between the years of 1890 and 1920. These stone structures, which number at least two dozen, include commercial, residential, and institutional

these buildings was quarried near La Veta on "Pinon Hill."

With twelve rooms, the hospital was La Veta's largest residence for many years and is still the town's largest sandstone residence. The hospital is a unique contribution to an area which has one of the largest concentrations of sandstone buildings in rural Colorado.


