### Description:

The Ellsworth-Jones Building (1902) is a three story, single storefront Neo-classical structure located at 511 Washington Avenue. Rectangular in shape, the building of reddish-brown brick measures 22' x 132', with the narrow end facing Washington. Directly west of the building is the Metropolitan Opera House, while to the east once stood the double storefront Ellsworth Block. The flat roof slopes to the rear. At street level, the Ellsworth-Jones Building is asymmetrical. On the right side is the raised entrance: a plate glass door flanked by plate glass sidelights. Above the entrance is a new metal canopy, affording a degree of protection from the elements. To the left is a large display window with brick in-fill below and prism glass transom above. Three granite columns, square in shape and topped with egg and dart engraved capitols, support the first floor cornice. This granite cornice continues the Neo-classical detailing. Carved into the entablature is the name of the company for which the structure was built: Ellsworth and Jones. The symmetrical second floor is composed of three rectangular windows, capped by prism glass transoms. Ionic columns appear to support this transom area and cornice above. Triple arched windows with stone surrounds are featured at the third floor level. The windows are separated by Doric columns from which the arches spring. The keystones are of acanthus leaf design. The metal cornice rests on heavy paired brackets. Centered between the brackets on the entablature is an olive wreath, with olive branches curving to each side. The Neo-classical details are continued in the dentils across the metal cornice. Historic photographs show that originally the building was crowned by a stone balustrade and identification pediment. With this exception, the building retains a very high degree of integrity.

The east elevation is presently exposed to the elements. The three story building which was adjacent was destroyed by fire. The owners have plans to cover this wall for both aesthetic and practical reasons.

The interior of the Ellsworth-Jones building is remarkably intact. The first floor retains it pressed metal ceiling, transomed doors, Neo-classical fireplaces in the NE and SE corners, pine woodwork, and marble and mahogany counter. A thirty inch mural, depicting various E.S. Ellsworth properties, runs around the perimeter of the main room between the ceiling and the picture rail. The original vault, extending from the basement through the second floor, is intact. The second and third floors, unoccupied and used largely for storage, also retain a high degree of integrity. The second floor, with its two fireplaces and vault, and the third floor with its skylight, are prime candidates for renovation and use as living space.







Significance:

The Ellsworth-Jones Building is the structure which best illustrates the importance of E.S. Ellsworth the businessman and philanthropist. It is locally significant under Criterion B as the main office of Eugene S. Ellsworth, and under Criterion C as an outstanding example of turn of the century Neo-classical commercial design. The period of significance is from the completion of the building in 1902 until Ellsworth's death in 1907.

Eugene S. Ellsworth was a land broker, town developer, and philantropist of immense success. The firm of Ellsworth and Jones, headquartered in Iowa Falls, purchased and sold land throughout the state of Iowa and other midwestern states. The company also had an extensive business in making loans from the same office and other offices located in Chicago, Boston, and Crookston, MN.

Ellsworth was active in more than business affairs. Between 1905 and 1907 he worked tirelessly to permanently endow Ellsworth College. He was one of the prime benefactors of the Iowa Falls Library and the Ellsworth Hospital. Ellsworth was instrumental in Iowa Falls' development in that he helped secure rail transportation, telephone communication, a golf course, and zoological park, and constructed significant commercial buildings for the city. Purportedly one of the four wealthiest men in Iowa at the time of his death (1907), there was little in Iowa Falls that E.S. Ellsworth did not leave a mark upon.

The Ellsworth-Jones Building is a superbly intact example of Neo-classical commercial architecture. From the egg and dart motif of the columns at street level, to the dentil work on the cornice, the exterior of the building is resplendent with Neo-classical details. Ionic and Doric columns, Roman arches, acanthus leaf keystones, and foliated decorative elements are only a few of the decorative elements found on the exterior of the Ellsworth-Jones Building.

The interior has changed very little from the days of its completion. Neo-classical fireplaces, with three quarter fluted columns, olive wreaths, and garlands upon the mantle, grace the offices of the first and second floors. Fluted pilasters, surmounted by lyres and acanthus leaves, flank the doorways of the first and second floor vaults. The stairway to the second floor retains its dark wainscoting and ornate newel post. The marble and mahogany counter, and the mural encircling the front office reflect the prominence of the firm and its partners.

Despite extensive research, the identity of the architect remains unknown.
