NATIONAL PHOTOS STATEMENT OF SIGNIFICANCE: The Robbins House is architecturally significant as a single_pen log house that evolved to the dogtrot type with the subsequent addition of a center hall and second pen. The split log construction of the original pen with ¹₂-dovetailed corners is characteristic of post-Civil War folk structures. On the premises are also found the county's single example of log stables, constructed of peeled poles joined with saddle notches. The Robbins House and land is historically significant because it was homesteaded after the Civil War in accordance with a May 20, 1862 Act of Congress, "To Secure Homesteads to Actual Settlers on the Public Domain." The house has been owned continually by the Robbins family.
