### Narrative Description

The Sherrill Mount House was constructed in  $1856^1$  as a commercial structure astride the stagecoach<sup>2</sup> route which traveled north along the Mississippi River. The Inn has 3 main stories, attic area and viewing cupola. The building was constructed of native limestone, quarried approximately 2 miles distant, which was transported by immigrants, in the block form, by wheelbarrows to the construction site.

A ramp of wood scaffolding was built to support the construction of the building, which allowed the workers to transport the stone to the top of the walls for placement. This ramp, built by hand, extended some 1000 feet to the north during construction and was removed after the structure was completed.<sup>3</sup>

When the building was completed it housed a tavern, beer garden, restaurant and kitchen on the first floor, dance hall and family quarters on the second floor, and overnight rooms on the third floor.<sup>4</sup> It would also serve the town of Sherrill as a post office and meeting hall. Except for the modernization of plumbing and mechanical systems and the lack of shutters along with modern aluminum window frames, the main structure retains it's original appearance. The kitchen and washroom, also of native limestone construction, have been covered with steel siding in the recent past.

With the exception of the kitchen room, the building exterior is totally of limestone, some 4.5 feet thick (as seen in the depth of the first floor window casements) at the foundation level. The exterior was plastered over at the time of construction to cover the limestone rock. The primary exterior plaster was then patterned with a block print to look like squared block construction.<sup>5</sup> This type of exterior plaster decoration is known and is "schitcherei" and is typical of larger public buildings in east central Europe. Examples of "schitcherei" from the same period are found in the eastern regions of the German state of Bavaria as well as on many government buildings in the city of Prague in the Czech Republic. This style is a probable throw-back to the eastern Bavarian origins of the builder, Mr. Peter Fries. Only traces of this original plastering and schiterei treatment is evident today. The primary outward appearance today is of rough limestone block mortared in place with a hand mixed cement mixture. All exposed wood areas to include the eaves, fascia, window and doors and trim work are painted.

The basement contains two vaulted limestone wine cellars used to store beer and wine for the tavern operation. Both cellars are in original condition with partial wine barrel racks still in existence, as well as the original wooden doors. The roof shape is of a hip design, with a large viewing cupola mounted on the upper most section of the roof. The eaves of the main building are decorated in fancy wood support angle scroll work and circular designs.

The interior of the building is of native timber in a post and beam construction. The rock exterior walls were plastered over and in turn covered during subsequent renovations with framing and plasterboard to accommodate modern electrical wiring and other fixtures.

The building was converted to apartments in the 1930's and served for a time as a local doctor's office. In the 1970's further updating and modernizing were completed. Additional bathrooms were added during these renovations as well as a second stairwell to accommodate the occupants of the back half of the building that was serving as a two-story apartment. Sometime during these renovations, the shutters were removed and the original windows covered with aluminum storm windows. The building was occupied until 1993 when the property was vacated as part of a divorce settlement between the owners. During that same settlement process, the property suffered severe water damage throughout the structure when the heat was turned off and all water pipes and bathroom fixtures froze and burst. The property remained vacant for the next several years suffering weather damage due to lack of repairs and general upkeep.

In 1999 renovation work began with upgrades to electrical, water and heating systems and the rebuilding of a cupola on the upper roof to replicate the original cupola, which was removed earlier. In September of 2000 the renovations were completed and the property rented as a multi-family 3 plex. Renovations continue today on the 3rd floor apartment with long term plans to fully renovate the structure back to a commercial inn operation.

### Statement of Significance

The building is of local and statewide significance under Criterion C as one of a very small number of pre-Civil War era hotels surviving in the State of Iowa. It is a locally significant example of stone construction of the time and is one of the largest buildings of this material surviving in rural Dubuque county. The property associated with the building at time of construction covered over 40 acres in what would become the town center of Sherrill. The inn included several outer buildings and agricultural operations, including a substantial orchard and vineyard along with two barns. Farmers in the area used to haul barley and other grains to the brewery in Potosi, Wisconsin, just across the Mississippi River from Sherrill. They would travel to the inn, remain overnight and make the river crossing with their grains the next day at the adjacent Finley's Landing, where a ferry to the Wisconsin side was located. Upon delivering their grains the farmers would re-cross the river and stay a second night at the inn before returning home.

The beer garden, tavern and dance hall on the second floor the inn was the social center of the entire community for a significant period of time until it's demise with the arrival of prohibition in 1919, at which time the building was first converted to a multi-family home.

Eventually the road, on which the building is located, was designated as "The Great River Road;" one of the more popular tourist trails in the tri-state region.







HISTORICAL MAP dtd 1892, Source: "SHERRILL THEN AND NOW", Schmitt, John H., December 1995, p. 35.





BASEMENT APROX 40X25 FT (NOT INCLUDING WINE CELLARS)








3<sup>ND</sup> FLOOR APARTMENT APROX 40X40 FEET (OPEN SPACE)

Attic Area Floor Plan of the Sherrill Mount House, 25 May 2001, drawn by the owner, Mr. Mark W. Maiers.




