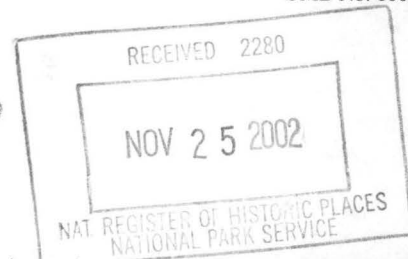

SUMMARY

The Crossett Post Office was a building far ahead of its time. Constructed in 1939-40 as a WPA project, the structure of the building, a basic square with a small "T" on the rear of the building that served as a loading dock, holds true to other post offices of that era. However, the design elements and style of the building were not typical. This one-story stucco building with a full basement is a combination of International Style and Art Deco with classical references through Greek Revival. The building is located at the northeast corner of the intersection of Main and Second Streets in the historic downtown district of Crossett. Though the interior of the building has changed over the years for functional purposes, the exterior is in excellent condition and appears almost the same as it did at the time of construction.

ELABORATION

The front, or west side, of the building is the main entrance, which is constructed of light green stucco walls with limestone coping around the base of the building. The front sidewalk leads to granite steps flanked by two limestone abutments. The front of the left abutment contains a 1964 plaque from the Crossett Rotary Club. The front of the right abutment contains a 1968 plaque commemorating the opening of the library. On top of both abutments sits a lamp post to greet visitors. Iron handrails line either side of the steps. The doorway is encased by glazed red marble with the words "Crossett Arkansas" across the top. The original double glass doors were replaced by a single glass door for safety and accessibility. The center of the façade of the building is covered by 65 tinted window panes measuring 25" x 18" with metal window grids. The front entrance is surrounded by these windows. Centered above the windows and directly below the pediment, the words "Paul Sullins Public Library" appear in metal letters on the frieze. These are the same type of letters that replaced the original "Crossett Arkansas Post Office." The name of the building was changed in 1968 when the public library moved into the building. A simple copper ornament decorates the pediment. There are also two copper cornices that flank the pediment. Left of the front steps is the limestone cornerstone. The cornerstone indicates that the building was a WPA project built in 1939, by supervising architect Louis A. Simon. When the building was originally built, a flagpole stood to the north of the front sidewalk. The flagpole was replaced in 1976 with a memorial to the war dead.

As you progress around the exterior of the building the same light green stucco, limestone coping, and large windows with limestone window sills and marble accent appear. On the south side of the building, is the exterior entrance to the basement. There are concrete steps leading down to double metal doors with small glass windows in each. The exterior door leads to a large basement that is divided into different rooms. The basement has been used mainly for storage over the years. It also served as an official Civil Defense Shelter.

The loading dock and back door are on the east side of the building. The loading dock has a metal handrail and opens onto a concrete platform. The back door of the building is also handicapped accessible.

The main, front section of the building has a metal gable roof, while the back of the building has a flat, built-up roof.

During the change from the post office to library, there were many interior changes made; however, the one area that has remained basically the same is the vestibule. The vestibule is semi-circular in shape and surrounded by metal and glass walls. The bottom trim on the walls is bronze. The original glass panes were plain glass, but in the 70's were changed to stained glass with a morning glory design to honor a Methodist deaconess who was hired by the Crossett Company to teach the early workers to read and write. The floor of the vestibule is terrazzo. There are two doors on either side of the vestibule leading into the main room of the building.

SUMMARY

The Crossett Post Office located at the northeast corner of the intersection of Main and Second Streets in Crossett, Arkansas, is being nominated to the National Register of Historic Places under **Criterion C** with **local significance** for its unique blend of Art Deco, Greek Revival, and International architectural styles in Crossett. It is also being nominated to the National Register under **Criterion A** for local association with federal postal operations and WPA construction in the growing town of Crossett, Ashley County.

ELABORATION

The history of Crossett, Arkansas, is a unique one indeed. In 1899, a young lumberman, E. W. "Cap" Gates, persuaded one of his relatives, C. W. Gates, and two Iowa investors, Dr. J. W. Watzek and E. S. Crossett, to purchase 47,000 acres of virgin timberland in southern Arkansas and northern Louisiana.

With the new landowners' blessings, "Cap" Gates supervised the construction of a sawmill and a small town nearby. Residences for employees, a church, a school, and a large company store were built, and E.W. Gates was appointed to serve as manager of the newly formed Crossett Lumber Company and the company-run town. E.W. Gates had grand visions for the future of Crossett.

At the turn of the century, company-owned sawmill towns were common. This meant that the company owned "everything." Employees worked for the company, lived in a company house, shopped at the company store, sent their children to company owned schools, and received company scrip as pay. Until 1946, in Crossett, every business and building in town, except the café, pressing shop (laundry and dry-cleaning store) and post office were company owned and operated. In 1946, due to the increasing size of the town, a new development plan was established and private homes were sold to company employees.

According to local historian, Rev. J.W. Buckner, "Company officials possessed overwhelming control over the destiny of the workers and the town." Due to this extreme control the Crossett Lumber Company officials were able to keep out much of the "riff-raff" that was usually associated with other company towns. Crossett Lumber Company's control has been attributed to the lack of transportation and the isolated location.

Because of his influential position in the company, "Cap" Gates was also influential in town. E.W. Gates did not want Crossett to become just another cheap, unsightly sawmill town with shotgun houses, narrow streets and poor facilities. E.W. Gates planned the town with wide streets, playgrounds, schools, churches, and provided modern facilities for the citizens. Buckner described Gates as having "a broader vision than any other sawmill man of the area in 1898. After all, he had been associated with men who did things in a big way and were used to broad plans."

In the late 1930s, the United States Treasury Department announced plans to build a new post office building in Crossett, Arkansas. The structural plans for this building were met with the same "broad vision." The Crossett Lumber Company promptly donated the land, which was the former site of the Club House and Natatorium. The company wanted the post office to reflect new progressive ideas, which would represent Crossett as a progressive city.

When construction was completed in 1940, Crossett reveled in the addition of the "pleasing green" stucco building that was designed using a combination of Art Deco, Greek Revival, and International architectural styles. The Post Office provided both convenience and an economic boost for Crossett. More importantly than that, however, this building was a symbol of pride for the citizens of Crossett. This pride was articulated in an article in *Forest Echoes*, a magazine published monthly by Crossett-Watzek-Gates Industries and devoted to the interests of their employees, announcing the plans to build the Post Office. The author described the decision as "indicative of recognition by those in authority that we have a permanent city," as opposed to the many company towns that became ghost towns once the company decided to move on.

The \$70,000 Crossett Post Office was finished and dedicated in August 1940. The building continued to house the post office until 1968, when plans were made to build a new post office. Chairman of the Crossett Public Library Board, Paul Sullins, entered into negotiations with the Post Office Department in hopes of purchasing the building to become the fourth home of the Crossett Public Library. The US Government sold the old post office facilities to the library board for \$1. The library board decided to honor Sullins for his work in securing the building for them by naming the new library the Paul Sullins Public Library. The library remained in the building until August 2002, when it was moved a new, larger facility.

SIGNIFICANCE

To the citizens of Crossett, Arkansas, in 1940, the building of the new Crossett Post Office signified the belief held by federal government that Crossett was not your typical short-lived company town. However, citizens of Crossett did not realize what a delightful structure they were getting. To the average citizen at the time, the design elements of this building may have been nice, but few realized just how innovative this building really was. In terms of design, this is a building built decades ahead of its time. The Crossett Post Office was, and still is, a jewel hidden in a small town in Southeast Arkansas.

The Crossett Post Office is being nominated to the National Register of Historic Places with **local significance** under both **Criterion A** for its association with federal postal operations and with WPA construction and **Criterion C** for its unique blend of International Style and Art Deco with classical references through Greek Revival architectural styles in Crossett.

ALL that parcel of land situate, lying and being in the City of Crossett, County of Ashley, State of Arkansas, being part of the northeast quarter of the northeast quarter of Section 19, Township 18 south, Range 8 west, and more particularly described as follows: The beginning point of said parcel lies south 6° 50' east 1037.50 feet from the section corner common to Sections 17, 18, 19, and 20 of Township 18 south, Range 8 west, which point is the line common to said Sections 19 and 20, and south 84° 20' west 669 feet from said point to a 6" x 6" x 36" concrete monument located at the intersection of the alley as now located between First and Second Street of said City, County, and State, and the north line of Rock Island Avenue as now located. Thence on a course along the north line of Rock Island Avenue south 75° 38' west of a distance of 165.95 feet to a 6" x 6" x 36" concrete monument which point marks the northeast corner of the intersection of Rock Island Avenue aforesaid and First Street. Thence on a course along the easterly side of First Street, north 14° west a distance of 120 feet to a 6" x 6" x 36" concrete monument. Thence on a course parallel with the northerly line of Rock Island Avenue north 75° 38' east a distance of 165.95 feet to a 6" x 6" x 36" concrete monument located on the west side of the above-mentioned alley. Thence on a course along the west side of said alley south 14° east a distance of 120 feet to the point of beginning.

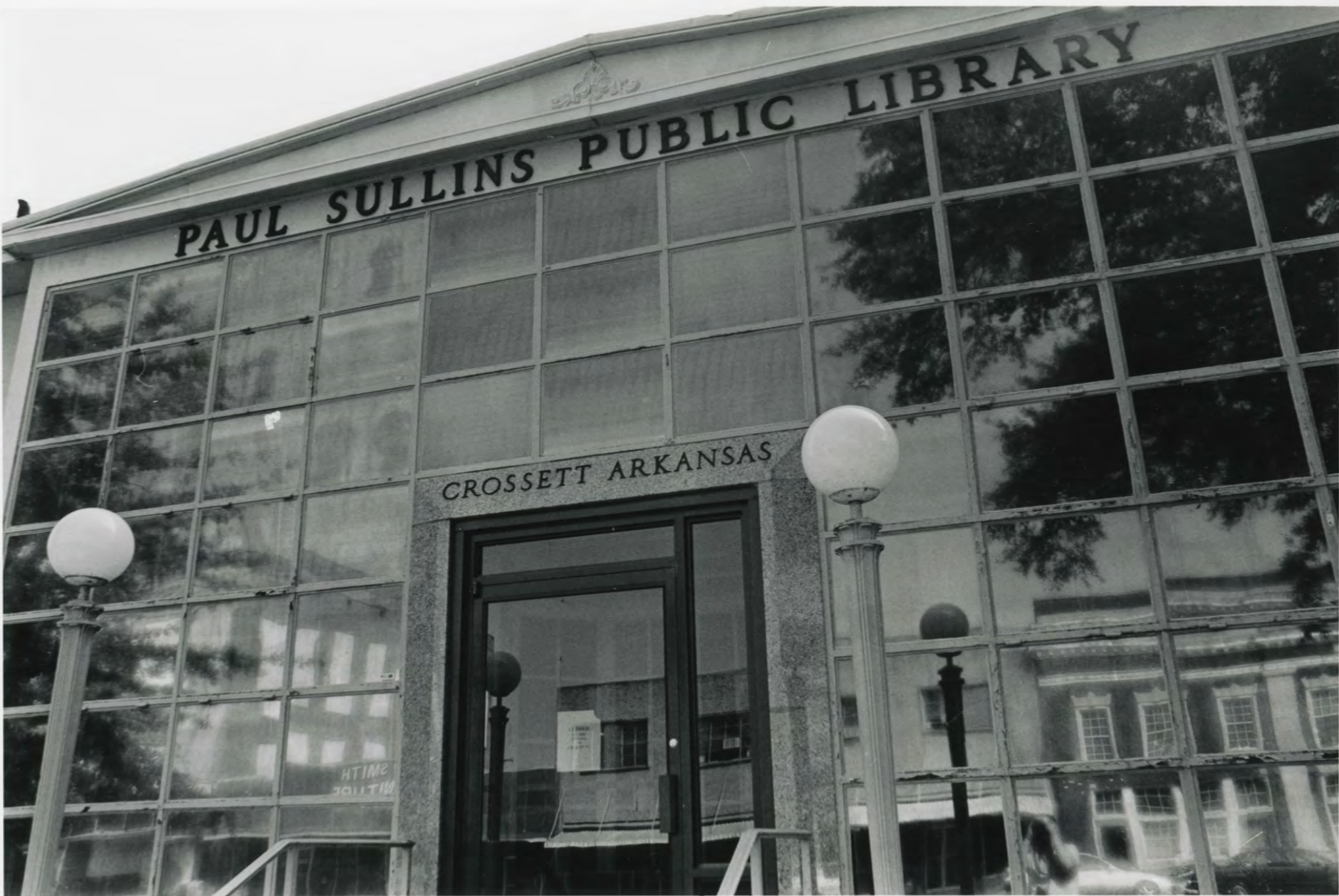

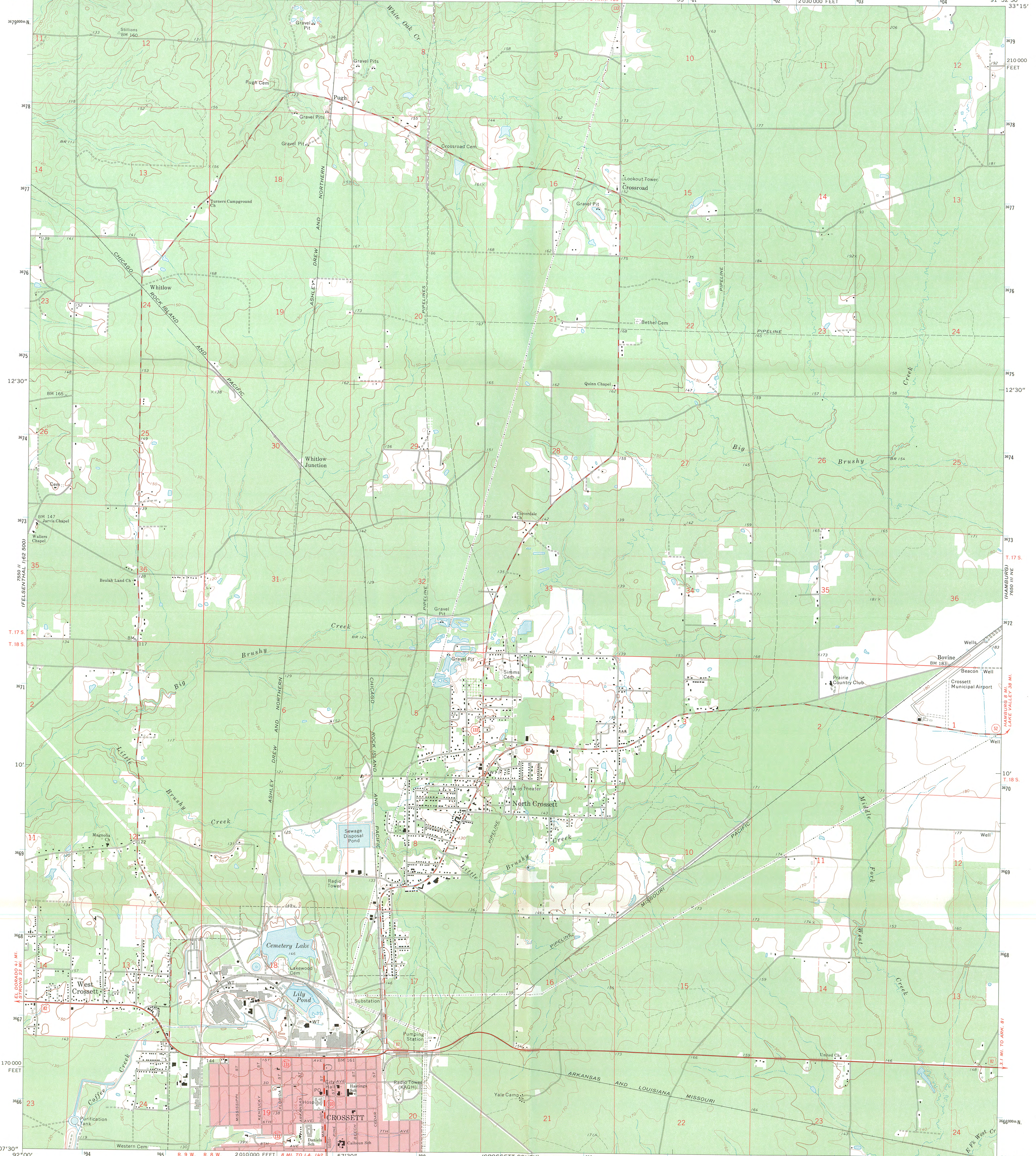

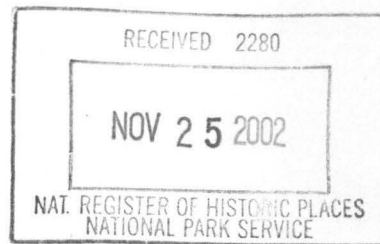
