Description of present and historic physical appearance:

The Erwin Street Historic District is located in the central business district of Cartersville in Bartow County in northeast Georgia. The Erwin Street Historic District nomination is part of the Historic and Architectural Resources in Downtown Cartersville, Georgia Multiple Property Nomination and includes six historic commercial and community landmark buildings and a Confederate Civil War monument (photo #1). The community landmark buildings include three institutional and two religious buildings. The buildings range from the large 1902 Neoclassical Revival style Bartow County courthouse to the one-story, brick former Central Office of Southern Bell constructed c.1940. Two of the buildings, the Sam Jones Memorial United Methodist Church and the Bartow County Courthouse are already listed on the National Register. Built in 1947, Dr. Harold J. Lowry's Dental Office is the only noncontributing building in the district.

The institutional buildings within the district include the Bartow County Courthouse, the former Cartersville United States Post Office, and the former Cartersville City Hall. Listed on the National Register on September 18, 1980, the courthouse at 135 West Cherokee Avenue was built in 1902 and designed by Kenneth McDonald & Company and J. W. Golucke (photo #2). The contractor was Fred Wagner. This Neoclassical style building has elaborate detail with a prominent, NPS Form 10-900-a

front, pedimented portico on the north fac de with Corinthian Columns, and pronounced cornice. Rectangular windows with emphasized keystones are on the front and side facades. The rear windows have plain stone lintels. A metal cornice encircles the building. Walls are 16" thick and window sashes are 5-1/2' wide. The ornate cupola, with its arched entrances, paired columns, and open pediment, rises in three stages to a ribbed gilded dome with clocks facing each direction. The courthouse has a granite block foundation.

The former U.S. Post Office, located at 1 North Erwin Street, is an Italian Renaissance Revival style building with beige, stretcher bond brick and a hipped slate roof (photo #3). This 1914-15 building features five front facade arches of Georgia white marble (photo #4). It was built by contractor Oscar Wenderoth and designed by John W. Emery of Pennsylvania. It has open eaves, exposed rafter ends, and a symmetrical facade. The central section of front facade (corresponding to interior lobby) features a five-bay arcade with white Georgia marble arches, fluted Corinthian pilasters, and arched five-part windows in the arcade. The other windows are 12/12, double hung sash. Other details include a double-door, front entrance, three-part semicircular fanlight, a molded brick water table, and decorative brick panels. The building served as the U.S. Post Office until 1965 and currently houses Cartersville City Offices. The interior was altered for use by the School Board and City Offices in 1969 and 1979. The vestibule and lobby are partially intact and features vaulted ceilings, wood birch pilasters and white tile floor with dark Creole Georgia marble borders and base.

The 1916 former Cartersville City Hall is a two-story, red brick building (photo #5). Located at 19 North Erwin Street and built by contractors R. W. and E. W. Smith, the front portion served as City Hall and rear portion as Fire Department. Today, it houses only the Fire Department. It has a three-bay symmetrical facade with recessed double-entry doors framed with fluted wooden pilasters and a simple wooden entablature. There are brick, semicircular arches over the first floor windows on the front facade. The North side windows are rectangular, double hung sash with 12/12, 9/6, 9/9, 6/6 configurations. The interior features a central hall with stairs to one side.

The religious buildings in the district include the First Baptist Church of Cartersville and the Sam Jones Memorial United Methodist Church. The 1904-05 First Baptist Church of Cartersville is a Romanesque Revival style stretcher bond, red brick building with a stone foundation and a cross-gabled parapet roof (photo #6). Located at 114 West Cherokee Avenue, it was designed by J. W. Golucke. It is a cross plan church with entrances in the front corner towers that United States Department of the Interior National Park Service

have different heights and roof shapes. Other features include corbelled brick details, round arched window and door openings, and rose (or wheel) windows in front and side facing gables.

Built in 1906, the Sam Jones Memorial United Methodist Church is a Classical Revival building with a full metal and stucco entablature and a portico supported by four Corinthian columns (photo #7). The church was built of beige brick with granite trim and rough-hewn granite blocks for the half basement. The building was built by contractor Eugene W. Smith and designed by Walter T. Downing. The below-ground half-basement contains a modernized meeting and dining The main floor contains a two-story sanctuary with its original room. pews, fluted Corinthian pilasters, original wainscoting, and a rounded-arch altar or chancel area. Original brass hardware remains throughout the building, as do the original steam heat and electrical fixtures. Changes include the excavation of the basement in 1933 to create more space, the addition of stained glass windows in 1945, the remodeling of the chancel or altar area in 1973, and the installation of a new organ.

The only commercial building in the district is the 1940 former Central Office of Southern Bell which now houses the City of Cartersville Economic and Development Department at 101 North Erwin Street (photo #5, left). A residential-type commercial building, it is a side-gabled, red brick, stretcher bond building with a rear extension, three-bay asymmetrical facade, semicircular arched entry in the front gable, semicircular fanlight over entry, and boxed cornice. There are lunette vents in side gables and rectangular double-hung, 6/6 windows. The side chimneys have been removed and a handicapped ramp has been added.

The North Erwin Street Historic District is located in the heart of downtown Cartersville, which is relatively flat. The streets are two way with parking limited to lots beside and behind the buildings. The landscaping consists of lawns around the buildings with small trees and shrubs. The courthouse lawn has larger oaks and dogwoods. There is a granite wall around the courthouse lawn and the Sam Jones Memorial United Methodist Church. The district is surrounded by historic and modern commercial and residential development.

Significance of property, justification of criteria, criteria considerations, and areas and periods of significance noted above:

Narrative statement of significance (areas of significance)

The North Erwin Street Historic District is significant in <u>architecture</u> for its good examples of representative styles, such as Romanesque Revival, Neoclassical Revival, Italian Renaissance Revival, and Colonial Revival, commonly used during the early 20th century for public building design. The district is also significant in architecture for its good, intact examples of community landmark and commercial building types. These buildings are classified by their function and reflect the development of downtown Cartersville into a well-established, small Georgia town.

Built in 1940 with Colonial Revival influences, the Central Office of Southern Bell in Cartersville is a good example of the residentialtype, commercial building. Built to reflect current domestic architectural trends, this commercial building type looks more like a dwelling than an office. Always freestanding, this building type originated in the 1920s when businesses strived to achieve a respectable and familiar appearance that made you feel "at home." Most recognizably seen in hotels, restaurants, and gas stations, it was also used in other commercial or service oriented buildings.

The district is also significant for its high concentration of buildings built by prominent architects. The Bartow County Courthouse Kenneth McDonald & Company and J. W. Golucke & Company. Kenneth McDonald (1852-1940) was a regionally prominent architect from Louisville, Kentucky. Known for his courthouse and jail designs, he worked with his brother Harry McDonald in the McDonald Brothers Company (1873-1897) and later with John Francis Sheblessy (1901-1905). The associate architect on the courthouse project was James W. Golucke (1857-1907) who was a prominent Atlanta architect known for the 20 courthouses he designed in Georgia. Most of his buildings reflect the Romanesque Revival style, as seen in the First Baptist Church of Cartersville which was completed in 1905.

Walter T. Downing (1865-1918) was a noted Atlanta architect who designed the Sam Jones Memorial Methodist Church in 1906. With offices in Atlanta and Chattanooga, he designed many public buildings, high rise offices, and private homes in both Georgia and Tennessee.

As the United States supervising architect from 1912 to 1929, Oscar Wenderoth (1873-1938), who designed mostly post offices, was the architect for the Cartersville United States Post Office. This post NPS Form 10-900-a United States Department of the Interior National Park Service

office is a Italian Renaissance Revival building that was completed in 1915.

The district is significant in <u>politics and government</u> for the Bartow County Courthouse, the former U.S. Post Office, and the former city Hall which document the presence, respectively, of the county, federal, and city governments in Cartersville. This area has been the center for county governmental activity since 1864 when Cartersville replaced Cassville as the county seat of Bartow County. In Georgia and throughout the South, county government has traditionally been the strongest form of local government. The present courthouse is the second courthouse in Barrow County's history and the longest-used one since it was built in 1902--the old courthouse is located on Church Street near the railroad. City government is represented by the former City Hall building, which now houses the Fire Department. More city offices are located in the former Central Office of Southern Bell and the former U.S. Post Office.

The district is significant in <u>religion</u> for the First Baptist Church of Cartersville and the Sam Jones Memorial Methodist Church, which have been an integral part of the development of downtown Cartersville. These churches represent the two historically dominant religious faiths in Cartersville and throughout Georgia. The Methodist Church is also significant in local religious history as the current home of one of the county's oldest Methodist church congregations. The church is also significant for having been named for one of Cartersville's most famous citizens, the nationally known evangelist Sam P. Jones (1847-1906), a member of the church, whose sudden death in 1906 during the church's construction led the congregation to name it as a memorial to him.

National Register Criteria

The North Erwin Street Historic District is eligible under **Criterion A** for its significance in the governmental and religious history of Cartersville. The district is also eligible under **Criterion C** for its concentration of historic, intact, commercial, institutional, and religious building types reflecting architectural styles popular in the early 20th century built by locally and regionally prominent architects.

Because the religious buildings within the North Erwin Street Historic District are integral parts of the district, there are no criteria considerations.

Period of significance (justification)

The Bartow County Courthouse was constructed in 1902 and is the oldest building in the district. The Central Office of Southern Bell was built in 1940, which is the most recently constructed building in the district that is historic (older than 50 years old).

Contributing/Noncontributing Resources (explanation, if necessary)

The six contributing buildings and one contributing object were built within the period of significance and retain their integrity. The one noncontributing building in the district was built after the period of significance.
