SUMMARY

The Mandarin Store and Post Office is at 12471 Mandarin Road, in Jacksonville, Duval County. The historic community of Mandarin has been incorporated into Jacksonville. The store sits on the south side of Mandarin Road at the corner of Brady Road. Built in 1911, this building was used as a general store and post office until 1964. The store is a one-story, Frame Vernacular building with a drop siding exterior. The front gable roof has a metal surface, and there is a full width porch across the front elevation. The building retains its historic integrity to a high degree and is in good condition.

SETTING

The Mandarin Store and Post Office is located in the southern part of Duval County, in what historically had been the community of Mandarin on east shore of the St. Johns River. Mandarin Road roughly parallels the river, and was an area of early settlement. The property is located diagonally across the road from the site of the winter homes of famed 19th century author Harriet Beecher Stowe, and is contiguous with the Mandarin Community Club (originally built by Harriet Beecher Stowe). The surrounding community is largely recent residential development with a few historic homes and a cemetery remaining in the vicinity. About one mile of Mandarin Road is being locally designated as a historic roadway.

PHYSICAL DESCRIPTION

The Frame Vernacular building with a rectangular footprint, measures 30' 6" in width, and 40' 6" in length. It is constructed on short brick pier foundations, and has a front gable and side shed roof finished with 5-V crimp sheet metal. The exterior is surfaced with drop siding with corner boards.

The <u>main, north façade</u> fronts onto Mandarin Road (Photo #1). There are two single-door front entrances with screen doors. One door goes into the store, flanked by two windows, and the other into the post office. The windows are 6/6, double-hung wooden sashes, and have wooden shutters. A porch spans the entire elevation, and is sheltered by a shed metal roof supported by five square posts. Two steps span the porch. Two benches affixed to the front porch were recreated from early photographs. Turned spindle balusters are at the east end of the porch (Photo #2). Within the gable above the store door is a large wooden louvered vent. A sign reading "Walter Jones" covers part of the vent. The post office portion of the building is covered with a side-shed roof, obscured from the north façade by the porch roof. At the top edge of the roof, above the post office door, is a small signs that reads "Post Office Mandarin, Fla."

The west elevation is a windowless solid wall (Photo #3). A seam toward the south corner indicates where a historic addition was made.

On the <u>south elevation</u> there are double doors on a straight line with the store's front door (Photo #4). The door is flanked by two windows with 2/2, double-hung wooden sashes, and wooden shutters. The gable

contains a rectangular vent with wooden louvers. The shed roof on the post office side of the building is evident. A recent wooden porch and access ramp rises from the east side.

The <u>east elevation</u> has one window filled by a 6/6, double-hung wooden sash, with a wooden shutter (Photo #5).

The interior of the building contains four rooms plus a restroom. The floor is heart pine, and the walls and ceiling are tongue and groove paneling. A great room, 20 feet wide running from north to south, comprises the general store (Photos #6,7). A second room measuring 10 feet wide by 8 feet long is the outside room of the post office, accessed only from the front porch (Photo #8). A third room 10 feet wide by 7 feet long is the inside room of the post office, accessed from the store by an interior door (Photo #9). The fourth room, 10 feet wide by 19 feet in length, was known as the "feed" room. A rest room, 10 feet wide by 7 feet long, with commode, sink, and broom closet, is a recent addition. The only side window in the building is to illuminate the inside post office room. The outside room of the post office houses the mailboxes, which were filled from the inside room. Many items from the old store such as the cash box, scale, ledgers, crates, boxes, barrels, bottles, a chopping block, etc. have been donated by descendants of the store's original owners.

ALTERATIONS

The original building was constructed with a single room containing the general store, and two east side rooms for the post office which had a service window and outside room opening onto the front porch. An addition extended the length of the store towards the south, and extended the post office portion also so they shared a common south wall. The addition is composed of materials identical to the original building, resulting in the assumption that the alteration came soon after 1911. The additions are noted on the floor plan attached. The building was restored in 1998. A restroom was installed. Front porch benches were replicated from historic photographs. Interior store counters were replicated from the damaged originals. Two signs that were on the building during its historic period have been restored and remounted in their original locations. The signs read "WALTER JONES," and "POST OFFICE MANDARIN, FLA." Some exterior siding, ceiling, wall, and floor boards were repaired with duplicated boards.

SUMMARY

The Mandarin Store and Post Office is nominated to the National Register for its significance on the local level under Criteria A and C in the areas of Commerce, Communications, and Architecture. The store and post office served as the commercial and community center of the Mandarin community throughout the historic period. The store's current location since 1911 reflects the change in commercial transportation from the St. John's River, to paved roadways. The store and post office is a rare and excellent example of frame vernacular construction. The physical integrity is very high.

HISTORIC CONTEXT

The historic community of Mandarin, now a part of Jacksonville, is on the eastern shore of the St. John's River, on a rounded peninsula. Native-American, Spanish, and English settlement was drawn to the fertile land bordering the river. Archaeological evidence of human habitation dating to the time of European contact has been found (Florida Master Site File). Timucua speaking Indians left three large mounds near the water's edge, an indication that the area was a settlement. The Native Americans were an agricultural and gathering society. In the 16th century Spanish settlers lived in the region, although information about their settlement of the Mandarin area is not known. During the 20 year British custody of Florida (1763-83), a settlement was established on the Mandarin site and named St. Anthony. When the Spanish reclaimed Florida from 1784-1821, they kept the name, calling it San Antonio (Graff, 1953:6). Upon the American take-over in 1821, residents changed the name to Monroe, in honor of U.S. President James Monroe. It remained Monroe until July 29, 1830, when at the suggestion of Calvin Read--a citrus farmer from Vermont, it was changed to Mandarin in honor of the Mandarin orange, which the area was introducing into the national market (Graff, 1953:14).

In the 1830s, riverboats made regular stops at Mandarin while on trips between Savannah and Picolata on the St. John's. Five main docks lined the north shore from County Dock Road, to Store Lane, the center of community development. The orange trees were hurt by a serious freeze in 1835, and an insect blight several years later. In 1841 the legislature incorporated Mandarin, but the duration of incorporation is unknown. In December of 1841, during the Second Seminole War, Indians burned several houses and killed three settlers. As a result, settlers relocated to better defended city centers such as St. Augustine and Jacksonville. Never the less, a general store operated in Mandarin community beginning in the 1840s. Prior to the Civil War lumber, cotton, oranges and vegetables were shipped from the community.

During the Civil War, Federal forces occupied Jacksonville and established garrisons as far upriver as Palatka. Confederates did what they could to harass them by planting mines in the channel off Mandarin Point. Two U.S. transports, including the Maple Leaf (NHL, 1994) and General Hunter, were sunk there in 1864 (Graff, 1953:41). Following the war, Harriet Beecher Stowe, the author of Uncle Tom's Cabin, and her husband bought a house in Mandarin for winter use. She helped procure from the Freedman's Bureau a school that was

located in Mandarin. The Stowe's also helped established the Episcopal Church of Our Savior (Wood, 1989:284).

HISTORIC SIGNIFICANCE

The origins of the Mandarin Store and Post Office as an institution go back to 1875, when John C. Brown built the original store on the riverfront at the foot of Old Store Lane, close to the Mandarin Wharf and Dock (Brown, 1963:2). Brown owned and operated the store until 1879, when he began to sell the inventory to another merchant to operate it. The last owner of the inventory was Walter Jones, who was appointed the postmaster in 1906. Son of an overseer of an estate near Liverpool, England, he had worked his way for passage to America in hopes of making a fortune. He worked at the store until, in 1911, it was replaced by the existing structure built by William Monson on property Monson owned on the northeasterly corner of Mandarin and Brady Roads (Graff, 1953:62).

When the store moved, Jones moved with it, leasing it from Monson and carrying on as both manager and postmaster. The previous year (1910) he had moved his family into a modest farmhouse located on the St. Johns River at the foot of County Dock Road. He continued his dual role until his death on December 30, 1928. His daughter, Agnes Jones, then assumed the role of manager and postmistress and served until she closed the store in 1964, when the post office was relocated to State Road 13. The store was purchased by the Jones family in 1958.

The relocation of the store from the riverfront to Mandarin Road signaled a shift of transportation and commerce from the age of riverboats, to cars and railroads. The five main docks along the early community's river frontage were no longer the primary contact for material exchange, but the corner of Mandarin Road and Brady Road was a primary intersection of the early community. Brady Road was the main inland corridor through the community and the area where larger farms were developed.

The store and post office served as the central institution of the Mandarin community and surrounding countryside. People from all walks of life frequented the store. It was not only where the inhabitants got their mail, food, stock feed, thread and window glass, but it also served as gathering place and point of news exchange for villagers. The ledgers detail how most food was bought on credit, and home deliveries were made, but it was also customary to give one's shopping list to Agnes who gathered the items from the stock while the customer waited. A large collection of magazines and books were available so it also functioned as sort of a library. Agnes was an anonymous philanthropist who provided necessities for the needy (Roach, 2000).

After its closure in 1964, the building was used as retail and office space, including for a local newspaper, *The Mandarin Advertiser*. It was used as a residence until it was restored as the Mandarin Store and Post Office in 1998.

ARCHITECTURAL CONTEXT AND SIGNIFICANCE

Frame vernacular construction techniques and forms are used by lay or self-taught builders,

exemplifying common building techniques based on forms and materials of a particular period or place (Ching, 1995:135). The industrial revolution permitted a standardization of building materials and parts that exerted a pervasive influence over vernacular house design. Popular magazines disseminated information about building trends and styles throughout the country. Railroads provided affordable distribution of manufactured building products.

The building was constructed by William Monson, a local builder who erected many homes in the vicinity during the first half of the 20th century. He was assisted by other local carpenters. The Mandarin Store and Post Office is the only historic building used exclusively for commercial purposes still standing in the Mandarin area. The Mandarin Store and Post Office is an excellent example of Frame Vernacular construction, and dates from 1911. The front gable, rectangular building has a sheet metal roof, drop exterior siding, corner boards, and brick piers. The front verandah has a shed roof. The building retains its integrity to a high degree, and still exemplifies a typical community store that also served as a post office.

VERBAL BOUNDARY DESCRIPTION

Part of the Samuel Fairbanks Grant, Section 22, Township 4 South, Range 26 East. More particularly described as follows:

Commencing at the intersection of the Southerly line of Mandarin Road and the Easterly line of Brady Road; thence along the Southerly line of Mandarin road, North 79 degrees 30 minutes E., 137.93 feet to an iron located at the Northwest corner of lands owned by Mandarin Community Club described in Deed Book 280, page 335; thence South14 degrees 20 minutes East, along the Westerly line of lands owned by the Mandarin Community Club, 364.87 feet to an iron located on the Northerly line of lands owned by Frederick Billard described in Deed Book 62, page 528; thence South 79 degrees 00 minutes West, along the Northerly line of Frederick Billard land, 155.74 feet to an iron located on Easterly line of Brady Road; thence North 11 degrees 32 minutes West, along the Easterly line of Brady Road, 365.47 feet to the place of beginning.

BOUNDARY JUSTIFICATION

The boundary encompasses the property historically associated with the Mandarin Store and Post Office.
