board and batten on the east, and vertical plank on the north and south. A pond is sited behind the house. The balance of the property is in tillage.

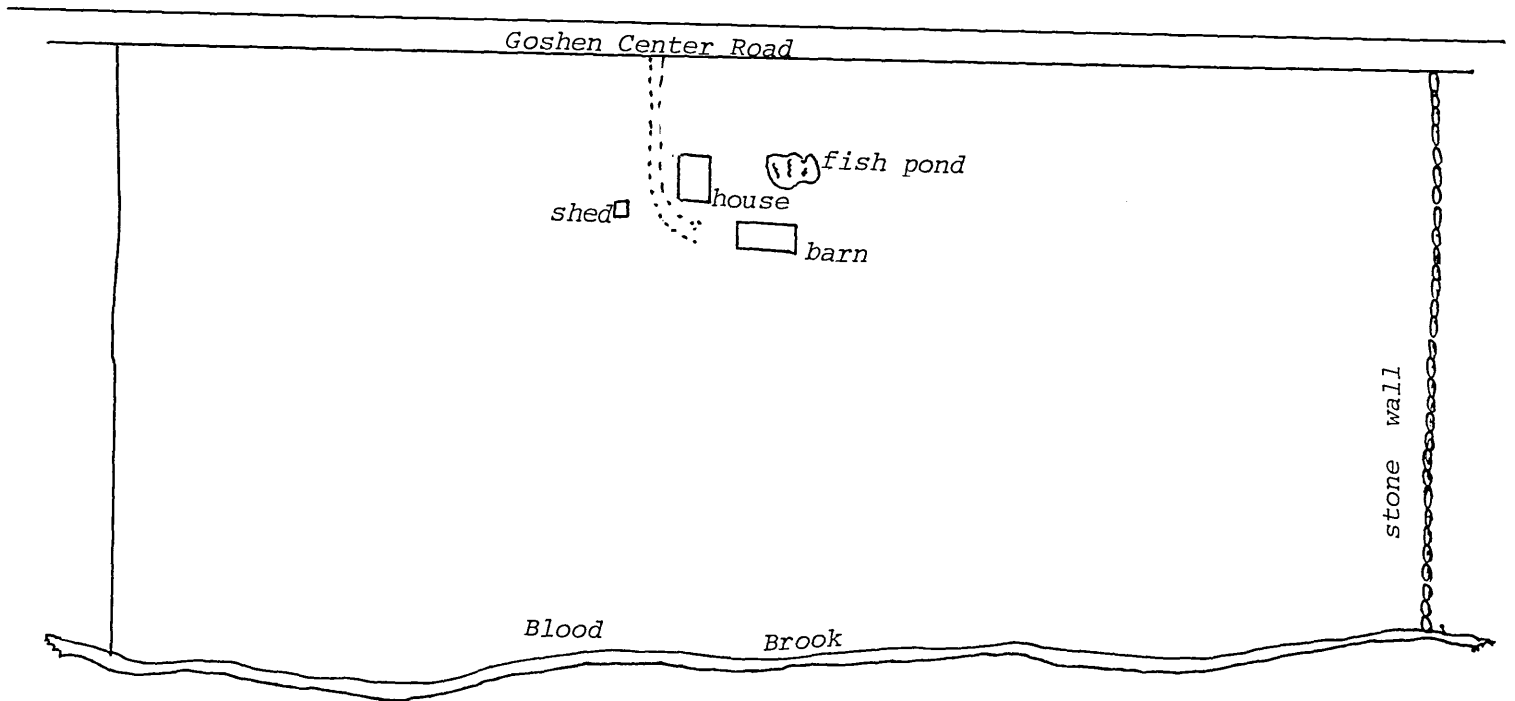
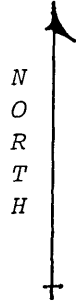
