The Cathance Water Tower is a two-stage wooden frame structure which is about thirty feet in height. Its pyramidal base is sheathed in clapboards, whereas its overhanging upper stage is clad in wood shingles. The tower stands in close proximity to the wooded east side of Cathance Road. Stone corner piers support the structure's timber sills.

The base of the tower features a vertical board entry door centered on the west elevation, a second similar door at the northwest corner, and a double hung window on the lower part of the east side, above which is a third door. A deteriorated catwalk located below the east side door leads to a ladder which in turn provides access to the upper level. The upper stage is comprised of a cribwork platform that overhangs the base by 2-3 feet. Its slightly tapered four walls are flared at the base, and it is capped by a shallow hipped roof. There are two small, symmetrically placed rectangular openings on the east and north elevations.

Inside, the stairs to the upper level of the base are located along the north wall and are accessed by the door at the northwest corner. The door on the west side provides access to the lower level of the base which originally contained the machinery that pumped the water to the banded wooden tank in the upper stage. According to tradition, the original pump was comprised of a hydraulic ram which was subsequently replaced by an electrically operated device. Remnants of the mechanism include a rotating iron shaft mounted to a wooden frame, and a boxed enclosure rising to the tank level that houses the inlet pipe.

The Cathance Water Tower is a two-stage wooden frame structure that was built by the Rogers family to supply the domestic water needs of their nearby residence (no longer extant). Although the tower's date of construction is uncertain, the techniques employed in its framing and the Victorian stylistic character of the upper stage suggest that it was probably built in the last quarter of the nineteenth century. It is eligible for nomination to the National Register under criterion C as a rare surviving example of an historic water supply structure.

Local historians state that the water tower was part of a complex of buildings which formed the Rogers Homestead, at the core of which was a two-story dwelling believed to have been erected in 1773 for John Hunter. This property came into the Rogers family when Alexander Rogers married John Hunter's widow. Photographs of the house made in 1966 show it to have had at that time a two-story ell and wing, the latter of which had a long one-story shed that terminated at a barn. An artist's conception of the complex made in 1978 when the remaining buildings were destroyed by fire, show an equally long wing and barn extending from the other end of the main house. The water tower stands to the northeast of this site and on the opposite side of the road.

Despite extensive research in documentary sources, there appears to be little verifiable information pertaining to the history of the Cathance Water Tower. One source relates an oral tradition that the structure was located for a period of time on the Topsham Fairgrounds, and then returned to its present site (Monahan notes, p.3). The implication from this information is that the tower was originally constructed on or near the existing site, but it has not been ascertained when it was originally built or relocated. However, two pieces of circumstantial evidence suggest that it has been located here for at least sixty years: 1) the Rogers family abandoned their homestead about 1940, and presumably it would not have been moved after that date; and 2) no one in Topsham seems to remember it occupying a different site. The tower and its immediate site are presently owned by the Town of Topsham.

Water towers which served domestic needs may have been common in Maine historically, but they are exceedingly rare today. The only other comparable structure in the state that is presently listed in the Register is the Bailey Farm Windmill (N. R. 6/28/88), an octagonal wood shingled frame tower which was built to pump -- but not store -- water for the farm on which it stands. The construction of structures like the Cathance Water Tower made it possible to benefit from the availability of fresh water by way of a pressurized delivery system, and to create protected storage for a large volume of water.
